LIEN WATCH: A Review of Small Community Liens

JANUARY-FEBRUARY 2011

INTRODUCTION

Every two months, the Division of Community and Regional Affairs' (DCRA) Rural Utility Business Advisor (RUBA) program publishes *Lien Watch*, a report of liens held against public service entities in small communities. The purpose of *Lien Watch* is to identify community entities struggling with cash flow or management issues, as indicated by active tax liens or court-related debts. DCRA uses this report to identify communities that may need technical assistance to build local utility management capacity in rural Alaska. All records in this report are in the public domain and may be found at: http://dnr.alaska.gov/ssd/recoff/search.cfm.

This report lists unresolved state and federal tax liens and court judgments levied against municipal, tribal, and utility entities in communities with less than 2,500 persons within the timeframe of the report period. The information in this report is based on public domain lien data dating from July 1, 2000, to February 28, 2011, extracted from the records of the Alaska Department of Natural Resources (DNR) Recorder's Office. A single organization may have lien items filed under multiple names. For this report, liens have been standardized under the most representative name. Liens unrelated to public-service entities are excluded. Liens issued to independent subsidiaries of tribal or community entities or for-profit private corporations are also excluded. To verify the validity of a particular lien, contact the entity listed or the agency that filed the document.

DATA LIMITATIONS

The Recorder's Office data has specific lien-related limitations. Data only represents debts for which liens have been issued. The recording of liens or their release may not be current due to

reporting or recording delays. These delays can lead to significant differences between the amount of reported and actual lien-related debt.

The search feature of the Recorder's Office database is limited. Keyword searches find only matches that begin with the term entered. Wildcard searches are prohibited. Consequently, records that include misspellings, have an unexpected word order, or lack information may be unintentionally omitted from this report. Finally, real property liens are not included within this report. Since 2010, DCRA has received data of new filings of liens and their releases from DNR's Recorder's Office.

BENCHMARK

To ensure the accuracy of Lien Watch, DCRA requested records of all active community and entity liens recorded since January 1, 2000, from DNR's Recorder's Office. In December 2010 and January 2011, these records were compared, and DCRA has added 79 lien claims and 11 lien releases. As with other data included in the Lien Watch, records with misspellings or other errors may have been unintentionally overlooked. Listed below are the liens, claimed and released, that were previously omitted from Lien Watch.



LIENS CLAIMED AND RELEASED

The compiled records through February 28, 2011, list 335 individual active lien items that were connected with 64 city, tribal, and utility entities in 58 communities across Alaska. The median debt load per community entity was \$24,573 (average — \$115,535). The majority (55%) of these lienholding entities owed at least \$20,000. Eleven of the 64 entities (17%) owed more than \$100,000.



The number of lien items recorded in January and February 2011 was 25, less than half the 66 lien items issued in January/February 2010. The number of lien item releases recorded in January and February 2011 was 15, lower than the 24 liens released in January/February 2010. Figure 1 shows the change in the number of active liens since *Lien Watch* began in January/February 2007. Due to the benchmark correction, there is an increase of 58 active liens between November/December 2010 and January/February 2011. The following tables list all of the liens issued and all of the liens released in the January/February 2011 period.

SELF-RELEASING LIENS

Liens filed with the Internal Revenue Service have a 10-year statute of limitations. If the IRS has not refiled the lien within that period, the lien is considered to have self-released, whether it is paid off or not. During the benchmark period (2000-2010), 20 liens were discovered to have self-released. Four additional liens self-released in the January/February 2011 period. Community entities with IRS liens filed against them 10 (or more) years ago did not satisfy their obligation. The IRS, however, is relinquishing its right to collect outstanding debt and is releasing liens after the 10-yearlong collection period. Hereby, the IRS expunges debt. The following liens are now released:

APPENDIX: LIEN DESCRIPTIONS

State Tax Liens:

• Alaska Employment Security Tax (Alaska EST) - Taxes collected by the State of Alaska, Department of Labor and Workforce Development to support the Unemployment Insurance Program.

Federal Tax Liens:

- IRS 6721 Refers to the portion of the Internal Revenue Code authorizing the IRS to penalize employers for providing false or incomplete information on an information return, such as a wage statement, filed with the IRS.
- IRS 6723 Refers to the portion of the Internal Revenue Code authorizing the IRS to penalize employers for failure to comply with a specified information reporting requirement within a specified time frame.
- IRS 730 Taxes owed to the IRS by organizations that accept wagers from others, conduct wagers on the behalf of others, or operate betting pools.
- IRS 940 Taxes owed to the IRS based on the federally mandated employer contributions under the Federal Unemployment Tax Act (FUTA).
- IRS 941 Taxes owed to the IRS based on employee withholdings relating to federal income, social security, and Medicare taxes.
- IRS 990 Taxes filed by nonprofit organizations and owed to the IRS based on failure to comply within a specified time frame.
- Occupational Tax The occupational tax is imposed on those who receive wagers that are subject to tax. The tax applies to persons receiving taxable wagers, whether they receive compensation or are volunteers.
- IRS 11C Occupational Tax and Registration Return for Wagering, to register and to pay the occupational tax before wagers are accepted and annually thereafter.
- Subordination of Federal Tax Lien An agreement between an entity and the IRS which allows other liens to take precedence over the debt owed to the IRS.

Court-Ordered Liens:

- Default Judgment Judgment entered against a party who has failed to defend against a claim that has been brought by another party.
- Final Judgment Judgment which leaves nothing open to further dispute and sets at rest cause of action between parties. A judgment is considered "final" and thus appealable only if it determines the rights of the parties and disposes of all of the issues involved so that no further action will be necessary in order to determine the entire controversy.
- Hospital's, Physician's, and Nurse's Lien An operator of a hospital in the state, a licensed special nurse in a hospital, or a physician who furnishes service to a person who has a traumatic injury has a lien upon any sum awarded to the injured person by judgment, settlement, or compromise.
- Judgment on Confession Judgment entered where the defendant confessed action. The act of a debtor in permitting judgment to be entered against him by his creditor for a stipulated sum. In Alaska, a confession judgment can be entered before or after the commencement of action in Superior Court.
