LIEN WATCH: A Review of Small Community Liens

MAY - JUNE 2007 UPDATE

INTRODUCTION

Community well-being is multi-faceted and dependent upon the successful operation of multiple community entities including local governments, tribes, and non-profit community associations. For entities with employees, the reporting and remitting of employment taxes on a consistent basis to the federal Internal Revenue Service (IRS) and to the Alaska Department of Labor and Workforce Development, Employment Security Division is a critical indicator of community organizational management capacity. Timely compliance with court orders, or a lack of court orders entirely, is also indicative of effective organizational management.

Charged with promoting community and economic well-being with particular focus on rural utility management, the Division of Community and Regional Affairs' (DCRA) Rural Utility Business Advisor (RUBA) Program sponsors *Lien Watch*, a bi-monthly review of small community liens. The purpose of *Lien Watch*, as developed by DCRA's Research and Analysis Section, is to proactively identify community entities struggling with cash flow or lacking effective management capacity as represented by active tax or court-related liens.

The presence of liens filed against one or more community entities may be an indicator of significant community hardship. The RUBA Program uses this information to identify communities at risk, promote quality community leadership, and build local utility management capacity in rural Alaska.

Unresolved state and federal tax liens and court judgments levied against municipal, tribal, and utility entities in communities with less than 1,500 persons are identified using public domain liens data dating from July 1, 2000 as provided by the Alaska Department of Natural Resources (DNR), Recorder's Office. Appendix A defines the various types of liens and judgments. Appendix B provides a complete list of current active liens recorded between July 1, 2000 and June 30, 2007. Analysis contained within this report focuses on lien activity as recorded by the Recorder's Office during the period of May 1, 2007 through June 30, 2007.

Data collection is limited to individual lien items of \$500 or more. Liens unrelated to cities, tribes, utilities, or community non-profit associations are excluded. Liens issued to independent subsidiaries of tribal or community entities or for-profit private corporations are also excluded.

DATA LIMITATIONS

Recorder's Office data has specific lien-related limitations. Data only represents debts for which liens have been issued. The recording of liens or their release may not be current due to reporting or recording delays. These delays can lead to significant differences between the amount of reported lien-related debt and actual lien-related debt.

The search feature of the Recorder's Office database is also limited. Keyword searches find only matches that begin with the term entered. Wildcard searches are prohibited. Consequently, records which include misspellings, have an unexpected word order, or lack information may be unintentionally omitted from this report.

Finally, real property liens are not included within this report. Real property lien releases sometimes describe the parcel without identifying the entity released from the lien. This can lead to a lien being legally released with no record linked to the entity, making the data unreliable for measurement.

Despite limitations, Recorder's Office data is the most comprehensive and current source of lien-related public record data in Alaska and is valuable in identifying communities at risk.

MAY - JUNE 2007 LIEN ACTIVITY

Lien Profile Summary

According to records compiled through June 30, 2007; 329 individual active lien items of \$500 or more were connected with 72 city, tribal, and utility entities in 60 communities across rural Alaska. The median debt load per individual lien item is \$5,087. 47% of the lien-holding entities owe at least \$20,000. Fourteen of the 72 entities (19%) owe more than \$100,000.

Liens Released

During the May 1, 2007 to June 30, 2007 period, state and/or federal lien releases were granted to municipal entities in Alakanuk, Chevak, Eek, Lower Kalskag, Nondalton, Pilot Point, and Upper Kalskag; tribal entities in Hoonah, Mentasta, Napaskiak, Nikolai, Noorvik, and Pilot Point; Atmautluak Joint Utilities; and Kwethluk Utilities Commission.

Alakanuk City Council was released from EST-related liens totaling \$21,481 spanning four consecutive quarters from fourth quarter 2005 to third quarter 2006. Alakanuk City Council has no further EST liens, but owes \$237,963 in combined IRS 941 and IRS 6721 lien-related debt.

The City of Nondalton was released from EST-related liens totaling \$1,952 and spanning fourth quarter 2005 to first quarter 2006. The City of Nondalton owes \$8,454 in court judgments and Nondalton City Council is responsible for \$17,039 in IRS 941 tax liens. The City of Nondalton and Nondalton City Council are the same entity, but have liens filed under separate names.

Chevak City Council was released from an EST lien in the amount of \$3,754 from fourth quarter 2006. Chevak City Council is still responsible for an EST lien in the amount of \$9,172 from third quarter 2003.

Kwethluk Utilities Commission was released from two EST liens totaling \$1,472 from third quarter 2005 and fourth quarter 2005. Kwethluk Utilities Commission remains responsible for three consecutive quarters of EST liens spanning first quarter 2006 to third quarter 2006 and IRS 941 liens for three non-consecutive quarters spanning third quarter 2004 to third quarter 2005. Kwethluk Utilities Commission is now responsible for state and federal payroll tax liens totaling \$15,803.

Mentasta Tribal Council was released from a \$650 EST lien dating from second quarter 2005. Mentasta Tribal Council is still responsible for three consecutive quarters of EST liens spanning fourth quarter 2005 to second quarter 2006 totaling \$7,898.

Nikolai Village Council was released from a \$1,056 EST lien dating from third quarter 2006. Nikolai Village Council is still responsible for an EST lien from fourth quarter 2006 in the amount of \$1,688.

Noorvik Native Community (Eskimo) was released from second quarter 2006 and third quarter 2006 EST liens totaling \$4,085. Noorvik Native Community (Eskimo) is still responsible for an EST lien from fourth quarter 2005 in the amount of \$1,932.

Three other entities were released from all EST-related liens: Atmautluak Joint Utilities (\$745), the City of Eek (\$2,534), and Hoonah Indian Association (\$4,753). With these releases, these three entities are now free from all lien-related debt.

Pilot Point Village Council was released from seven non-consecutive quarters of IRS 941-related debt spanning from fourth quarter 2000 to third quarter 2003 totaling \$79,171. These represented the only recorded and active liens against Pilot Point Village Council, which is now free from all lien-related debt.

The City of Lower Kalskag was released from seven non-consecutive quarters of IRS 941-related debt spanning from third quarter 2000 to second quarter 2006 totaling \$40,233. These represented the only recorded and active liens against the City of Lower Kalskag, which is now free from all lien-related debt.

The City of Upper Kalskag was released from IRS 941 lien-related debt from third quarter 2003 and fourth quarter 2004 totaling \$5,275. These represented the only recorded and active liens against the City of Upper Kalskag, which is now free from all lien-related debt.

The City of Pilot Point was released from IRS 941 liens spanning first and second quarters 2003 totaling \$30,215. The City of Pilot Point remains responsible for EST liens totaling \$7,055 spanning three consecutive quarters from third quarter 2003 to first quarter 2004, an IRS 6721 lien for \$5,096 from first quarter 2001, and IRS 941 liens totaling \$56,199 spanning five consecutive quarters from second quarter 2003 to third quarter 2004. In total, the City of Pilot Point is responsible for \$68,351 in state and federal lien-related debt.

Napaskiak Tribal Council was released from IRS 941 liens spanning three consecutive quarters spanning first quarter 2006 to third quarter 2006 totaling \$25,622. Napaskiak Tribal Council still has IRS 941 liens from fourth quarter 2004 and first quarter 2005 totaling \$12,945.

Employment Security Tax (EST) Liens Issued

During the May 1, 2007 to June 30, 2007 period, new EST liens were filed against the Cities of Akhiok, Kotlik, Saint George, and Saint Michael; the Traditional Councils of Atmautluak, Hooper Bay, Ohogamiut (Marshall), and Saint George; and Kwethluk Utilities Commission. For Atmautluak Traditional Council (\$1,569), Ohogamiut Traditional Council (\$1,765), and Saint George Traditional Council (\$6,468), these represent their only active lien items.

The City of Saint George was issued an EST lien from fourth quarter 2006 in the amount of \$13,187. The City of Saint George has previous EST liens spanning three consecutive quarters from third quarter 2003 to first quarter 2004. The combined EST lien-related debt for City of Saint George is \$33,486.

The City of Akhiok was issued EST liens covering third quarter 2006 and fourth quarter 2006 in totaling \$4,258. The City of Akhiok has previous EST liens spanning three consecutive quarters from fourth quarter 2005 to second quarter 2006 as well as a court-issued judgment. Combined EST and court-related debt totals \$69,490.

The City of Saint Michael was issued an EST lien for fourth quarter 2006 in the amount of \$1,640. In combination with its federal lien-related debt, the City of Saint Michael has \$66,917 in total lien-related debt.

Hooper Bay Traditional Council was issued EST liens totaling \$6,336 spanning third quarter 2006 to fourth quarter 2006. Hooper Bay Traditional Council also has active EST liens for five non-consecutive quarters spanning first quarter 2005 to second quarter 2006 and IRS 941 liens for five non-consecutive quarters spanning third quarter 2001 to first quarter 2006. Hooper Bay Traditional Council's owes \$54,136 in state and federal lien-related debt load.

Kwethluk Utilities Commission was issued an EST lien in the amount of \$1,054 for third quarter 2006. Kwethluk Utilities Commission also has active EST liens for three consecutive quarters spanning first quarter 2006 to third quarter 2006 and IRS 941 liens from three non-consecutive quarters spanning third quarter 2004 to third quarter 2005. Kwethluk Utility Commission owes \$15,803 in state and federal lien-related debt.

Kotlik City Council's EST lien in the amount of \$1,275 covers fourth quarter 2006. Kotlik City Council also owes \$11,519 for two IRS 941 liens from second quarter 2006 and fourth quarter 2006. Kotlik City Council owes \$12,794 in state and federal lien-related debt.

Internal Revenue Service (IRS) 941 Tax Liens Issued

During the May 1, 2007 to June 30, 2007 period, the Recorder's Office recorded new liens filed by the IRS to recover 941 taxes from the City of Adak, Chignik Lake Village Council, and Kotlik City Council.

The City of Adak was issued IRS 941 liens in the amount of \$165,782 for five consecutive quarters spanning fourth quarter 2005 to fourth quarter 2006. These liens represent the only liens filed against the City of Adak.

Chignik Lake Village Council was issued an IRS 941 lien in the amount of \$10,970 for third quarter 2004. In addition, Village of Chignik Lake has EST and 941 liens totaling \$24,536 and Chignik Lake Traditional Council has \$210,772 in court judgments. The combined lien-related debt load equals \$246,278. The Traditional Council, Village, and Village Council are all the same entity with lien documents filed under separate names.

Kotlik City Council was issued an IRS 941 lien in the amount of \$6,817 for fourth quarter 2006. Kotlik City Council also has an IRS 941 lien for \$4,702 from second quarter 2006 and an EST lien for \$1,275 from fourth quarter 2006. Kotlik City Council is currently responsible for \$12,794 in lien-related debt.

Alaska Court Judgments Issued

During the period of May 1 to June 30, 2007, court judgments against Chevak Traditional Council and Chignik Lake Traditional Council were filed.

Chignik Lake Traditional Council was issued a final judgment in the amount of \$108,374. Combined with a default judgment in 2005, Chignik Lake Traditional Council owes a combined \$210,772 in court judgments. Village of Chignik Lake holds state and federal liens totaling \$24,536. Chignik Lake Village Council owes \$10,970 in IRS 941 lien-related debt. The combined lien-related debt load equals \$246,278. The Traditional Council, Village, and Village Council are all the same entity with lien documents filed under separate names.

Chevak Traditional Council was issued a judgment on confession in the amount of \$36,623 in August 2006; however, the judgment was not recorded by DNR until May 2007. This judgment represents the only court judgment against Chevak Traditional Council. The Council has no active state or federal tax liens.

APPENDIX A: LIEN DESCRIPTIONS

State Tax Liens:

- Alaska Employment Security Tax (EST) Taxes collected by the State of Alaska, Department of Labor and Workforce Development to support the Unemployment Insurance Program.
- Fisheries Business Tax Taxes due to the State of Alaska General Fund. Monies are split between the city and/or borough in which processing occurs and an allocation program administered by the State of Alaska, Department of Commerce, Community, and Economic Development.
- **Seafood Marketing Tax -** Taxes due to the State of Alaska General Fund, typically for redistribution to the Alaska Seafood Marketing Institute for the purpose of marketing Alaskan seafood.

Federal Tax Liens:

- IRS 6721 Refers to the portion of the Internal Revenue Code authorizing the IRS to penalize employers for providing false or incomplete information on an information return, such as a wage statement, filed with the IRS.
- IRS 940 Taxes owed to the IRS based on the federally mandated employer's contribution under the Federal Unemployment Tax Act (FUTA).
- IRS 941 Taxes owed to the IRS based on employee withholdings relating to federal income, social security, and Medicare taxes.
- Subordination of Federal Tax Lien An agreement between an entity and the IRS which allows other liens to take precedence over the debt owed to the IRS.

Court-Ordered Liens:

- **Default Judgment** Judgment entered against a party who has failed to defend against a claim that has been brought by another party.
- **Final Judgment** Judgment which leaves nothing open to further dispute and sets at rest cause of action between parties. A Judgment is considered "final" and thus appealable only if it determines the rights of the parties and disposes of all of the issues involved so that no further action by the court will be necessary in order to settle and determine the entire controversy.
- Hospital's, Physician's, and Nurse's Lien An operator of a hospital in the state, a licensed special nurse in a hospital, or a physician who furnishes service to a person who has a traumatic injury has a lien upon any sum awarded to the injured person by judgment, settlement, or compromise.
- **Judgment on Confession** Judgment entered where the defendant confessed action. The act of a debtor in permitting judgment to be entered against him by his creditor for a stipulated sum. In Alaska, a confession judgment can be entered before or after the commencement of action in Superior Court.
