If you need assistance in completing your filing, it is advised that you seek legal counsel. Please be aware that this filing will become public information.

**ITEM 1**: Provide the name of the entity currently on record and the Alaska Entity Number.

**ITEM 2**: Indicate the date the resolution was adopted by the board, and attach a copy of the restated articles of incorporation.

**ITEM 3**: Restated Articles of Incorporation must be signed by the corporate president or vice president, and by its secretary or assistant secretary.

**NOTE**: Persons who sign documents filed with the commissioner that are known to the person to be false in material respects are guilty of a class A misdemeanor.
