Domestic Business Corporation (AS 10.06)

- This Certificate of Election to Dissolve (Part 1 of 2) is only for Domestic Business Corporations. Once filed, the entity will be placed into an "Intent to Dissolve" status.
- The Certificate of Election to Dissolve must be submitted together with, or before, the Articles of Dissolution (Form #08-407) for a "Voluntarily Dissolved" status (Part 2 of 2). Both forms are required to complete the dissolution.
- This form will not be filed if the official signing this form does not match an official on record for this entity, and/or if your entity's biennial report is not current. Verify your entity's status and current information online at: www.Corporations.Alaska.Gov, click Search Corporations Database.
- Standard processing time for complete and correct filings submitted to this office is approximately 10-15 business days (2-3 weeks). All filings are reviewed in the date order they are received.
- The information you submit is a public record and will be posted online at www.Corporations.Alaska.Gov.

Important: A corporation that has elected to wind up and dissolve shall immediately file a certificate evidencing the election as provided in this section. — AS 10.06.608(a).
