<p>A “Trademark” includes any word, name, symbol, or device, or any combination, used, or intended to be used, in commerce to identify and distinguish the <u>goods</u> of one manufacturer or seller from goods manufactured or sold by others, and to indicate the source of the goods. In short, a trademark is a brand name on <i>physical goods/products</i>. If your trademark is used in advertising for services (not physical goods or products), use the “Service Mark Registration” application (form #08-549).</p> <p>This trademark registration is valid only in the State of Alaska for a period of five (5) years. 3. the flag, coat of arms, or other insignia of the United States, this or another state, or municipality of this or another state, or a foreign nation, or simulation of any of these;
4. the name, signature, or portrait identifying a living individual, except with the written consent of that individual;
5. merely descriptive or deceptively misdescriptive of an applicant's goods or services;
6. is primarily geographically descriptive or deceptively misdescriptive of an applicant's goods or services;
7. primarily a surname;
8. a mark that so resembles a mark registered in this state or in the United States Patent and Trademark Office, or a mark previously used by another and not abandoned, as to be likely, when used on or in connection with the goods or services of the applicant, to cause confusion or mistake or to deceive;
9. a mark that so resembles the name of another organized entity, or a reserved or registered name, that the mark is likely to cause confusion or mistake or to deceive.
