FROM: Jane P. Sawyer, Regulations Specialist RE: Regulations Project – Exit

Package - Opacity

At the October 2020 meeting, the board opened this regulations project to address opaque exit packaging at retail stores. Attached is the initial draft.

The intent of this project, in simple terms, is to allow the consumer to put their purchased marijuana or marijuana product in their own opaque bag.

In the draft, language from 3 AAC 306.345(a)(3) is removed but used and reworded to create a new paragraph (3 AAC 306.345(a)(4)). This new paragraph allows for the opaque package to be provided by the product being already opaque-packaged for final retail sale by the cultivator or the manufacturer, or the retail store, or the consumer's own opaque package/bag.

- Put out for public comment
- Amend and put out for public comment
- Send back to staff for revisions
- Close the project without action
