Lacy Wilcox, President of AMIA: Welcomes Eliza Muse to the board and the new AMCO staff. She states the license cap discussion was helpful. On August 31st, 1 – 3pm, there will be a discussion with AMIA regarding federal legalization. They will be discussing ideas on how to mitigate the potential downsides of federal legalization on Alaskan businesses so continuation of the conversation the board hosted last week. Details will be posted on Facebook. She encourages the Board to draft a public comment asking for the States rights approach, it is important for federal lawmakers to hear from state regulators. The deadline is September 1st. She provides a status update for handler cards. The board has mentioned in the past that perhaps a working group is needed to audit the active versus the inactive courses. She does not think that a working group is Marijuana Control Board Meeting Agenda: August 18-19, 2021

necessary now and this task is delegated to staff at the board's instruction. So please instruct staff to audit current courses once the audit is complete, AMIA asks that the board instruct staff to list the courses, placing the Alaskan courses before out of state providers and comprehensive courses before those that irresponsibly offer pass guarantees, we ask that you do this as a courtesy to Alaska instructors and out of state courses that offer through and ethical education. Three of the course providers are AMIA members and have their support, and she would be happy to provide that information to staff if it helps with the web page.

Follow up on a transportation issue that has been worked on already with AMCO and AMIA specifically around the security and safety of our transport manifests. Help expedite solutions to some of their most important concerns around security and transportation, including some specific METRC issues. METRC responsiveness is an ongoing concern for them, and they hope that METRC will be responsive to Alaska issues, including requests from the office for improvements to the system. She suggests the Director request a meeting with METRC leadership. That the AMCO Director attend with Ms. Wilcox to talk through some of those problems. They have all paid them enough money, they work for the licensees so they should be held accountable. If this cannot occur, then, perhaps, as mentioned in the past and supported by this board a tracking system working could be created so that the subject matter experts can inform regulators as to exactly what changes need to be made in the system.

The testing packaging and labeling working group. Thanks AMCO, specifically Rick, again for hosting a conversation regarding testing and they look forward to more dialogue on specific issues that laboratories face and the implications for all licensees in the public. Resolving the potency variance and lab practice issues is only part of the problem. The industry and public long for pesticide testing but hesitate to officially ask for it until the labs can be better aligned. They asked for more robust mold testing, but again hesitate for the same reason. They agree that DEC and Mr. Crupi do need to have continued involvement in providing general laboratory practices and offering checklist audits for review. But they feel strongly that one man and one agency can't possibly effectively oversee fairly three and hopefully someday more private labs without some assistance from experts. It is a big deal and it deserves an empowered working group.

This working group could also review and make recommendations on packaging. Specifically, how to perhaps make the packaging requirements more environmentally practical, while also potentially thinking ahead to federal legalization and how packaging can serve as a tool to protect Alaska manufacturers. This working group could consider recommending regulatory changes on labeling so that the consumer and public are best served by the information that is required to be on products.

Glenn Steckman, City Manager for Nome: Welcomes the Board to Nome. Thanks Rick Helms for attending a two-hour meeting that they are now having to address the just the issue of homelessness which is created by chemical abuse, alcohol abuse and obviously mental health, which makes up a substantial population, which also then impacts, the sexual assaults that they see in the community. Sexual assaults are very high in a community this size, where it should be two to three a year, last year it was almost 100. Businesses worked well with the city administration and he thanks them.

Jana Weltzin, counsel for many licensees: thanks Nome for hosting the board meetings. She appreciated the city manager's comments - they were very thoughtful and important. She thanks Eliza for stepping up into this really important role. She reminds the board regarding the distributors regulation project – suggests a working group if staff needs industry comments.

The Director has been doing such a fabulous job at finally staffing the AMCO office completely, this is probably the first time that she knows of at the office has been staffed to a degree that it is a full staff now with these two new employees coming on.

The license cap discussion needs to continue - keeping it going forward and learning more about the pros and cons and the unintended consequences in either direction.

Agrees with AMIA regarding the METRC frustration. It's very difficult to get METRC to give a straight answer, and they have a high staff turnover and we understand that. We know everybody's facing that issue right now, but really holding them accountable and maybe a letter from this board kind of outlining the issues that the industry is facing would be very helpful. She thanks the AMCO staff for working so hard and caring for and supporting the industry.

Lisa Coates, Herban Extracts and Katherine: *Testing and taxes need attention. Her products THC limits/numbers dropped. There's a problem with all the THC range numbers and I think that they need to start focusing on making a range for the product. Like take the lowest to the highest test - let's put it in a range, like other states do so that people can stay in business. They are losing profit, thousands of dollars off the top of price per pound. The state of Alaska has made more money than she has and she owns her own business and cultivates her own cannabis - work for herself and they still make more money than she does. Something needs to be done about it and hopes that other growers will speak up.*

A. Director's Report

Director Klinkhart summarizes his report. Bruce S. asks if other tracking companies showed interest in Alaska. The Directors states there were two others that submitted bids – one was unresponsive and the other not qualified. Christopher J. supports AMIA's suggestion with database/METRC working with staff. Eliza M. says that public health uses METRC data as well – supports idea. Nick M. would like to see METRC address the board in the first quarter, which they did before. Bruce S. asks how well are they serving other states? Rick Helms says he attended a METRC meeting for just Alaska and he brought these issues to their attention. Their response was there was no endgame in site. Bruce S. mentions the contract – if they are not meeting the contract, why are we paying them? The Director says they knew about the liability and will provide the board a copy of the contract. Nick M. asks if there are metrics in the contract and do they report on that? Director Klinkhart says they want to charge for our questions/solutions. Christopher J. asks Joan W. if staff can show the contract to the board. She says it is a public document on state's website but the board should be kept from negotiation process. **Christopher J. motions to instruct staff to have METRC come up for a in person meeting during the first quarter. Bruce S. seconds. None opposed, motion carries.**

B. Petition Process Discussion

Director Klinkhart summarizes his memo. Christopher J. believes the petition process should remain the same. Eliza M. has no comments – new issue. Bruce S. welcomes any effort to standardization. Joan W. says there is no request to change regulations/requirements. The board still has full authority. Nick M. understands the problem and supports giving guidance to applicants. Rick Helms agrees it is a problem – he is looking at working with the Department of Revenue to find more solutions.

Director Klinkhart summarizes the report in James Hoelscher's absence. Bruce S. mentions outstanding taxes. Christopher J. thanks Enforcement for their hard work. Nick M. asks why the DOR memo is dated July 23rd. Shouldn't there be an updated memo? Yes, it was received after agenda was finalized. He would like the current memos attached. Eliza M. asks if there is a mechanism where the board can see if there are taxes owed when reviewing renewals. Yes. Can they take action on these tax delinquent licensees? Nick M. answers – explains past practices and moving forward, they will be using their options. Joan W. says the board can revoke – do not need to wait for renewals.

B. Notices of Violation Issued and Licensee Responses

Christopher J. is disappointed with Alaska Cannabis Exchange's response, yet pleased with Hamilton's communication. Director Klinkhart speaks about the fine schedule. Christopher J. mentions Canna Get Happy – something needs to happen. The Director says Joan W. and Jane S. are working on that. Jane S. says the regulation project is out for public comment. September 28, 2021 is date public comment is closed. Joan W. says the board is not without authority to take action.

Nick M. comments that Alaska Cannabis Exchange – have we formally changed the process by suppling the complainant's name? There is further discussion regarding providing names. Rick H. compares it to a noise complaint at a bar. Can't solve a problem without communicating. Christopher J. suggests disregarding Canna Get Happy but if it continues, staff should write an accusation. **Christopher J. motions for staff to write an accusation for Alaska Cannabis for both NOVs. Bruce S. seconds.** James H. is present – agrees with the Director. Speaks of Enforcement actions/context regarding complaints. Christopher J. says he is not asking for a huge fine – work with AMIA to find a fair fine amount. Nick M. doesn't appreciate their response, but doesn't think it rises to an accusation. Director Klinkhart will use the proposed fine schedule if this motion is passed. **Christopher J. is in favor of the motion. Nick M.**, **Eliza M. and Bruce S. are opposed. The motion fails.**

Director Klinkhart provides a summary of the memo and appeal of the Director's decision. Steve Crupi is present. Christopher J. asks about procedures. Richard Moses, lawyer who works with Joan W., is present as well. Bruce S. asks if FAT is online and if this matter should be in public or executive session? Richard Moses answers Christopher's earlier question. Joan W. answers Bruce's question regarding executive session. 3:09 pm: Lance Wells, counsel for FAT, is present. Steve Crupi is present and so is Richard Moses. Lance Wells asks for executive session. There is discussion by the board about executive session. There is no motion therefore there is no executive session.

Steve Crupi explains his role in the audit and presents a summary. Bruce S. asks about their interaction with the other labs. Mr. Crupi states that one will be getting their completion letter and the other one had fully cooperated in a timely manner. Eliza M. asks for the other lab's audit findings. Nick M. agrees. Director Klinkhart says there is another lab that is under probation and being audited as well. Nick M. asks if a 30-day response is sufficient time with the number of deficiencies listed. Mr. Crupi says the other audit corrections were probably submitted within 20 - 25 days. Within the 30 days, FAT could at least propose a plan to get back into compliance.

Lance Wells, counsel for FAT, says that they submitted a response and asked for a 2-day extension to address some deficiencies. Lab Director Alex Tackett is present. How does the board define a threat to

public safety? Mr. Crupi answers it is the understanding of how tests are performed. There were calculation errors in the past. Nick M. would like Mr. Tackett to talk about the responses so for and not to debate Mr. Crupi's findings. Mr. Tackett says they have satisfied all requirements.

Richard Moses states that FAT is on probation which they agreed to and so did the board, therefore they are on a shorter leash than other labs. Dylan Macomber, FAT licensee, is present and recommends the board to read all the labs deficiency reports and compare them. **Christopher J. motions to suspend the** *license for 60 days and to include the entirety of Tab 10.* Director Klinkhart suggests making it effective within 7 days. **Christopher J. amends his motion – says effective 10 days. Eliza M. seconds.** Bruce S. asks Ms. Macomber why should board not uphold the suspension. Ms. Macomber doesn't think it a threat for public safety. Responses would be given in one email instead of piecemeal emails. Doesn't think it warrants a shutdown.

Christopher J. and Eliza M. are in support of the motion. Nick M. thinks if the board waits 7 days to make the suspension effective then it's not a public safety issue. He would suggest a two-week suspension, but it would start immediately. He will vote no on the motion. There needs to be a partnership between DEC and the labs – the relationship should not be confrontational. Christopher J. says the 10 days was in the interest of the industry – he does not want the industry to be penalized and will not amend his motion. Bruce S. says two-weeks isn't enough but two months is not helpful either. Christopher J. asks Eliza M. about her stance on the length of the suspension. She would support a lesser period but would be the last chance. **Christopher J. amends the motion to a 30-day immediate suspension.** Nick M. asks Ms. Macomber if 30 days is enough time to correct and respond to DEC. She doesn't foresee that being an issue. **Eliza M. seconds.** None opposed, motion carries. **Christopher J. amends the motion to include the entirety of Tab 10 in support of the decision. Eliza M. seconds.** None opposed, motion carries.

Christopher J. agrees with the statements made by Nick M. and Bruce S. He says if there is a minor change to the ingredients, even the binding agents, then those need to brought back to the board.

Eliza M. is curious if this includes concentrated, oils. There have been some regulated products in some states or associated with that lung injury, like the electronic vape pen a year and half ago. Many cases associated with vitamin E as an additive but mostly off-market products, but there were seven pieces there was maybe found in vaping oil. So, this issue could potentially lead us to be unintentionally creating sort of an umbrella approval for products that otherwise really good. Christopher J. believes that would be a substantial change which would need to come back to the board.

Nick M. clarifies that if the manufacturer wants 10 flavors of one product, those 10 flavors need to be on the initial request so they have a list of flavors to choose from, they're not changing. If they wish to add an eleventh flavor, they would need a separate request and it goes to the board.

Eliza M. says having an exhaustive list of potential flavors for the product would be helpful.

The board agrees that flavors do not need separate forms/fees. They do not want 15 forms and fees for the same product with the only variation is a flavor – unless a flavor is being added later.

Jana W. suggested that colors should be listed as well and staff should notify the Department of Environmental Conservation, a non-objection response would be required before allowing the changes.

The board instructed staff to do an advisory and/or provide guidance to product manufactures and anyone who comes in for a new product manufacturing license.
