RE:Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on October 22<sup>nd</sup>, 2021, November 19<sup>th</sup>, 2021 and December 22<sup>nd</sup>, 2021. Fourteen Notice of Violations were sent on October 23rd, 2021. Sixteen Notice of Violations were sent on November 22<sup>nd</sup>, 2021. Eleven Notice of Violations were sent December 23<sup>rd</sup>, 2021.

The Department of Revenue combined both active and expired licenses that owe taxes on their October 22<sup>nd</sup> and November 19<sup>th</sup> memos. There are two memo's sent on December 22<sup>nd</sup>, one with active licenses and one with both active and expired licenses. I've highlighted the nonactive licensee's.

Attached are the memo's provided by the Department of Revenue and Notice of Violations separated by responses and non-responses.
