Baily Stewart: Thank you for the work that's been done, the last couple meetings. I feel we are truly heading in the right direction with regulations projects currently. I come before you today to talk about our trade show regulations under 3 AAC 306.760. Alaska had its first recreational cannabis bowl this past November. Alaska Leaf sought out a retailer to help facilitate in the entry intake, we were that retailer for this event. As you know, Granger has always gone above and beyond, and upholding regulations in this was ours and Alaska Leafs utmost priority. We wanted to do this the right way and we were successful. I come before you today to talk about our experience with regulations. Our state regulations were very doable for this event, and I do want to thank you all for that, where I'd like to shine light to is in regard to regulations. Is the quantities we were able to transport to the event, according to regulations, we were only able to transport one sample package of each marijuana's product to the event for display and up to one ounce of marijuana to the trade show or event for display. For green Jar this meant we were able to take one of each product entered which, translated into being able to take 38 different concentrates equaling to 19 grams of concentrate. I was able to take 21 edibles to the event, however, for flower with 67 entries meant, I was able to take 0.41 grams per entry or just a top three in each flower category. Seeing as there's four categories per flower that may, even if I brought the top three in each category, I was only able to bring 2.3 grams of each string which had its own complications as well. The ceremony was held at the end of the event and taking this into consideration, bringing the top three with mostly giveaway the winners in runner ups. At the end of the day, I feel licensees should be trusted with more than just one ounce of marijuana. You already do so under Section D of 3 AAC 306.760 trade shows which states, "A licensed product manufacturing facility and a licensed retail facility may bring up to one sample package of each product made or sold by the facility to the event for display." I believe we should be able to do this with power as well the different products being different strains each cultivator cultivates.

With that said, well, I do feel we have other pressing issues in our industry that you are addressing. I wanted to provide feedback as a licensee who utilizes these regulations for a fully legal recreational trade show. I believe we could make small changes to regulations in order for them to be more industry-friendly in regard to the flower category. This can be as simple as allowing up to one ounce of marijuana per strain to be displayed or as low as two grams, this will allow cultivators to truly display their products and retailers as well, and I appreciate your time and consideration on the matter.

<u>Malan Paquette</u>: Member of public and advocate down here in Southcentral Alaska. Yesterday at the Alcohol Control Board I offered praise and encouragement about engaging in the public process and so just want to kind of reiterate that today. I have a quick list of vacancies at Boards and Commissions and Councils statewide. I'll try to go through it really quick it's. gov.alaska.gov forward slash services board smash boards. Alaska Children's Trust has a vacant public seat, the Alaska Council on Emergency Medical Services has one vacant consumer seat. One vacant nurse with ER experience or one and a third vacant seat hospital or native

healthcare organization administrator. Again, that's the Alaska Council and Emergency Medical Services. A Council on the homeless, looks to be in establishing board with multiple vacancies and for public seats. The Alaska Housing Financial Corporation board of directors has one vacant seat for rural resident or experience with regional housing authority. Alaska Juvenile Justice Advisory Committee has one vacant tribal representative seat and one vacant victim advocacy seat again that's the Alaska Juvenile Justice Advisory committee. The Alaskan Mental Health board has two vacant consumer seats and one vacant mental health provider. Alaska Safety Advisory council has one vacancy in in the industry, the Alaska State Emergency Response Commission has a vacant seat for local government representative. There's also a vacant seat for Local Emergency Planning committee and rural Board of Psychologists and Social Workers, both have vacant professionals private sector licensees they need a psychologist and a clinical social worker. the Governor's Council and Disabilities in Special ED has a vacant seat for a special ED teacher. Governor's Council on Human Trafficking and Sex Trafficking appears to be a new board with all vacant seats. Governor's Council on Missing and Murdered Indigenous Persons have multiple vacancies. I'm speaking about public vacancies available for serving a board or Commission or Council. Serve Alaska has vacant seats for an educator or local labor organization, the statewide Suicide Prevention Council has three vacant seats, one for person 16 to 24 years of age, one vacant seat for a youth organization and one vacant seat for Alaska Federation of Natives with a recommendation to be seated. Please encourage continued public participation within your friends, families, peer professionals, mentees and mentors. Thank you for all you're doing for this board as well.

Lacy Wilcox, president of AMIA: The industry would also like to welcome the board member representing rural Alaska. Welcome Mr. Cyrus. I would like to share my contact information with you, Mr. Cyrus upon your request and you're ready, to catch up and get to know each other. So being that we are in the new nonnormal of 2022, I want to recognize over 30 AMCO related zoom's have been hosted through the unknown, the global pandemic and we really appreciate that. You guys are killing it, this is, I thought it'd be over by now, be way more back to normal, but we're not so I really, really appreciate it a lot and I don't want any board member or staff person to feel singled out and my constructive feedback when indeed I'm overall very pleased with the collaborative relationship.

There are things, however, that licensees I represent want me to talk about, and there are things in my leadership position that I must get to first. Despite how emotional that can be I will swear, my God, I can't believe this is pretty tough, I gotta pick the big ones, so we do have a quite a big concern about the long wait time for simple forms. Teaching you the board, right now, today, to instruct the director, as in previous times for different director to be able to separate that queue from new applications for new licenses versus simple forms. Give him whatever authority, it is that he needs to get those simple things done and off the books. I can get this moment everything's getting put into one queue and its first come, first serve and its really, really impacting hundreds. There are people out there who were submitting a simple packaging change and waiting at this point up to nine months. This is a really problematic deal and I don't want to take away from the review of staff for you, not against like that's pretty thorough, but the simple changes, I believe that we should trust our director and staff to approve it, and I would really, really ask you guys, to make a change. And that was where I was like, I want you guys to personally know you guys are doing a great job, but that's a big deal.

Now I want to talk about working groups. Generally, I understand this on the agenda so I'm not going to go into the results of a specific working group or the content of the latest one. But the industry wants to thank you guys for making repeaters priority they are effective when done correctly and we believe that they bridge application simmers ancillary businesses industry regulators here, important. However, the latest working group, not going to talk about the specific outcomes, have seemed chaotic and its administrator can we as industry are not sure what the problem was that was trying to be fixed and what the goal was the working group and how that administration of the working group is supposed to effective teaching whatsoever.

Barret G.: Echoes Lacy's testimony. Discussion about testing for heavy metals & pesticides that isn't required by regulations. Difficulty with previous waste regulation project. I'm not going to be super harsh, but it was a mess at least, not impressed. I would really encourage you guys to do a little bit better job. I guess if we're going to go working groups to give it a structure, when you order instruct people he wants to have your staff buy in. A clear understanding of what working group is and that's going to be on you guys support to make sure that they know what they're doing.

Continuing on, when I talk really quickly about tax delinguency, I think the last meeting one board member and specifically, that said that this is what the industry wants, like we want you to come down hard on taxes that is true, we have said over and over that we need to remedy this. I'm not going to take that away, however, we appreciate your authority to take, case by case. Interesting decisions last time that resulted in the consideration. That's a tough spot. What we would like is for you guys to not have to have that emotional debate on the case by case, that you guys give yourselves some structure so that it is not subjective, is not emotional, that you've got a blueprint to follow, so it doesn't feel like be in the moment. I got an attorney or if you yourself are well spoken. Your ducks in a row, maybe get through, I want you guys to have some structure and I'm going to encourage you to collaborate with the Department of Revenue to understand what to hardships look like. What do they do with other industries when there's delinguency? I know the answer already. I want you guys to hear from them and that's going to be there is no other industries they've got some authority that they don't currently have with marijuana. There's a lot to explore on taxes, what should be executive a taxpayer and what is different about marijuana is quite a bit, and I think that it's time for you guys, to be presented to better understand the differences. We want you to continue to be hard on delinguency and want also to have discretion. What those truly are so as much as it's fair to say it's what industry wanted, we also want you guys to have some structure behind it, so that at every board meeting or not rediscovering how we feel about taxes. Folks out there, please get your taxes, it's not your money you're holding onto, it's the state so send it. We want you guys to take the heart approach we've taken. I understand it's hard to do but let's take emotion out of it, so that I myself not crying over on the side. You know, like that it takes so much emotion it's really, really hard know you're going to not renew somebody, it's hard on you, don't feel good about it, it feels bad for you. It feels bad for anybody, so if you've got a structure and it takes that much of it we're going to encourage you don't structure it so that we're not taking.

Thank you very much, sorry it's all critical. First off where we get into here to just like to say that I do agree with what they are saying I'm pretty much on every count. This board is doing your job, but appreciate the effort. We've got a lot of things that need to patch. We can continue to work in the right direction, but do is that there are some critiques and bring to the board, but when it because I know this this board wants to improve things just like us. So we've come a long way since we first started this industry together and people will ask you about is happening with health and safety concerns. For consumers are consuming cannabis, the focus of the board seems to be disproportionately spend on this topic and, while other public health and safety issues or name or this board is failing to give due diligence to waste management, pesticide use or heavy metal testing. Regulations don't even reguire someone who uses pesticides to be a certified to set up within the state. Cultivated operating fans asked for us as we listed maybe use, but does not ask for proof pesticide applicators to the patient. Furthermore, we still have no way to test for us sides or habits, I realized, it may be expensive, but, in the name of public health let's start the discussion. We can find the money somewhere; many people spoke about tax reform and then tax reform that includes reduction and we're help pay for the for testing and the name safety. And say the board is going these issues may sound both but here's an example of the timeline: I made the comment back in January 2018 regarding the negative effects of healthy plant waste three days inside that building or destruction, delivered a letter from a testing facility to the previous director stating that they had link several aspergillus outbreaks to waste storage. A year later in 2019, after seeing pictures of balancing pathways and everyone and mailbox or spring Arab states that

regulations regarding ways to be reviewed again and they feel are agreed, requesting that our project for waste disposal. But eight months later, I made a public comment that the waste regulation project wasn't even listed on the director's report of those regulations topics that were being overlooked. And finally, in July of 2020, thank you to Director Klinkhart for making sure that edition was added civil law. or years since a public health issue was raised, and no conversation has ever been started going into screen concentration in the liquid form, there was a work group that formed a map within a month. This is where the frustration comes in, or attention is being paid to eliminate access to cannabinoids, then there is limiting access to talks. I don't have the answers for these tough questions regarding pesticides or heavy metals testing and how to manage the expense. We need to make time to start the conversation and address these public health issues, instead of spending so much time trying to figure out how many millimeters of sugar water is required for milligrams of THC and I believe this industry is made of good people. I look forward to seeing the shared responsibility maintain and to the development of regulations that undue burden is on the industry, while increasing safety and transparency.

Dru Malone: In the state of Alaska by my count, there are over 100 independent limited cultivation licenses. By independent I mean cultivation licenses that do not have any interest in another license type. Alaskans had one of the smallest pricing types available in the country and, at first glance this looks like a good idea to give individuals opportunity to enter the market at a relatively low cost and at the same time, draw growers out of the black market into legal markets. But, more importantly, this license type could allow Alaska to develop a unique cannabis market. One that is supplied by small independent growers that contributes an incredible variety of high quality products to the consumer. But the reality is that fish license type is becoming a road to nowhere for many independent cultivators. This is because of the regulatory framework that was designed or more aptly described as copied from other states. Although I think there are quite a few troubling regulations, one that has been pernicious is the ability to hold three to four license types by one person or business or commonly called vertical integration. When vertical integration was allowed by the state is set the stage for what is happening today, that is, a system that creates gatekeepers you can put their financial interest above others in the industry without recourse. This is pushing the consolidation of the industry into a handful of entities, in effect, creating an oligopoly that can restrain others from accessing the market. Let me be clear, I do not fault anyone for working within the regulatory framework, these are the rules, except for it is most definitely the fault of the laws and regulations put in place originally and some of those adapt and sense that is for independent cultivators at a disadvantage.

A recent example the change of the hardest backside for testing originally five pounds of harvest needs to be tested. That was changed to 10 pounds effectively cutting testing costs in half the larger harvest, which are predominantly standard cultivators. But many limited cultivators are fast growers their harvest batches are on the smaller side more like two to six pounds, so a harvest batch of 10 pounds costs around \$240 to test, but the equipment wait can cost a craft or \$480 or more. So, what does all this mean to someone holding or in process of obtaining the limited cultivation license? It means literally that if they cannot make a sale to a retail store or as a last resort to a processor, which is a money losing avenue, you are locked out in the marketplace via regulation, it means that THC percentage quality or price will not necessarily garner a sale as one buyer told me why would I buy your product if I have my own product I can't sell. But all this takes into account what products, the vertically integrated entities are willing to purchase from independent is subject to percentage and price constraints and the gatekeepers to the retail market can impose. If they are willing to purchase it all, but let me stress again, this is not the fault of 30 vertically integrated entities, they are only operating within the regulatory framework, the framework is the problem. It is up to the regulators to resolve this out of balance issues, as stated in a recently a daily news article by a vertically integrated angie key. We want to cut out all of the middle person what this statement ignores is that between the plant and the consumer, everyone is a middle person. What they are saying is they want to be the only middle person, so it seems clear the board needs to act, and act quickly to present a very real possibility that a sizable number of the independence will fail. And they will fail, not because of poor business practices or poor-

quality products, but simply because they do not have a chance to access the market. So, what could possibly be the solution, well, I see four possible solutions, the two best ones are to give the same rights to independent cultivators that are given to breweries under the alcohol regulations, that is the ability to sell product grown on site and the general public, without an additional license. Not a retail store that's the ability to sell flower grown only in their independent cultivation facility. This is limited access this limited access would complement sale to retail stores and give a safety valve to independence that would open avenue for sale of products that they're retail stores will not purchase. I know some I know some vertically integrated entities want to work with limited cultivators because we can bring some unique products to the table enhance their product line.

Nick: I hate to cut you off, but you're going on, like six minutes, and we are limited the time for the public comment, your comments are important. Have you sent this information into the marijuana control email box?

Dru: I have not.

Nick: Okay, if you could type it up and get it into the marijuana control box what you're saying is important, but we do have a limit on time that each person can speak.

Dru: I understand that. Will I get any kind of response?

Nick: You will, number one that you that we've received the information and number two if any of the board members have questions, I'm sure they'll get those to you, but we do appreciate your time and you calling in, but we do have to limit the length of the public comment. I apologize for that would you like to make one quick point before you go.

Dru: Well, I would just like to say that you know, a comment that was made to me by eliminating cultivator license were first issued. And he said I don't want to get rich, I just want to make earn a decent living and I think that's important to remember when it comes to this situation, I would like to board to work quickly to find a solution if it's not something I could get something that would work. Thank you very much.

<u>Teri Zell</u>: I have a cannabis store out in the valley. Last board meeting I brought up the issue of having our drive through open again to serve the public in a healthy, safe and well-maintained manner. And I have, much to his chagrin, bothered Chief Hoelscher many times about coming out and seeing what we have, as well as inviting any of the MCB members. I did bring it up to them last time and was assured that it would be talked about at this meeting, but I do not see anything on the agenda, and I think it's really important, especially with all that's going on right now with Covid. Our customers feel really safe being able to do this, and I would just like to have a working meeting going on about this so that we can talk about it.

Nick: I didn't recall anybody saying anything at the last meeting about having something on the agenda, but I don't either, this is the for the record Director Klinkhart, I do know that to troubleshoot has been working with her to get out there and we've been discussing that, but if memory serves me right, there was some discussion at some issues, of course, with the fact that there aren't emergency declarations in place. Okay, all right, thank you for your comment.

<u>Jana Weltzin, JDW Law</u>: I wanted to welcome the board member Ely Cyrus. I really appreciated his comments and I'm really hopeful, for his input and excited for that. We thank the staff license team, and particularly in Investigator Banks. I think that the theme that you've been hearing this public comment is priorities are our priorities and, once this really, I mean for someone who is really good exercise and kind of identifying what their priorities are and I feel like that's been a really great improvement because now, they have their priorities identified and executing them and they've been really working with licensees to prevent issues, not just to find issues and I really appreciate that approach. Obviously, licenses have to do a great job clearly there's no avoiding the fact that we've got a seven-month review on that and there's just got to be something that we can do, but on the flip side, I was here for the alcohol meeting yesterday and I listened to Carrie's report and she was listing these crazy numbers of the work that they're doing - not even including marijuana. So this staff needs a bigger budget and more positions, and I think that's something, as an industry, that we've got to prioritize now - we've got to start helping with that. Creating a bigger budget because that's what we deserve, that they deserve and that's what gold alcohol and marijuana. I always love sitting in they'll call me and so it's like a redheaded stepchild - no offense to redheads - because they'll get to an issue and they're like well why are we doing. So, I think it's clear, we have a resourcing issue that we need to address it from our side of the industry, advocating, supporting this out and the staff needs to you know identify their priorities and try their best to meet their priorities and exercise when they just don't have enough resources to do so, people will be vocal about that, ask for help.

So, getting back to the priorities, I hope it is coming clear that you know the industry has been asking for things. I hundred percent agree with various comments about why are we prioritizing sugar water versus THC cannabinoids versus our first actually looking at testing and looking at what we're trying to protect people from protecting their health and safety. Also, when we go federally legal, it will be a permanent and so why do we want to be caught flat footed we don't we're already going to be at a disadvantage. Let's not disadvantage ourselves anymore, start doing the groundwork now. Let's start prioritizing pesticide testing and looking at what it's going to take to get that investment. Hearing Bailey's comments really illuminates how we need something different for industry awards in our industry. I really again - just priorities, priorities, priorities. Let's identify our core priority. We got Enforcement pretty hard a year and a half ago, the industry rallied real hard against Enforcement and Enforcement responded with prioritizing and identifying the parties put it in writing, doing the hard work. And it's worked so let's do that, let's identify our priorities and then let's work on, because I think if we have 100 different buyers and we're running around their heads cut off. As an industry and as regulators we're not we're not working on the same team, you know and really you're all on the same team we're just playing different positions, and so I think you'll need to work on that. With myself so anyways that's my comments. Thank you again Mr. Cyrus for joining me the board. I haven't met you yet, but I'm really excited to meet you.

A. Licensing Report

Carrie Craig presents her report. Bruce S. asks if staff is asking for a regulations project to discuss on Friday. Jane S. says yes. Discussion regarding the Director's delegated authority to approve certain application without it coming back to the board. Jane asks for a motion from the board on Friday. Lacy Wilcox, President of AMIA, is present in person and suggests that Licensing continue these discussions on streamlining and suggests putting together their priorities much like Enforcement had done in the recent past.

Joan W. questions the interpretation of AS 17.38.150 regarding the duties of the director which says:

"The director shall enforce this chapter and regulations adopted by the board. The director shall issue, renew, transfer, suspend, or revoke all licenses and permits and issue product approvals at the direction of the board. The board may delegate to the director the authority to temporarily grant or deny the issuance, renewal, or transfer of licenses and permits. The director's temporary grant or denial of the issuance, renewal, or transfer of a license or permit is not binding on the board. The board may delegate to the director any duty imposed by this chapter except its power to propose and adopt regulations."

Nick M. states the board has delegated certain authority to the Director to approve operating plan changes. He speaks about a notification letter the previous director has sent in which said, "Your operating plan change has been temporarily approved." Then it would appear on next agenda and the board would approve them, possibly as a batch. He states that reviewing a simple change application should take 10 minutes for it to get looked at when it is submitted to the office, and then staff can send it to the Director and he can provide temporary approval so the licensee doesn't have to wait 9 months.

Jana Weltzin speaks about splitting the queue in two parts – one for new and transfers and one for the shorter and less complicated applications. She suggests assigning one examiner for the bigger applications and the other for the change applications – the only issue with that is what happens when one of those two examiners are out of the office for a period of time?

Nick M. states it may make sense to split the queues – it had worked in the past and doesn't recall the reason the queues were merged. He also states that it doesn't have to be limited to two queues – if the director thinks that they need three of four to be more efficient then he can do that. Bruce S. states he doesn't want to create more work for staff, but if they can do it efficiently then do it.

The board would like to see a list of all the delegations given to the Director for review at the next meeting.
