### Section 2 - Overview of Operations

2.1. Provide an overview of your proposed facility's operations. Include information regarding the flow of marijuana from seed or clone to harvest and transfer from your premises:

Our facility contains 196 sq ft of flowering canopy space. 48 sq ft of vegetative space and a 40 sq ft drying room. Our plants will be grown in soil under LED Lighting. The soil will be amended with organic compost, worm castings, glacial rock dust, rock phosphate, down to earth bio live 5-4-2 npk. The plants will be watered balanced with ph adjusted water and fed as needed.

During our growing cycle the plants will receive 2- 3 weeks for immature propagation, transplanted and into vegetative cycle for 2-3 weeks, and switched into flowering cycle for 9-10 weeks. After harvesting we will dry the weighed and recorded plants for 10-14 days. Once dry we will go into curing/ trimming and then to testing awaiting approval for sale or transfer.

Our growing environments are controlled via electronic sensors that communicate with fans and dehumidifiers. Any air exhausted will go through a carbon filter to mitigate any odor.

4.7. Describe the marijuana cultivation facility's irrigation and waste water systems to be used:

Our irrigation will be delivered via a pump and a watering wand or a pump and a automatic moisture sensor. There will be little to no waste from the plants from the organic growing methods. All water will be stored in a reservoir with in-floor drains in case of a flood.

North Star Gardens anticipates the following waste at the cultivation facility: (1) marijuana that is identified as contaminated, infected or is otherwise rejected for quality (2) waste from marijuana flowers and plant material and trimmings; (3) run off water from cultivation and processing; (4) any other materials or containers in contact with marijuana products that risk contamination; and (5) any other waste as determined by the Marijuana Control Board, Director or a licensee. Marijuana waste will be stored away from all other products in a locked container in Room #5 as shown on the premises diagram, and will be rendered unusable prior to leaving the facility for disposal. A notice will be sent to AMCO enforcement via email not later than three days prior to rendering waste unusable. Marijuana waste will be rendered unusable by grinding the materials and mixing with other compostable and non-compostable material until the resulting mixture is no more than fifty percent (50%) marijuana waste. The final waste mixture will be picked up by the city waste facility and delivered to the city landfill. A log recording the final destination of all marijuana waste will be maintained as a business record and will be made available to the MCB upon request.

All marijuana waste will be ground using a grinder and will then be mixed with at least 50% non-marijuana solid wastes such as; food waste, yard waste, cat litter, vegetable oil, soil, paper waste or cardboard waste. At least three days before rendering marijuana unusable, a notification email will be sent to AMCO Enforcement.

6.1. Describe the odor control method(s) to be used and how the marijuana cultivation facility will ensure that any marijuana at the facility does not emit an odor that is detectable by the public from outside the facility:

Exhaust air from cultivation operations will be filtered through charcoal prior to exiting the facility. Charcoal filters will be replaced regularly to ensure optimum performance. Should additional odor control be required, an ozone generator may be introduced in the exhaust.

7.3. Describe the testing procedures and protocols the marijuana cultivation facility will follow:

All harvested marijuana will be processed into batches of five (5) pounds. A designated North Star Gardens employee will collect a testing sample at random from each batch. Said employee will prepare a signed statement attesting that each sample was randomly selected, provide a signed statement to the testing facility, and maintain a copy as a business record. The facility will transport all samples to a licensed testing facility in compliance with the state regulations and the company's transportation policies. The facility will ensure that any individual transporting marijuana has a valid marijuana handler permit issued by AMCO. While awaiting the testing results, the remainder of the batch will be segregated in the secured quarantine area located in Room #5 as seen on the premises diagram. The facility will maintain all testing results as part of its official business records, and will enter the results in METRC. North Star Gardens will comply with any request from AMCO for a random sample from any growing medium, soil amendment, fertilizer, crop production aid, pesticide, or water and shall bear the expense for all such requests.
