Form Amendments

To add efficiency to the process of a diagram change since these now go straight to enforcement, we made changes to some forms.

MJ-04 (cultivation operating plan supplemental) used to require the applicant to describe the size of the space(s) under cultivation the cultivation facility would have. The applicant would then have to essentially describe the same information on MJ-02 (premises diagram) and MJ-14 (diagram change). We removed the language from MJ-04 and moved it to MJ-02 and MJ-14 so that there is only one form where the same information is being requested, therefore, having only one form that needs to be reviewed when describing the size of the cultivation.
