RE:Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on December 21st, 2022, and January 26th, 2023. Twenty-two Notice of Violations were sent on December 22nd, 2022. Twenty-seven Notice of Violations were sent on January 30th, 2023.

The Department of Revenue combined both active and expired licenses that owe taxes on both lists from December 2022 and January 2023 on their memos.

Attached are the memo's provided by the Department of Revenue and Notice of Violations separated by responses and non-responses.

This seems to be working well to control our costs and not constantly be suffering from the high burden of selling just trimmed flower as a small cultivation's only revenue stream.
