RE: Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on June 29th, 2023, July 27th, 2023, April 20th, 2023, and August 17th, 2023. Sixteen Notice of Violations were sent on July 3rd, 2023. Seventeen Notice of Violations were sent on July 28th, 2023. Nineteen Notice of Violations were sent on August 17th, 2023.

Active and expired licenses are combined on the lists below provided by The Department of Revenue.



This is a notice to you as licensee that an alleged violation has occurred. Marijuana cultivation facility fails to pay tax; AS 43.05.230(e) DOR can publish list of taxpayer(s) who failed to pay their taxes.; 15 AAC 61.020. License revocation and suspension.

**3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice. A licensee may respond, either orally or in writing, to the Notice.**

Good Morning Jason,

All tax payments have been made to the state. I'm not sure why the May tax payment due shows a balance of \$65.38, but Ben is out of the office at the DOR. I sent the amount due from the slip and that same amount reflects as received. I initiated a wire transfer for the \$65.38 just for good measure because I don't want to wait for his response. I've attached screen shots of the account paid in full as well as verification of the wire transfer.

I hope this stops the NOV from moving forward! Either way the amount that triggered the NOV of \$646.80 has been paid.
