STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and CK Group Partnership, d/b/a Van Reuben Willis Insurance (CK Group), the licensee in this matter, stipulate and agree that the unlicensed activity that occurred during the time CK Group was not appropriately licensed is resolved as follows:

1. On or about June 5, 2009, the division received notification that the firm's federal employer identification number had been changed when the sole proprietorship of Van Reuben Insurance was converted to CK Group Partnership. This change occurred in 2006 although the partnership started on January 1, 2005. License number 79590 was subsequently issued in the partnership name, effective June 16, 2009.
2. As required by the division, CK Group submitted a notarized statement listing whether business had been transacted when the firm was not appropriately licensed as the partnership. The statement indicated that insurance had been transacted between May 3, 2006 and June 12, 2009.

3. CK Group agrees to pay a civil penalty under AS 21.27.440(a) in the amount of \$5,000 with \$3,000 suspended. The civil penalty is payable at the time CK Group is notified that the director has signed the order approving this agreement.

4. In the event CK Group violates the Alaska insurance laws during the next two years, the suspended portion of the fine referenced in paragraph 3 will be reinstated. CK Group also will be subject to any and all sanctions authorized by the insurance laws including imposition of additional penalties.

5. By signing this agreement, CK Group understands and agrees that any failure to comply with the terms of this agreement may be grounds to revoke, suspend, or non-renew Alaska insurance license number 79590.

6. CK Group understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.




