	11	1. On July 2, 2014, the division issued Adela Fangaeva Poulivaati (Poulivaati) trainee
	12	independent adjuster license number 0100106961.
	13	2. The effective date of Poulivaati's license was July 2, 2014.
	14	3. AS 21.27.840(c)(1) requires a trainee independent adjuster licensee, not later than
	15	four months after the effective date of the licensee's trainee independent adjuster license, to
	16	comply with the independent adjuster licensing requirements of AS 21.27.060 concerning the
	17	insurance laws and regulations of this state.

	19	4. AS 21.27.060 requires licensees to personally take and pass, to the satisfaction of the
	20	director, an examination that tests the knowledge and competence of the applicant as to the
	21	applicant's duties and responsibilities as a licensee and the insurance statutes and regulations of
	22	the state.
	23	5. After receiving an inquiry from the division regarding the status of Poulivaati's exam
	24	results, Poulivaati, on December 30, 2014, notified the division that she had failed to pass her
	25	adjuster's exam.

6. Due to Poulivaati's failure to pass the independent adjuster licensing examination to
the satisfaction of the director within the four month period after the effective date of her
trainee independent adjuster license, the director is required under AS 21.27.840(c) to revoke
Poulivaati's license.

7. Pursuant to AS 21.27.840(d), Poulivaati may submit a new application for a trainee independent adjuster license after she has successfully completed the testing requirements of AS 21.27.840(c).
