16 **COMPANY OF MILWAUKEE, WISCONSIN** in this state.

18 **IT IS FURTHER ORDERED**, that during the period of suspension,
19 **NORTHWESTERN NATIONAL INSURANCE COMPANY OF**
20 **MILWAUKEE, WISCONSIN** shall not solicit or write any new business in
21 Alaska, but shall file the Annual Statement, pay fees and any taxes due as
22 provided by AS 21.09.170 (h).


