WHEREAS, a Certificate of Authority to transact the business of insurance
in the State of Alaska was issued to **NATIONAL HEALTH INSURANCE**
COMPANY, domiciled in the State of Texas.

WHEREAS, the Commissioner of Insurance of the State of Texas, placed
NATIONAL HEALTH INSURANCE COMPANY under an Order of
Supervision for being hazardous to the public on September 8, 2003.

1 **WHEREAS**, the Certificate of Authority issued to **NATIONAL HEALTH**
2 **INSURANCE COMPANY** to transact the business of insurance in the State of
3 Alaska was suspended on March 10, 2004, for a period of one year by reason of
4 placement of **NATIONAL HEALTH INSURANCE COMPANY** into said
5 supervision in accordance with AS 21.09.140 (a) (2) and for failure to meet the
6 capital and surplus requirements in accordance with AS 21.09.070. This order
7 has since been extended to the present.

11 **WHEREAS**, the Quarterly Statement dated September 30, 2008 shows that
12 **NATIONAL HEALTH INSURANCE COMPANY** now meets the Capital and
13 Surplus Requirements of AS 21.09.070.

16 **WHEREAS**, On September 30, 2008 the Commissioner of Insurance of the
17 State of Texas released **NATIONAL HEALTH INSURANCE COMPANY**
18 from the Order of Supervision as it had substantially complied with the terms of
19 said order.

22 **IT IS HEREBY ORDERED**, pursuant to the provision of
23 AS 21.09.170 (a) that Certificate of Authority No. F-1403 issued to **NATIONAL**
24 **HEALTH INSURANCE COMPANY**, shall be reinstated, allowing it authority
25 to continue to transact the business of insurance in the State of Alaska. Pursuant


