CONSENT AGREEMENT

The Division of Banking, Securities and Corporations (the Division) issued Alaska Order #95-04S, Temporary Order to Cease and Desist, and Order Proposing Civil Fine (the Temporary Order) naming the above RESPONDENTS on December 30, 1994.

Respondents' counsel advised the Division of their wish to effect a settlement of the Temporary Order. Respondents have not requested a hearing in this matter and wish to accede to the Temporary Order becoming permanent and payment of a reduced \$1,500 civil fine.

The Division and Respondents wish to settle the issues in the matter without the time and expense associated with an Administrative Hearing. David W. Williams and Marvin Butler, on behalf of Respondents, attest under oath, agree and consent as follows:

Respondents have ceased making offers and soliciting sales of any securities, including the Montgomery SMR System, or any other purported general partnership interests, to Alaska residents and have complied with the Temporary Order in all respects.

Respondents agree not to make any further offers or sales of securities without registration of the offering or the filing of an exemption notice pursuant to Alaska Statute (AS) 45.55.070, regardless of any exceptions contained in applicable law. Respondents agree to comply with all provisions of the Alaska Securities Act including the antifraud provisions of AS 45.55.010.

Respondents agree not to engage in any securities business or transactions as a broker dealer, agent, or investment advisor in Alaska, or with Alaska residents, regardless of the location of any party or any exception contained in applicable law, until properly registered with the Division.

Respondents attest that neither they nor their affiliates, including CLT Document Services, Inc., a Nevada Corporation, have offered or sold any other securities, including purported general partnerships or other investment opportunities, to Alaska residents.

Respondents attest that all transactions with Alaska residents in the Intech Group's Montgomery SMR System have been disclosed to the Division. Respondents have previously provided proof of refunding \$22,495 representing a single Alaskan transaction.

Respondents consent to a \$1,500 civil fine under terms of the Alaska Securities Act, Section 45.55.920(c) and include herewith valid payment of this amount with the returned, signed, and notarized Consent Agreement.

Respondents waive all rights to a hearing in this matter and accede to the entry of this Final Order #95-04S to Cease and Desist and Imposition of Civil Fine.

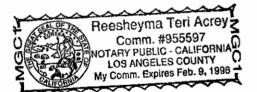
