#### 7. Investigative Report/Training

Jasmin Bautista presented the Investigative Report. The report covered April 12, 2022 through September 7, 2022. There are currently 14 open cases in various statuses, and 5 were closed.

#### 8. Division Update

Division Director Sara Chambers joined the meeting

Director Chambers joined the meeting to discuss creating a Disciplinary Matrix committee with the board and what a committee entails. After receiving this information, the board elected to discuss the Disciplinary Matrix the next day during the scheduled agenda item.

## A. HB 265

HB265 is now in effect in Centralized Statutes as AS 08.01.085. This bill applies to Social Workers. These new statutes explain Telehealth in full. The Division now has a website page explaining the new Telehealth laws: <a href="https://www.commerce.alaska.gov/web/cbpl/TelehealthInformation.aspx">https://www.commerce.alaska.gov/web/cbpl/TelehealthInformation.aspx</a>

The board then reviewed their telehealth regulations in full to ensure they were in compliance with the new Telehealth centralized statutes. No adjustments are needed to Article 3 of the Social Work regulations.

## B. Naloxone Response Request – discussion

Director Chambers reached out to the Department of Law to answer questions the board has had on a Naloxone Response Request from the Veteran's Health Administration National Social Work Program Office. The board wanted to know if licensed social workers can legally administer naloxone. The response from Department of Law stated "at this time except in emergency situations, social workers in Alaska cannot administer Naloxone (Narcan)". However, should the board desire to allow this, statutory framework is in place. Board Chair Brandon Ercanbrack will complete the form, which will then be sent forward by OLE Davis.

### 10. Department of Health Presentation – C. Lee

Charity Lee from Department of Health joined the meeting

Charity Lee presented to the board: Training Social Workers on Suicide: The Need for Required Education. This presentation provided various suicide/psychiatric care/suicide training statistics in Alaska. The presentation noted that suicide continuing education is needed for the Social Work workforce in Alaska, as Alaska currently has the second highest suicide rate in the nation, and is the highest for youth. The Division of Behavioral Health currently offers trainings through at least 2027 with CEUs, and there are free online trainings with CEUs available through AFSP, Zero Suicide listserv, smiadvisor.org, etc. Almost every state that requires suicide continuing education includes three CEUs as a one-time requirement.

The board noted that they will have additional discussion on this tomorrow during the New Business agenda item.

# 1. Call to Order/Roll Call

Chairperson Brandon Ercanbrack called the meeting to order at 9:00am

# 2. Old Business

# A. Regulation Update – 12 AAC 18.108 Temporary Military Courtesy License; 12 AAC 18.115 Supervision

Both regulations went into effect as of 9/11/22. Applicants may apply for a Temporary Military Courtesy License if they meet the requirements. OLE Davis issues these without board approval. There is no paper application for this license type. The Supervision regulations were updated to re-define "face-to-face" so applicants may receive supervision via Zoom/Phone/etc. without prior board approval. The current Position Statement on this topic must be updated. Ann Applebee assigned herself this task. Once completed, it will go to OnBoard for approval by the board as a whole.

# **3. New Business**

# A. Disciplinary Matrix – Create committee?

After receiving further information from Director Chambers on creating a committee, the board has decided they would prefer to have a Board Meeting to create the Disciplinary Matrix. Jasmin Bautista stated it will likely be a long project, but a half-day meeting would be sufficient to begin the project. The board will reach

out to other jurisdictions to see if they would be willing to provide their disciplinary matrices as an example. The board will schedule this meeting during the Administrative Business agenda item.

# **B. Discuss Prorating CEs**

## Lacey Derr joined the meeting

RLS Derr asked the board to review their current CE regulations, and to discuss if they would like to update their regulations to prorate CEs for those who have had their license for 12 months or less when they renew. The board reviewed the Continuing Education regulations for all other mental health boards. The board discussed this in full and agreed on a regulation change. In addition, the board discussed the possibility of adding Suicide Prevention continuing education and the presentation received from Charity Lee. The board agrees this is not going anywhere, and it is important for social workers to be knowledgeable in this area.

A motion duly made by Ann Applebee, seconded by Amber Taylor and approved by unanimous consent, was Resolved to approve a regulation change to 12 AAC 18.210: Renewal 12 or less months: 21 hours of Continuing Education (6 AK native, 6 Substance Abuse, 3 Ethics, 3 Teletherapy, 3 Suicide Prevention)

# **C. Social Work Compact**

RLS Derr discussed the Social Work Compact draft recently released by ASWB. ASWB would like feedback from board members from all jurisdictions regarding the compact draft. Alaska is interested in the compact in what this can do for license mobility, however discussions must be had for financial reasons as the board does not collect revenue from compact licensees (when initially licensed in other states), but they are required to pay for Investigations costs. RLS Derr states that we would like to assign a board member the task of being the go-to person regarding the Social Work Compact. Chairperson Ercanbrack has assigned himself this task. OLE Davis will forward any pertinent emails as necessary.

# D. TBD

RLS Derr discussed the Motivo platform with the board. Motivo is a platform for telesupervision. This platform tracks hours, assists applicants in finding a supervision, amongst other things. The board should be aware Motivo made need to be discussed further in the future if the Division decides to discuss using this platform. RLS Derr will provide updates on this topic. It will be added to the agenda as necessary in the future.

# 4. NASW AK Chapter Meeting

Toni Protzman joined the meeting

Toni Protzman is the Executive Director for the NASW Alaska Chapter. She wanted to introduce herself to the board to see how they can work together, offer her resources to the board as necessary, and wanted the board's opinion on the upcoming compact. She will be surveying her membership to see which way they are leaning on the compact as well. The board is interested in the results of that survey. This will be provided to the board once received. This amongst other survey findings will be emailed to OLE Davis and forwarded to the board/added to the agenda as necessary. Toni Protzman has started a library online to pull up all CEs and Alaska Native CEs so all licensees can find CEs as necessary.
