# ETHICS ACT PROCEDURES FOR BOARDS & COMMISSIONS

All board and commission members and staff should be familiar with the Executive Branch Ethics Act procedures outlined below.

#### Who Is My Designated Ethics Supervisor (DES)?

Every board or commission subject to the Ethics Act<sup>1</sup> has several ethics supervisors designated by statute.

- The chair serves as DES for board or commission members.
- The chair serves as DES for the executive director.
- The executive director serves as DES for the staff.
- The governor is the DES for a chair.<sup>2</sup>

#### What Do I Have To Disclose?

The Ethics Act requires members of boards and commissions to disclose:

- Any matter that is a potential conflict of interest with actions that the member may take when serving on the board or commission.
- Any circumstance that may result in a violation of the Ethics Act.
- Any personal or financial interest (or that of an immediate family member) in a state grant, contract, lease or loan that is awarded or administered by the member's board or commission.
- The receipt of certain gifts.

The executive director of the board or commission and its staff, as state employees, must also disclose:

- Compensated outside employment or services.
- Volunteer service, if any compensation, including travel and meals, is paid or there is a potential conflict with state duties.

For more information regarding the types of matters that may result in violations of the Ethics
 Act, board or commission members should refer to the guide, "Ethics Information for Members of
 Boards and Commissions." The executive director and staff should refer to the guide, Ethics
 Information for Public Employees." Both guides and disclosure forms may be found on the
 Department of Law's ethics website.

#### How Do I Avoid Violations of the Ethics Act?

- · Make timely disclosures!
- · Follow required procedures!
- Provide all information necessary to a correct evaluation of the matter!<sup>3</sup>
- · When in doubt, disclose and seek advice!
- Follow the advice of your DES!

# What Are The Disclosure Procedures for Board and Commission Members?

The procedural requirements for disclosures by members are set out in AS 39.52.220 and 9 AAC 52.120. One goal of these provisions is to help members avoid violations of the Ethics Act. The procedures provide the opportunity for members to seek review of matters in advance of taking action to ensure that actions taken will be consistent with the Act.

#### Procedure for declaring actual or potential conflicts.

Members must declare potential conflicts and other matters that may violate the Ethics Act on the public record and in writing to the chair.

*Disclosure on the public record.* Members must identify actual and potential conflicts orally at the board or commission's public meeting **in advance** of participating in deliberations or taking any official action on the matter.

- A member must always declare a conflict and may choose to refrain from voting, deliberations or other participation regarding a matter.<sup>4</sup>
- If a member is uncertain whether participation would result in a violation of the Act, the member should disclose the circumstances and seek a determination from the chair.

*Disclosure in writing at a public meeting.* In addition to an oral disclosure at a board or commission meeting, members' disclosures must be made in writing.

- If the meeting is recorded, a tape or transcript of the meeting is preserved and there is a method
  for identifying the declaration in the record, an oral disclosure may serve as the written
  disclosure.
- Alternatively, the member must note the disclosure on the Notice of Potential Violation disclosure form and the chair must record the determination.

Confidential disclosure in advance of public meeting. Potential conflicts may be partially addressed in advance of a board or commission's public meeting based on the published meeting agenda or other board or commission activity.

- A member identifying a conflict or potential conflict submits a Notice of Potential Violation to the chair, as DES, in advance of the public meeting.
- This written disclosure is considered confidential.
- The chair may seek advice from the Attorney General.
- The chair makes a written determination, also confidential, whether the disclosed matter represents a conflict that will result in a violation of the Ethics Act if the member participates in official action addressing the matter. <sup>5</sup>
- If so, the chair directs the member to refrain from participating in the matter that is the subject of the disclosure.
- An oral report of the notice of potential violation and the determination that the member must refrain from participating is put on the record at a public meeting.<sup>6</sup>

*Determinations at the public meeting.* When a potential conflict is declared by a member for the public record, the following procedure must be followed:

- The chair states his or her determination regarding whether the member may participate.
- Any member may then object to the chair's determination.
- If an objection is made, the members present, excluding the member who made the disclosure, vote on the matter.
- Exception: A chair's determination that is made consistent with advice provided by the Attorney General may not be overruled.
- If the chair, or the members by majority vote, determines that a violation will exist if the disclosing member continues to participate, the member must refrain from voting, deliberating or participating in the matter.<sup>7</sup>

If the chair identifies a potential conflict, the same procedures are followed. If possible, the chair should forward a confidential written notice of potential violation to the Office of the Governor for a determination in advance of the board or commission meeting. If the declaration is first

made at the public meeting during which the matter will be addressed, the members present, except for the chair, vote on the matter. If a majority determines that a violation of the Ethics Act will occur if the chair continues to participate, the chair shall refrain from voting, deliberating or participating in the matter. A written disclosure or copy of the public record regarding the oral disclosure should be forwarded to the Office of the Governor for review by the chair's DES.

#### **Procedures for Other Member Disclosures**

A member's interest in a state grant, contract, lease or loan and receipt of gifts are disclosed by filling out the appropriate disclosure form and submitting the form to the chair for approval. The disclosure forms are found on the Department of Law's ethics website.

# What Are The Disclosure Procedures for Executive Directors and Staff?

Ethics disclosures of the executive director or staff are made in writing to the appropriate DES (chair for the executive director and the executive director for staff).

Disclosure forms are found on the ethics website, noted above.

Notices of Potential Violations. Following receipt of a written notice of potential violation, the DES investigates, if necessary, and makes a written determination whether a violation of the Ethics Act could exist or will occur. A DES may seek advice from the Attorney General. If feasible, the DES shall reassign duties to cure a potential violation or direct divestiture or removal by the employee of the personal or financial interests giving rise to the potential violation.

- These disclosures are not required to be made part of the public record.
- A copy of a determination is provided to the employee.
- Both the notice and determination are confidential.

Other Disclosures. The DES also reviews other ethics disclosures and either approves them or determines what action must be taken to avoid a violation of the Act. In addition to the disclosures of certain gifts and interests in the listed state matters, state employees must disclose all outside employment or services for compensation.

The DES must provide a copy of an approved disclosure or other determination the employee.

# How Are Third Party Reports of Potential Violations or Complaints Handled?

Any person may report a potential violation of the Ethics Act by a board or commission member or its staff to the appropriate DES or file a complaint alleging actual violations with the Attorney General.

- Notices of potential violations and complaints must be submitted in writing and under oath.
- Notices of potential violations are investigated by the appropriate DES who makes a written determination whether a violation may exist.<sup>8</sup>
- Complaints are addressed by the Attorney General under separate procedures outlined in the Ethics Act.
- These matters are confidential, unless the subject waives confidentiality or the matter results in a public accusation.

#### What Are The Procedures for Quarterly Reports?

Designated ethics supervisors must submit copies of notices of potential violations received and the corresponding determinations to the Attorney General for review by the state ethics attorney as part of the quarterly report required by the Ethics Act.

- Reports are due in April, July, October and January for the preceding quarter.
- A sample report may be found on the Department of Law's ethics website.
- An executive director may file a quarterly report on behalf of the chair and combine it with his or her own report.
- If a board or commission does not meet during a quarter and there is no other reportable activity, the DES advises the Department of Law Ethics Attorney by e-mail at ethicsreporting@alaska.gov and no other report is required.

If the state ethics attorney disagrees with a reported determination, the attorney will advise the DES of that finding. If the ethics attorney finds that there was a violation, the member who committed the violation is not liable if he or she fully disclosed all relevant facts reasonably necessary to the ethics supervisor's or commission's determination and acted consistent with the determination.

# How Does A DES or Board or Commission Get Ethics Advice?

A DES or board or commission may make a **written request** to the Attorney General for an opinion regarding the application of the Ethics Act. In practice, the Attorney General, through the state ethics attorney, also provides **advice by phone or e-mail** to designated ethics supervisors, especially when time constraints prevent the preparation of timely written opinions.

- A request for advice and the advisory opinion are confidential.
- The ethics attorney endeavors to provide prompt assistance, although that may not always be possible.
- The DES must make his or her determination addressing the potential violation based on the opinion provided.

It is the obligation of each board or commission member, as well as the staff, to ensure that the public's business is conducted in a manner that is consistent with the standards set out in the Ethics Act. We hope this summary assists you in ensuring that your obligations are met.

- <sup>1</sup> The Act covers a board, commission, authority, or board of directors of a public or quasi-public corporation, established by statute in the executive branch of state government.
- <sup>2</sup> The governor has delegated the DES responsibility to Guy Bell, Administrative Director of the Office of the Governor.
- <sup>3</sup> You may supplement the disclosure form with other written explanation as necessary. Your signature on a disclosure certifies that, to the best of your knowledge, the statements made are true, correct and complete. False statements are punishable.
- <sup>4</sup> In most, but not all, situations, refraining from participation ensures that a violation of the Ethics Act does not occur. Abstention does not cure a conflict with respect to a significant direct personal or financial interest in a state grant, contract, lease or loan because the Ethics Act prohibition applies whether or not the public officer actually takes official action.
- <sup>5</sup> The chair must give a copy of the written determination to the disclosing member. There is a determination form available on the Department of Law's ethics web page. The ethics supervisor may also write a separate memorandum.
- <sup>6</sup> In this manner, a member's detailed personal and financial information may be protected from public disclosure.
- <sup>7</sup> When a matter of particular sensitivity is raised and the ramifications of continuing without an advisory opinion from the Attorney General may affect the validity of the board or commission's action, the members should consider tabling the matter so that an opinion may be obtained.
- <sup>8</sup> The DES provides a copy of the notice to the employee who is the subject of the notice and may seek input from the employee, his or her supervisor and others. The DES may seek advice from the Attorney General. A copy of the DES' written determination is provided to the subject employee and the complaining party. The DES submits a copy of both the notice and the determination to the Attorney General for review as part of the DES' quarterly report. If feasible,

the DES shall reassign duties to cure a potential violation or direct divestiture or removal by the employee of the personal or financial interests giving rise to the potential violation.

The board welcomed Alison Osborne, one of the division's regulations specialists, to the meeting.

The board began discussion on the board's regulation projects, first starting with an amendment to **12 AAC 75.200**. **REGISTERED GUIDE-OUTFITTER PROVIDING SERVICES**. Chairman Jason Bunch explained that the changes to the regulation were in response to a request from the Alaska Wildlife Troopers, to amend the regulations so they allow registered guide-outfitters to provide transportation services through guide use areas they are not registered in, as long as the transportation services originate or terminate in a guide use area for which the guide-outfitter is registered.

The board moved onto another regulation project, a repeal of **12 AAC 75.230(g). GUIDE USE AREA REGISTRATION**. The board stated that the intent of the regulation was for the purpose of guide-outfitters being able to have a Spring brown bear season in Game Management Unit (GMU) 9 in 2021 instead of 2020 and was only created because of guiding/hunting complications due to COVID-19.

The board moved onto another regulation project, an amendment to **12 AAC 75.400(a)**. **TRANSPORTER ACTIVITY REPORT.** The board stated that this was merely an update to the transporter activity report (TAR), changing some of the required information that is provided by a transporter when they are transporting clients. After discussion, the board decided to change the type of services provided (#2 on the form), located at the top of the new form, to read as:

 You Must Check all that Apply: Drop Off, Pick Up, Marine Drop Off & Pickup w/ Overnight

Ms. Osborne informed the board that, because the form is adopted by reference, they only needed to change the revised date on the form, and that the form could be used immediately. She also said that the revised date must be in advance of their public notice. The board discussed using the form immediately. Mr. Bay informed the board that they had roughly 3,000 TARs left, and suggested moving over to the new form when they start running low. Chairman Bunch asked Ms. Osborne if they could still use the TARs they have left if they decided on a revised date of December 2023, to which she said yes. The board agreed to a revised date of December 2023 for the new form and would move forward with it when they run low on the number of TARs they currently have. 12 AAC 75 is amended by adding a new section to read:

AAC 75.405. Marking of aircraft and vessels used by guides and transporters (a) aircraft used by a guide shall be marked with 12-inch FAA Registration numbers, not less than 1" thick in a color that contrasts with the background and is easily visible from a distance.

- (b) any vessel over 16 feet in length used by a guide or transporter must be marked with 12-inch numbers, on both sides of the vessel that are not less than 1" thick in a color that contrasts with the background and is easily visible from a distance. The number shall include the guide license number for guides prefixed by the letter "G", and transporter license number for transporters prefixed by the letter "T".
- (c) a guide or transporter shall display an authorized sticker on a vessel used for the purposes of transportation. The following board approved design must be used by the guide or transporter



(d) an authorized sticker or more may be provided to the licensee.

(b) A registered guide-outfitter who contracts to guide a hunt and who is participating in a hunt as required in AS 08.54.630(b)(3) shall be in communication, either personally or through an agent, with the assistant guide, who is in the field with the client, at least once during the hunt if the hunt is longer than five days.

- (c) In this section, "communication" includes in-person contact, radio contact, telephone contact, and signaling.

- (1) before leaving a client in the field, advise the client of the date, time, and location at which the registered guide-outfitter will pick up the client and the course of action the client should follow if the registered guide-outfitter is unable to pick up the client as planned;
- (2) either personally or through a class-A assistant guide, an assistant guide, or a licensed transporter, transport the client into and out of the field at the planned date, time, and location, unless prevented by weather, mechanical problems, or other safety concerns; and
  - (3) check on or communicate with a client in the field as agreed to before transporting that client.

**12 AAC 75.260. REGISTERED GUIDE-OUTFITTER CONTRACT REQUIREMENTS.** (a) A contracting registered guide-outfitter shall deliver a written contract to the client within 90 days after receipt of a deposit, or before services are provided, whichever is earlier.

- (b) A contract must
- (1) include the name, license number, and signature of the guide-outfitter, and must include the name of the guide-outfitter's business if it is different from the name of the individual guide-outfitter;
  - (2) include the name and signature of the client;
  - (3) list each big game animal to be hunted, and must identify the primary animal to be hunted;
  - (4) list the approximate times and dates that the client will be in the field;
  - (5) list the number of hunting days and dates for each species, if appropriate;
  - (6) state the cost and payment schedule;
- (7) state the amount of the trophy fee, if any, and must identify who is responsible for the cost of the license and tags;
  - (8) state the extra transportation cost, if any;
- (9) include a statement of services provided, including lodging, meals, number of clients per guide, trophy care and shipping, care of meat, and clarification of who is responsible for what;
  - (10) set out the deposit refund or transfer policy upon cancellation;
- (11) include a statement about compensation for any delay of the client arriving in the field on schedule or for the client departing the field before the contracted hunt ends; and
  - (12) identify who is responsible for private and federal land use fees.
  - (c) A registered guide-outfitter shall retain a copy of the contract for at least four years.
- (d) A contracting registered or master guide who is signing the hunt contract, and who intends to apply a client for a drawing hunt permit for a hunt conducted under regulations required under AS 16.05, shall obtain a unique verification code for each guide use area in which a unique verification code is required from the department before entering an application for the client. Unique verification codes will only be issued to registered or master guides who are registered in a guide use area located in the hunt area the year the application is made and the years the permit is valid. Unique verification codes are current until the associated guide use area registration expires or is withdrawn or amended. Unique verification codes may only be utilized by the contracting registered or master guide who is applying clients for a drawing hunt permit.
- (e) A contract may be amended at any time before the conclusion of the hunt, as recorded on the hunt record, with the signature of the contracting guide-outfitter and the client.

# 12 AAC 75.265. GUIDE USE AREA BOUNDARY CHANGES. (a) The board may propose to amend guide use area boundaries

- (1) on its own motion;
- (2) upon the recommendation of the Department of Fish and Game; or
- (3) in response to a petition from another person.

- (b) At least 90 days before the date of a board meeting at which guide use area boundaries changes are proposed, the department will publish, in a newspaper of general circulation, a notice soliciting petitions to propose amendments to guide use area boundaries. To be considered for proposal by the board at the board's next meeting, a petition must be received by the department no later than 60 days after the notice is published.
- (c) If the board proposes to amend guide use area boundaries, the board will mail notice of the proposed amendment to
- (1) each registered guide-outfitter with a valid license who is registered for a guide use area the boundaries of which are proposed for amendment;
  - (2) the Department of Natural Resources;
  - (3) the Department of Fish and Game; and
  - (4) the Department of Public Safety.
  - (d) The board may amend guide use area boundaries after considering whether
    - (1) the Department of Fish and Game objects to the proposed amendment; and
    - (2) amendment of existing guide use area boundaries is necessary in order to respond to
      - (A) big game conservation and management concerns, including
        - (i) abundance and diversity of big game;
        - (ii) the historical harvest of big game in an area; and
        - (iii) existing administrative boundaries established for wildlife management purposes;
      - (B) law enforcement concerns;
      - (C) land ownership in an area;
      - (D) administrative restrictions;
      - (E) the existence of boundaries that can be readily identified in the field;
      - (F) the accessibility of an area and other transportation considerations;
      - (G) the existence of complementary and noncomplementary land uses within an area;
      - (H) recommendations of the Department of Natural Resources;
      - (I) the existing facilities within the area;
      - (J) any public comment received; and
      - (K) other considerations relevant to the drawing of guide use area boundaries.

Mr. Bay,

This letter is written in response to your e-mail sent February 6, 2024 and our phone conversation on February 8, 2024.

During the phone call we concluded that item (1) in your e-mail was not missing and you had acceptable data from forms submitted by Ellis Big Game Guides.

We talked at length about your request regarding item (2) in the e-mail. You noted that my notarized submittal from my Master Guide indicating I had more than 125 days "in field" did not suffice in order to allow me to sit for the RGO exam in March. I pointed out that there is not a clear position that defines my submittal was insufficient in allowing me to sit for the test in March. You indicated that I needed to summarize my points and position in a letter in order to allow the matter to be elevated because the current practice of approval only recognized "hunt records" submitted by someone other than me. These records are confidential and not subject to inspection or copying per Alaska Statute 08.54.760. I do not have knowledge, control, or any other pertinent details on the referenced "hunt records". This is not the business, responsibility, or requirement of an Assistant Guide. In fact it could be argued that I was violating the law if I was involved with it because it is part of contracting a hunt.

The following lines out the intent of the statutes and regulations as it pertains to my application and the overall support of the position that I meet the requirements to sit for the RGO Exam:

First, I would like to clarify I submitted a complete application in October of 2023. All required items on Form 08-4013 (Rev. 6/28/18) were submitted and delineated with cover sheets.

The item in question is bullet number two on Form 08-4013 (Rev. 6/28/18):

"has been licensed as and performed the services of a Class A Assistant Guide or Assistant Guide, or a Class-A Assistant Guide Outfitter or Assistant Guide-Outfitter in Alaska for a part of each of three years for a total of *125 days* "in field" guiding experience;"

On Form 08-4013c (Rev. 6/28/18) I submitted a notarized form indicating I had a total of 237 days in unit 12 "in the field" on "guided hunts". The definition of "field" per Sec. 08.54.790, **DEFINITIONS** is:

"'field" means an area outside established year-round dwellings, businesses, or other developments associated with city, town, or village; "field" does not include permanent hotels or roadhouses on the state road system or state or federally maintained airports;"

Please note that my experience in the application applies to <u>days "in field"</u> in Unit 12, per this definition given by the State of Alaska. I have a lot more days <u>"in field"</u> than this as a licensed Assistant Guide. Furthermore, there is not a reference in the statutes or regulation that defines the days <u>"in field"</u> by a <u>"hunt record"</u>, as indicated in your e-mail.

I kindly ask that you reconsider your position on my application. Based on the timeline so far, I will assume that clarification will not be reached in time for the March test, but I hope it can be cleared up in time for next December's test. I was hoping to have qualified for my Guide License in time for Spring Bear Season, thus saving me the expense of having to renew my Class-A Assistant Guide License. In the spirit of getting to a working solution I will pay the fee for a renewed Assistant Guide License and appreciate any monetary concession that may be available upon the passing of my Guide testing next winter.

I appreciate your time and help with this matter, and I can be reached most hours of the day at if you have any questions.
