On May 20, 2022, the Division filed an Accusation against Mr. Andrew's registered nurse license alleging violation of AS 08.68.276, 12 AAC 02.960(e), and 12 AAC 44.600 et seq. The central issue of the Accusation was Mr. Andrew's failure to prove completion of continuing competency as required after random audit, and his failure to comply with the requirements of the audit. The Accusation was properly served on May 24, 2022, in accordance with AS 44.62.380. Mr. Andrew failed to respond within 15 days of service as required by AS 44.62.390, and the Division proceeded to present its case of default to the Board on November 1, 2022. On November 2, 2022, the Order of Default was mailed by certified mail to Mr. Andrew's address of record in accordance with AS 44.62.530, which was delivered to Mr. Andrew's address of record on November 7, 2022; 30 days after the decision was mailed or otherwise delivered (AS 44.62.520).</p>	Default Revocation

On May 19, 2022, the Division filed an Accusation against Ms. Chambers' registered nurse license alleging violation of AS 08.68.276, 12 AAC 02.960(e), and 12 AAC 44.600 et seq. The central issue of the Accusation was Ms. Chambers' failure to prove completion of continuing competency as required after random audit, and her failure to comply with the requirements of the audit. The Accusation was properly served on May 19, 2022, in accordance with AS 44.62.380. Ms. Chambers failed to respond within 15 days of service as required by AS 44.62.390, and the Division proceeded to present its case of default to the Board on November 1, 2022. On November 2, 2022, the Order of Default was mailed by certified mail to Ms. Chambers' address of record in accordance with AS 44.62.530, which mail was returned to the Division, and the revocation became effective on December 2, 2022; 30 days after the decision was mailed or otherwise delivered (AS 44.62.520).
