#### SB74/HB137 – Letters of Support

SB74=Passed on Senate side | HB137=Finance – Bill can still be amended in House Finance. If it gets amended; it would have to go back to Senate for concurrence. If minor changes, could be taken up on Senate floor. If more substantial changes, might dig into it more. If the House takes up the Senate version, does not have to go back to Senate for approval. Only one letter of support necessary at this time as SB74 has passed on senate side. Address letter to House Finance Committee Chairs w/individual copies addressed to each committee member.

Bills are not identical any longer between Senate + House. Senate introduced committee substitute bill <a href="https://www.akleg.gov/PDF/33/Bills/SB0074B.PDF">https://www.akleg.gov/PDF/33/Bills/SB0074B.PDF</a> that does not require fingerprinting of **currently** licensed Alaska physical therapists/PTAs to gain compact licensure. This affects renewals of Alaska license and anyone applying for a PT compact licensure in another state. This would not exempt initial licensure applicants. Sec. 4 is that change.

#### Sec. 4. AS 08.84 is amended by adding a new section to read:

Sec. 08.84.034 Exemption from criminal justice information and criminal history record check. A physical therapist, physical therapist assistant, occupational therapist, or occupational therapy assistant holding a valid license under this chapter on July 1, 2024,

is exempt from the requirements of AS 08.84.030(a)(4) and 08.84.032(a)(8), but is otherwise subject to this chapter.

For reference, here's the changes being made to Sec. 08.84.030 Qualification for licensing section

- 11 (4) have been fingerprinted and have provided the fees required
- 12 by the Department of Public Safety under AS 12.62.160 for criminal justice
- 13 information and a national criminal history record check; the fingerprints and
- 14 fees shall be forwarded to the Department of Public Safety to obtain a report of
- 15 criminal justice information under AS 12.62 and a national criminal history
- 16 record check under AS 12.62.400.

And the changes being made to 08.84.032 Foreign-educated applicant section

- (8) have been fingerprinted and have provided the fees required
- 11 by the Department of Public Safety under AS 12.62.160 for criminal justice
- 12 information and a national criminal history record check; the fingerprints and
- 13 fees shall be forwarded to the Department of Public Safety to obtain a report of
- 14 criminal justice information under AS 12.62 and a national criminal history
- 15 record check under AS 12.62.400.

Add language in letter of support of fingerprinting committee substitute language added on Senate side? YES – language added.

Concern regarding current effective date of implementation in the bill of July 1, 2024. Could amend date in House Finance for effective date to (six months) January 1, 2025 or (one year) July 1, 2025 to allow for more time as bill did not pass in first part of 33rd legislature. (Most likely wouldn't get kicked back to committees for this small of a change). This would allow for additional time needed for Board to enact regulations and Division necessary changes to implement. Add language to Letter of Support expressing this concern/requesting the effective date change? YES – language for one year extension added.

SB74/HB137 = exclusive to physical therapy **compact** licensure but would have impact on OT/OTA re: overall Alaska licensure requirements as fingerprint requirement would be extended to all initial Alaska license applicant types including OTs/OTAs.

Is Occupational Therapy going to introduce a bill to include compact licensure? Separate bill = YES Amendment? If separate bill introduced and not passed, it dies at end of 2024

session and has to be re-introduced in 2025. Model language available for OT. Harder to pass PT bill if amended at last minute to include OT.
