

On 3-5-13 one of my senior servers, Diana Kay Vega sold a beer to a person under age after looking at his ID, but not reading it correctly because she wasn't wearing her glasses and thought she saw 1992 for the year. Immediately after the violation I posted a note to all of the servers about the issue, then in a few days we had a staff meeting which included a discussion about the importance of clearly reading the dates and not just giving it a glace, and to always error on the side of caution. My older staff members have been told to always carry their reading glasses with them or to take ID's into the kitchen for better lighting and to get their glasses before ever serving drinks. In addition I have posted new labels on all of the registers, bar areas, banquet room areas and swinging doors reminding all the servers about the correct birth year necessary for being 21 years of age, just to prevent any possible confusion.

I believe I have the a very qualified and well trained staff who generally do an exemplary job of following the law, but this time Kay failed to take the extra caution that is necessary to be absolutely certain of being in compliance. In my 15 years of running this restaurant and lounge, this is our first violation and I would assume that for good long time my servers will be excessively thorough in ensuring that everyone who drinks here at Mykel's is of age and with proper identification.

This firm represents Kay Inc. Please let this letter serve as a response to the notice of violation ("NOV") issued on March 4, 2013. The NOV refers to two (2) violations: service to a minor and failure to have proof of completion of an approved alcohol served education course.

Kay Inc, and Mr. Martin Kim, take these matters very seriously. Responding first to the service to a minor violation, I am advised by Mr. Kim that what happened was simply a mistake. It should be known that Mr. Kim is an elderly gentleman with great respect for the military, and those that serve. Mr. Kim was confused because the identification furnished by the informant was a military identification card, but it did not have a date of birth on it. To this end, Mr. Kim asked the patron his age, and the patron represented that he was over the age of 21. This is where my client made his mistake.

I have spoken to Mr. Kim regarding this incident. He understands that in the future, he must adequately ensure that the patron furnishes their date of birth via a proper identification card, so that he can establish whether they are of the legal age. He will not make this mistake in the future. Kay Inc. has held a meeting of all its employees to discuss this issue, and how to assure it does not happen again in the future.

Further, on the date in question Mr. Kim did not have his TAM card on his person. He did, however, have valid TAM training. As a result of this incident, I have spoken with Kay Inc and Mr. Kim regarding ways to prevent this mistake in the future. We have discussed that the business should keep a binder containing copies of the TAM cards for all employees. This will help to ensure that this will never happen again.

Finally, as you are aware, Mr. Kim has been a licensee for over nine years. He has no criminal record. Mr. Kim accepts and realizes that he made a mistake in this instance.

My client and I would be glad to come down and talk to you about this NOV should you wish for us to do so. If further action is required, please contact me directly. Thank you for your time and consideration in this regard.

Good day. This correspondence is an official response to your initial correspondence titled Notice of Violation (please see attachment 1). I have read and reviewed the contents within and am prepared now to provide the following response:

In your letter you cited the date and time in which Mr. Hamilton had been involved in an incident that led to his arrest. I spoke with Mr. Hamilton concerning the incident to obtain his input on the incident that took place. He informed me that he was under a lot of stress at that particular time because he had a few issues prior to that with a "shady character" and was trying to maintain safety on the premises prior to the incident involving the underage minor that attempted to purchase alcohol. He also stated that was his first time having an encounter with the ABC agents. I informed him that, periodically, these inspections occur to insure that alcohol is being kept out of the hands of minors and there was no need for him to make a huge deal of the matter. Also, I reminded Hamilton that the store has posters all over concerning the Zero Tolerance Policy regarding state liquor laws and the violation thereof so he was made fully aware that I cannot and will not tolerate any actions that violate state liquor laws.

After further discussion, he mentioned that he was told in training that when an incident involves a minor attempting to purchase alcohol that he is supposed to confiscate the ID of the minor in question and release it to the local uniformed police officers so that they may make record of the incident. I then clarified with him that the ABC Inspector is considered law enforcement and he should have given the ID to the Inspector. After I explained and showed him some guidelines he then realized that he did not need to "err to the side of caution" and that these inspections are just a part of the business.

Regarding the matter surrounding his expired TAMS Card, I was unaware that his card was expired as he told me that he was up-to-date before we agreed to bring him in to assist the store in addressing security protocols in an effort to cut back on crime around the premises. Within 24 hours of the incident, he took the initiative to have the card renewed (see attachment 2).



On November 29, 2012, our Customer Service Associate Kristopher Ian Cox, was found to have sold an alcoholic beverage to a person under the age of 21 and thereby violated AS 04.16.052. As you know from past experience, this is a very serious matter for us since we work very hard to ensure that we perform all restricted age sales in a proper manner.

Kris Cox was employed by Tesoro starting May 31, 2012 and ending in December 4, 2012. Kris completed our initial, internal training for restricted product sales on June 2, 2012. Additionally, Kris completed the Techniques of Alcohol Management Course provided by CHARR on June 5, 2012. He also received additional in-house training conducted in October 18, 2012 to reinforce appropriate ID policy and practices (these verbal communications were documented and signed by him as part of our ongoing employee quality control and performance evaluation policies).

Our operating procedure requires all personnel to enter the DOB into the POS for verification of legal age, if the individual appears to be 30-years of age or younger. Kris failed to ask for identification. Kris Cox's employment was terminated following this incident.

We will continue to work diligently to minimize occurrences of improperly performed restricted product sales. Further review of standard policy, practices and expectations will be emphasized and conducted with our store employees and their managers to ensure correct future performance practices and compliance.

This firm represents Chepo's Fiesta and Jose Nanez. As such, please let this letter serve as a response to Notice of Violation No. 13-0049. We are providing you with this letter to explain our client's account of this alleged violation and to describe what actions have been taken to reinforce the policies in place at Chepo's with regard to it's employees relative to AS 04.16.030(A)(1) and all other pertinent statutes in Title 4 pertaining to the illegal sale of alcohol to minors.

This is my client's second NOV since opening over 27 years ago. It has been over 7 years since his first NOV. It appears from our investigation into this particular matter, that Chepos waitress, Theresa Burton, carded the minor, but misread the minor's identification. Ms. Burton apparently looked at the identification and then processed with the sale. This was a very serious mistake. Ms. Burton has been terminated from employment from Chepo's Fiesta as my client has a zero-tolerance policy for sales to minors or drunken persons.

Further, the NOV alleges that my client somehow made an intentional false statement to the ABC Board in his 2012 renewal and that this matter has been referred to the District Attorney's office for review regarding potential criminal charges. Please be advised that my client did not ever intentionally make false statements about anything to this Board or any other person for that matter. As such, he never had the requisite mens rea and a criminal prosecution will never succeed not to mention it seems like an overly harsh penalty based upon the facts and circumstances of this matter. Nonetheless, my client made a mistake and did not catch that Ms. Burton's TAM card was recently expired. In fact, she herself did not even know it was expired. As a result of this mistake, my client has fresh copies of all employee TAM cards in

his possession for both of his restaurants. Suffice it to say, my client will not make this mistake again.

In response to the sale to a minor issue, my client has met with all employees of Chepo's in both locations to stress the importance of their obligation to sell alcohol in a legal and accountable manner, with an emphasis on sales to minors and drunken persons. They will continue to implement policies and provide in-restaurant and supplemental training to insure that all employees conduct themselves in a professional, accountable, and legal manner. My client takes this Notice of Violation very seriously and welcomes the opportunity to come and speak to you personally about the efforts of the business to increase compliance and education to prevent these kinds of incidents from occurring at all.

On March 7, 2013 a employee of Pizza Paradiosos, Nena Ann Brewer, in Kenai, Alaska furnished alcohol during a compliance check to a person under 21. Ms. Brewer has worked at Pizza Paradisos for 25 years as a server, she has been an exemplary employee and asset to us. Unfortunately she has been diagnosed with both cataracts and stigmatism in both eyes. She wears either contact lenses or glasses while at work. During this incident Nena felt the person requesting the alcoholic drink appeared under the age of 21, she said the ID given to her was a stainless steel looking military ID, she had never seen one before and carried the ID from the table into the the servers station to better see and determine the date and authenticity; she said she saw the 1994 birthdate on the ID as 1992! She provided the drink. She said the fact that it was not a typical alaska ID made it hard for her to

see the number correctly. It was a shock to us that Nena of all servers at Paradisos would have made this type of mistake. We have had very few incidents of this kind in 42 years of business. We immediately had a staff meeting and explained to all our servers the severity of checking ID's properly. We have a large poster on wall with the year 1992 marked as a reference, we insisted all servers must ask another trained server to read the dates of ID's in question. We have provided a magnifying glass to Nena and anyone else who may have a hard time focusing on small print. We realize the consequences and responsibility we must abide by when serving alcohol to the public. Nena has gone to court and pled guilty of the charge, we too accept the responsibility of what occurred and as I said immediately called a meeting concerning only this issue. We hope this is satisfactory. Our liquor license number is 3032.

I am writing in response to the above referenced Notice of Violation issued on 12-28-2012 and received by myself and Rebecca Gerleve on 1-5-2013. I am the Food and Beverage Manager and Rebecca is the Restaurant & Lounge Manager, at the Fairbanks Princess Riverside Lodge.

As to the substance of the Notice of Violation, a citation and summons was issued to Erica Jane Kulwicki on 12-28-2012. She is employed as a bartender at the Fairbanks Princess Riverside Lodge. However, formal charges have yet to be filled by the District Attorney's Office.

Until the charges against Erica Jane Kulwicki are resolved, any actions on the Notice of Violation would be premature.

Following this incident, I have taken the following steps to ensure all staff are adhering to the laws of Title IV and providing responsible service.

- I have reviewed with the staff, the regulations pertaining to this Notice of Violation in the 2011-2012 Edition of the ABC Title IV statute book. AS 04.16.049 on page 56 and AS04.16.052 on page 62.
- 2. I have held a meeting with my Bartenders, Servers and Catering staff to review proper ID checking procedures and the types of identifications we accept.

We are asking for a second form of Identification when a customer presents a Military Identification. We are using the state identification to verify date of birth and alcohol restrictions.
- 5. We are requiring Erica to attend a TAPS course for a refresher on state laws and procedures in regards to serving alcoholic beverages.

My client, Stonebridge Companies ("Stonebridge"), who operates the Homewood Suites for Apple Six Services Anchorage II, LLC, pursuant to a management agreement, has asked me to respond on its behalf to Notice of Violation No. 13-0345 ("Notice") which was received on April 1, 2013. Please consider this letter Stonebridge's written response required by the Notice as well its written request for an appearance and opportunity to respond orally.

Foremost, let me assure you that Stonebridge is a responsible purveyor of alcoholic beverages and it makes every effort to operate in a legal and accountable manner. It also takes any possible violations very seriously. This letter is designed to inform you of the policies and procedures that were in place on the date of the incident as well as steps it has taken or is in the process of taking in order to ensure that violations of the type alleged in the Notice do not reoccur.

Initially, it is important that you are aware of the circumstances surrounding the incident of March 26, 2013. Homewood Suites is an extended stay hotel where the average guest spends at least a week. It does not have a restaurant or bar. The only alcohol served is at a "Manager's Reception" which takes place Monday through Thursday from 5:00 to 7:00 p.m. at which a buffet dinner along with beer and wine are available to hotel guests. No spirits are served. The reception is held in the hotel's "breakfast" room where Homewood Suites offers its guests daily breakfast. [Pictures of the dining and food service area are attached hereto as Appendix 1.]

In the food service area, there are taps for two kegs of beer. [Appendix 1 at pp. 4-6] The kegs are kept in a locked cabinet. Only during the Manager's Reception are the tap heads in place and the kegs connected. At the completion of each reception, the tap heads are removed and the hoses disconnected from the keg and secured. Wine is served from bottles, brought into the reception from secured storage and then removed after the reception. The alcohol service area has proper signage including a sign that clearly indicates that (1) only hotel staff can serve alcohol; (2) that there is a two drink limit and that the alcohol must be consumed in the reception area; and (3) notifies guests that room keys and ID's must be presented. [Appendix 1 at pp. 6-7.] All of these requirements are standard Stonebridge Policy. All Stonebridge employees who serve alcohol are TAP trained and certified. Both employees working the reception that night have current TAP cards. [See Appendix B.] It is also company-wide policy that all GM's and Managers-on-Duty be TAPS/TAMS trained.

Standard procedure for the Manager's Reception is to have one TAPS certified employee in the room dedicated to serving alcohol and one TAPS certified employee responsible for food service including replenishing the buffet during the reception hours. Servers are required to card ID any individual who appears to be under 30 years of age.

Stonebridge company-wide policy is to verify guest status by checking patrons' names against a guest list to be provided daily by the Front Desk agent and deny service to any person not a registered guest or accompanied by a registered guest. [A copy of the Stonebridge Companies' policy for "Alcoholic Beverages – Legal Compliance" in place on the date of the incident is attached hereto as Appendix C.] Unfortunately, these last two policies were not being followed by the now former Homewood Suites' General Manager on the night in question.

The policies and procedures followed by Stonebridge are in place to ensure that its servers comply with the laws of the State of Alaska, the Municipality of Anchorage, as well as Stonebridge's management principles when serving alcoholic beverages. The incident of March 26 was not due to a lack of policy or institutional control. It was caused by the hotel GM's failure to follow proper policy and protocol. Stonebridge is taking steps as explained further below to ensure there is no reoccurrence.

Earlier in the evening of March 26, the person later identified as your "UB-13-003" entered the Homewood Suites and asked the Front Desk employee "if there was a bar where" he "could get a drink." That person was informed that there was "no bar in the hotel" and was directed to the nearby Hilton Garden Suites. The person then left the hotel. Subsequently, at approximately 7:15 p.m., that individual apparently came back,

entered the reception area unnoticed and poured himself a beer from the tap, which was inappropriately left momentarily unattended.

Normally, the alcohol area is <u>never</u> left unattended by standard protocol. However, on this particular night at approximately 7:10 p.m., the dedicated beverage server on duty was asked to step away from the service area to assist a guest in another area of the hotel, before she had the opportunity to break down and store the alcohol. Prior to doing so she reported to the hotel GM, who was physically present at the reception, received his permission to leave her post and secured the GM's assurance that he would monitor alcohol service. At no time was the room or alcohol left unattended. However, in a monumental error in judgment, the GM failed to reposition himself in order to have a clear line of sight to the alcohol service area. Because it was 7:15 p.m., the reception had ended 15 minutes prior so the dedicated food employee was busy removing/storing food in and out of the kitchen. There were only a handful (6-8) people left in the reception area. It was at this exact time that the underage buyer took the opportunity to serve himself a beer.

The alleged violation apparently occurred despite Stonebridge's policies and procedures. This is unacceptable. Stonebridge therefore has taken or is in the process of taking the following corrective actions to prevent a reoccurrence.

- Stonebridge policy makes clear that failure to comply with "all applicable laws and Company policies and procedures may result in disciplinary action up to and including termination." The GM's failure to ensure compliance with company policy and Alaska law is not behavior Stonebridge will ever tolerate. In mid-March Stonebridge's General Manager submitted a two-month notice of resignation, effective in mid-May. If the General Manager had not already resigned, Stonebridge would have taken the appropriate disciplinary action and terminated him. As a result of the incident, the GM has been removed from his duties and not allowed to finish out the remainder of his employment.
- The server who left the tap unattended was not disciplined as she followed appropriate procedure.
- Stonebridge ensured implementation of the following safeguards at the Homewood Suites effective immediately:
 - (1) Mandating compliance with its guest list policy requiring that a hotel guest list be provided to the servers prior to each Manager's Reception and that the list be used to verify every patron as a hotel guest prior to service;

- (2) Mandating tracking each alcoholic beverage served on the guest list to enforce the two (2) drink limit per guest;
- (3) Mandating and training servers and Managers on Duty that the "tap area" must under no circumstances ever be left unattended;
- (4) Mandating and training servers and Managers on Duty that liquor should be the first area secured and locked every night exactly at 7 p.m.
- The incident has also caused Stonebridge to re-evaluate and enhance its policies and procedures for alcohol service at Manager Receptions company-wide to ensure it is following best practices. Mandatory training of the revised polices will follow implementation. Accomplishing this task is a top priority for Stonebridge.

Ms. Gifford, Stonebridge is committed to the safe and lawful service of alcoholic beverages. It will continue to strive to ensure it has proper policies and procedures in place and that its employees are appropriately trained to implement those policies and procedures so that the risk of any violations is minimized.

Policy:

All associates with job responsibilities pertaining to selling, serving and/or pouring alcoholic beverages will be trained and certified in a TIPS, TAM or Serve Safe program within thirty (30) days of hire, and will comply with applicable federal, state and local laws at all times.

Procedures:

- 1. No alcoholic beverages can be served, sold or poured on hotel premises by associates unless the hotel or restaurant has a valid liquor license.
- 2. The hotel's liquor license must be displayed prominently in the designated service and/or sales area(s) as required by law.
- 3. General Managers, MODs, F&B/Banquet/Room Service Managers and Supervisors and Sales Directors and Managers must be knowledgeable about the type and restrictions of the liquor license held by the hotel and federal, state and local regulations applicable to alcoholic beverages available in the hotel and/or restaurant.
 - a. General Managers will notify their Regional Operations Director of any changes in applicable laws or discrepancies between Company policies and procedures, applicable laws or franchise requirements. In all cases, the law supersedes any Company or franchise policy or procedure.
 - b. Regional Operations Directors and General Managers will contact the responsible corporate associate to file required notifications of management changes with regulatory authorities and to comply with procedures for management qualification.
- 4. Alcoholic beverage compliance (ABC) certification is required in states where certification is voluntary as well as in states where it is mandatory.
 - a. Associates whose job duties include supervision of or the actual sale, serving or pouring of alcoholic beverages and who do not have a valid ABC certification when hired will be trained and certified in a TIPS, TAM, Serve Safe or comparable program within thirty (30) days of hire or within the time required in the jurisdiction of the hotel, whichever is sooner. Training must be done by an approved vendor or a Stonebridge associate who is a certified trainer for an approved program.
 - b. Associates must advise their manager or supervisor at least sixty (60) days prior to expiration of their certifications to arrange to complete required training to renew their certification before expiration.





- c. Associates must carry their ABC certification cards when on duty. Copies of current certification cards must be retained in associates' personnel files.
- d. Managers and supervisors will maintain the attached Alcoholic Beverage Compliance Training form listing all associates who are required to be certified, and monitor certification compliance monthly to assure all certifications are current.
- e. The birth date, i.e. month/day/year, will be reviewed with associates at the start of each shift.
- 5. Hotel Restaurant and Bar Operations:
 - a. Signage stating the legal drinking age and reserving the right to check IDs of any patrons and refuse service will be prominently posted in the service and/or sales area(s).
 - b. IDs will be checked for any patrons appearing to be under thirty (30) years old prior to serving alcoholic beverages.
 - c. Patrons are not permitted to bring in alcoholic beverages obtained outside the restaurant or bar or to take open containers out of the serving area designated by the liquor license.
- 6. Room Service
 - a. Associates delivering alcoholic beverages with room service orders must be 21 years of age or older.
 - b. Guests accepting delivery of alcoholic beverages with room service orders must be of legal age as required by applicable laws. IDs must be checked for any individuals who appear to be under thirty (30) years old.
 - c. Alcoholic beverages must be excluded on menus for room service provided by a Stonebridge managed hotel to another Stonebridge managed hotel.
 - d. Alcoholic beverages must be excluded from menus for outsourced room service.
- 7. Manager's Receptions:
 - a. Signage stating that alcoholic beverages are available only to hotel guests of legal drinking age and reserving the right to check IDs of any individuals and to refuse service will be prominently posted in the reception area.
 - b. Prior to serving patrons requesting alcoholic beverages, IDs will be checked for any individuals who appear to be under thirty (30) years old.
 - c. Patrons will not be permitted to bring alcoholic beverages obtained elsewhere into the reception area or to take alcoholic beverages outside of the reception area unless permitted by the hotel's liquor license.
 - d. The reception area where alcoholic beverages may be consumed according to the liquor license will be clearly marked by signage or other obvious boundaries.
 - e. To the extent possible, the associate host will verify guest status by checking names of patrons requesting alcoholic beverages against the guest list provided daily by the Front Desk agent. Any patron who is not a registered guest or accompanied by a registered guest will be denied service.





- 8. Gift / Suite Shop Sales of Alcoholic Beverages:
 - a. Signage stating the legal age for purchase and reserving the right to check IDs of any individuals and to refuse service will be prominently posted in the shop.
 - b. IDs will be checked for any individuals who appear to be under thirty (30) years old.
 - c. No alcoholic beverages can be sold by guest service agents or other associates who are under 21 years of age or who are not ABC certified. Managers must coach associates on how to effectively communicate with guests when alcoholic beverages cannot be sold because no associates aged 21 or older who are ABC certified are on duty.
 - d. Associates cannot deliver alcoholic beverages purchased in the shop to quests' rooms.
- 9. Banquets, Meetings, Events, Catering, Hotel Promotions On Premises:
 - a. No alcoholic beverages may be served, poured or sold on premises unless the hotel or restaurant has a valid liquor license as required by law.
 - b. Associates who serve at banquets and other events must be ABC certified.
 - c. Associates serving at banquets and other events will be instructed to notify the banquet/event supervisor on duty of any patrons who appear to be underage or intoxicated. The banquet/event manager or supervisor will take appropriate action to deny service if warranted.
- 10. Alcoholic Beverages Purchased Outside Hotel by Guests
 - a. In hotels that do not sell or serve alcoholic beverages, guests may not consume alcoholic beverages in public areas of the hotel. Guests are allowed to consume their own alcoholic beverages in their rooms, private hospitality suites or private event rooms not serviced by hotel associates or subcontractors.
 - b. In hotels that sell or serve alcohol, guests may not bring alcoholic beverages that they purchase outside the hotel into areas where alcoholic beverages are sold or served by the hotel.
 - c. Hotels shall have a written policy and signage in appropriate areas, e.g. pool/spa, to advise guests of hotel policy.
- 11. Additional Requirements:
 - Associates cannot purchase alcoholic beverages for guests under any circumstances. This includes the grocery shopping service offered by some hotels.
 - b. Hours when alcoholic beverages can be sold or served will be posted in the appropriate places.
 - c. Corporate approval is required for any bar/lounge operations serving alcoholic beverages after midnight.
- 12. Failure to comply with all applicable laws and Company policies and procedures may result in disciplinary action up to and including termination.

In counseling her after the event, her explanation to me as to what happened, it came down to that, while checking the ID's of the two minors, she did not look close enough at the IDs presented her or notice that the birth dates clearly made them minors. When I asked why, "I didn't have my glasses on". Not a stellar defense, but honest.

I have verbally reprimanded her for failure to follow the regulations as set forth by the Alcohol Beverage Control Board in AS 04.16.052. Both citations are now part of her personnel file. She is acutely aware of her error. The experience of the events and her upcoming court appearance due to the actions on the night of 2-27-13 will make her a better bartender in the future.

Since then, I have purchased magnifying glasses that all dining room staff are currently using. I have required Linda Anderson to wear her glasses at all times while checking IDs. At the start of each day, the bartender is now required to post the date service is to begin for someone turning 21 years of age, i.e.3-5-92 at the top of their paperwork. A small 1992 calendar is attached to their bank location, where they must circle the date on the calendar as well. We have already instituted a policy of checking everyone's ID in the dining room to insure compliance with the law. I have also posted additional warnings to our guests for either bringing in beverages from their guest room or taking beverages from the dining room out of our controlled serving area and consuming them on the Hotel property, i.e. parking lot, lobby, etc.

I will insure that all supervisors of staff have a current TAP card in their possession while on hotel property. I currently have a CHARR Trainer on staff, Sergio Infanzon that will be assisting in additional training for all dining room and front desk personnel in Alcohol Awareness in the near future.

In all, having random checks for violations of licensee's is a good thing. It helps ensure the compliance of laws and regulations concerning Alcohol.



At the outset, thank you for taking the time to speak with me on Friday regarding Ms. Pak and the January 7th Notice of Violation which she received in connection with a violation of AS 04.16.150 stemming from the sale of alcohol by one of her wait staff. As I discussed with you, because of her limited English Ms. Pak asked me to assist her in responding to the Notice and in conveying to you and to the Board her embarrassment and distress over the fact that one of her wait staff evidently sold alcohol to an underage person - even after apparently first asking to see the individual's ID.

As reflected in Ms. Pak's Affidavit as enclosed, since receiving the Notice of Violation, Ms. Pak has met with each of her employees to re-emphasize the importance of checking every customer's ID and to underscore the necessity of confirming each customer's date of birth. In addition, Ms. Pak has mandated that each of her wait staff, including specifically Chin Suk Wahlgren, the waitress who evidently served the underage person, enroll in and complete the ABC Board's education course which is being offered in Fairbanks on January 16, 2013. In fact, Ms. Pak has emphasized to each of her employees that their failure to attend and complete the course will result in their being terminated from employment with Seoul Gate Restaurant.

Ms. Pak wishes to express her sincere apologies for the violation by one of her wait staff and wants to assure the Board that there will be no similar violations in the future.
