The application was approved with delegation at the board's November meeting and was brought back to the board at its February meeting because none of the items awaiting approval were accomplished between November and February. The board continued the delegation to this meeting to determine whether the applicant was going to complete delegated matters.

What an exciting time to be part of Alaska's budding Craft Distillery industry.

I understand the board is requesting an update regarding where we are in the licensing process. Since the city of Skagway's approval of our application in July of 2015, here is what we've done so far:

- Applied for and had approved a Conditional Use Permit in Skagway.
- Applied for the State Liquor License.
- Submitted a building plan to the State Fire Marshall and DEC, both have approved our application which the ABC board has on file.
- Application for a TTB Federal License submitted January 24, 2016 and is being processed.
- Federal Excise Tax Bond has been issued has been sent to the Department of Revenue along with the Alaska Alcoholic Beverage Tax License Application.
- Joined the Alaska Distillers Guild.
- Three members of our family have attended the Artisan Craft Distilling Institute course.
- Preparing product label artwork to send to the TTB for approval once we receive the license.

Our goal is to be distilling and have an open tasting room by May 2017 or sooner. It takes a lot of planning and expense to get through a business start-up. We are well into the process in both time and expense, still we are excited and believe we can achieve our goal as long as we get through the state and federal licensing in a timely manner.
