The Municipality of Anchorage (MOA) has protested transfer of ownership of the above licensed per AS 04.11.480(a) and 3 AAC 304.145(g)(1). Details are as follows:

Date Notification sent to MOA: February 8, 2016

Date Protest received: March 23, 2016

Basis for Protest: Lack of approvals from Anchorage Fire and building safety which have since been met. Notification from MOA on 04/12/16 that protest remains due to delinquent taxes owed: \$1,102.50

3 AAC 304.145(d) met? Yes, notification for opportunity for hearing before Anchorage Assembly

Recommendation: Uphold protest and deny transfer of license with an abeyance period of 30 days (if requested by the licensee) to get MOA protest lifted by paying taxes
