Third Waiver Request

In April of 2014, the board approved a transfer of ownership and location for this license, from to Jack D. Tripp, DBA Tripp's Viking Liquor at 218 Front Street, Juneau, to Thibodeaus Market Inc., DBA Thibodeaus Liquor at no premises. The first waiver for the 2015 licensing year was approved in February of 2016. The second waiver for the 2016 licensing year was approved in October of 2016.

A transfer of location application (and DBA change) is on the delegated consent agenda for this meeting. The licensee indicates they expect to begin operating in the spring of 2018 should the transfer be approved.

Recommendation: Evaluate the request against 3 AAC 304.170.
