Barry Tanner, 90% shareholder of the licensed corporation, passed away two years ago. Heidi Tidler, Personal Representative of her father's estate, is requesting the board grant an additional extension of the time by which a transfer application must be filed under AS 04.11.030. The board granted a 90-day extension at the October 8, 2014, meeting; a transfer application was delayed due to a protracted probate period. Probate is now complete, and closure of the estate is pending.

Ms. Tidler is in contact with staff and working to finish the transfer application. She has requested an additional 90-day extension.

Recommendation:

Grant Ms. Tidler an additional 180-day extension to ensure the transfer application is completed and no additional extensions are needed. The board is not limited to the length of the extension under AS 04.11.030(b).

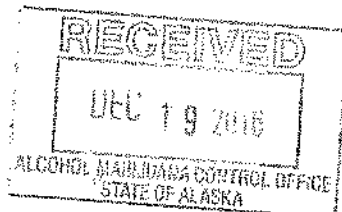

- 21 5. Venue is proper because decedent was domiciled in this judicial district at the time of
22 death.
- 23 6. The time for appointment of a personal representative has not expired.

- 2 other judicial district of the state and neither this will nor any other will of the decedent
- 3 has been the subject of a previous probate order.

- 6 9. The person whose appointment is sought has priority for appointment as personal
- 7 representative.
- 8 10. No bond is required because the decedent's will directed that the personal representative
- 9 serve without bond.
