or dispensing of alcoholic beverages;

(2) the person has the written consent of a parent or guardian; and

(3) an exemption from the prohibition of AS 23.10.355 is granted by the

Department of Labor and Workforce Development.

(f) A person 18, 19, or 20 years of age may enter and remain within a common

<u>carrier in the course of employment if the employment does not involve serving, selling,</u> mixing, delivering, or dispensing of alcoholic beverages.

(g) A person under the age of 21 may enter and remain within a common carrier during passenger travel without a parent or guardian. (Eff. 11/6/2004, Register 172;
