## MEMORANDUM

RE: Techniques for Alcohol Professionals Course

On or about the week of 30 January, 2017, Inv. Hoelscher requested I review CHARR's *Techniques for Alcohol Professionals* course for compliance with 3 AAC 304.465(c)(1-16).

**Exhibit #1, "16** <u>Required Points for Alcohol Server Education in Alaska"</u>: Section 4, third bullet statement: An attempt is made to tell what a drunken person is, and the word intoxication is used. I recommend they use Title IV's definition found under AS 04.21.080(b)(8). It is less confusing and more straightforward.

**Calendar, Exhibit #5:** There is an error in statement #3. It says, "If you are in the municipality of Anchorage, you must ID all customers at liquor stores." Anchorage ordinance 10.50.35C in part states "Mandatory identification check in the retail sale of alcoholic beverages: Licensee or licensee's employee or agent shall require any **purchaser of alcoholic beverages** at any package liquor store to produce a current government-issued identification with birth date and photograph for identification check prior to any on-premises sale...."

**Course book, page 2**: In the section "resulting in a \$10,000 fine and up to one year in jail," there should be an "or" after "and." One can receive one or the other or both. The second offense within five years is misleading and makes it sound like the three offenses listed could each be felonies. Furnishing within five years of a conviction or a similar statute from another state is a felony. Serving to a drunken person is always going to be a Class A misdemeanor, and selling drugs is contingent upon the classification of the type of drug being sold.

Course Book, page 5: The address and phone number listed is not correct.

**Course Book, page 8**: Underage buyers are between the age of 18 and 20 ½ years old, not 21 years old. The second paragraph also states if failing a compliance check, a citation will be issued. It's actually a summons that is issued, and one could also be physically arrested and taken to jail.

**Course Book, page 8**: The third paragraph refers to the "shoulder tap" program. Those providing alcohol may be arrested. They could also receive a summons. This is dependent on the location and resources available as to what happens to a person furnishing alcohol to a minor.

**Course Book, page 8**: The fourth paragraph describes types of incidents for which a server can receive a citation or administrative action. Remove the word "citation," as these examples would be summonses. A server could also be issued a summons for not having his/her server card.

**Course Book, page 9, "Physical copy of Title 4 on premises":** It is not a requirement to keep Title 4 book on the premises.

**Course Book, page 15, Last paragraph, "Specials, Promotions and/or Happy Hours":** It is not legal to raise the price of alcohol to offset cost of entertainment.

**Course Book, page 17, "Adulteration or Misbranding of Alcohol":** Regulation doesn't mention anything about topping off like-branded bottles from 1.75ltr to a 750ml bottle. You can't misrepresent Monarch in a Grey Goose bottle and pass it off as Grey Goose.

**Course Book, page 21**: Regarding written orders, might want to add that licensees have to contact AMCO to be entered into database for shipping areas with restrictions.

Course Book, page 23, "Common Server/Seller Citations": Change citations to summons.

Course Book, page 24, Summary, fourth line down: The word "not" needs to be removed.

**Course Book, page 32, First paragraph, last word:** Intoxication is being used in same sentence as drunken person. Use Title 4 definition of drunken person.

**Course Book, page 38, "How to calculate BAC":** I would remove this and just teach totality of circumstance in regards to a drunken person.

**Course Book, page 43, "Verifying if a person is of legal age":** Just an observation from compliance checks. When clerks "do the math," they often forget to figure in the month and day often mistakenly thinking the customer turned 21 this year.

**Course Book, page 44, "Born on or before**": Remove the "on or before" calendars from liquor side of retail stores. I've seen clerks look at wrong calendars multiple times and fail a compliance check. Keep tobacco "on or before" calendars on retail side only.

**Course Book, page 46, "Statement of Truth," 2<sup>nd</sup> paragraph**: "Statute" should be replaced with "regulation," which requires them to keep Statements of Truth for 90 days. We would like to see taught that AMCO is contacted when yellow form is filled out so we can verify if the person is under 21 as best we can. However, this is not a requirement.

**Course Book, page 55.** Temporary licenses are now printed on black and white regular paper.

Once the noted corrections are made, the course will be in compliance with 3 AAC 304.465.
