Subject: QUAKE! Licensing and Permitting Issue

Hello Director Franklin,

I am writing you to inform you that my landlord emailed today stating that she will not honor her agreement to modify our lease agreement, per Municipality of Anchorage and Alaska AMCO requirements.

On April 26, 2016 Laura Cantrell (landlord for Firelake Plaza II, LLC) testified on my behalf before the Anchorage Assembly Meeting, in regards to my alcohol permit

application. One or more of my application's conditions was to modify our lease; to include (among other things) live music. She agreed to all requirements.

Laura and I had at least three email and/or text message correspondences, from April - August 2016, where she agreed to make those required lease changes. Today she emails me and tells me otherwise.

All my floor plans, equipment, contractor work, advertising, etc were based on the plans she approved on April, 26 2016. That is hundreds of thousands of dollars in construction costs, countless lost profits, and the degradation of the good name of my company for something she never had any intention of doing.

Because of her actions I believe my alcohol permit, REPL license, and Brewpub license may not be valid. I will NOT distribute or manufacturer any more alcohol until further notified by you.

I would have come forward earlier, but my landlord kept telling me she would make the required changes. Today she said that she would not.

I have given my landlord plenty of opportunities to do the right thing. But, it is clear to me now. She never had any intention of doing so.

I sincerely apologize for my landlord's failure to honor her obligations to the Muni and State of Alaska.

Please let me know what I need to do to make amends and to be licensed and permitted at another location; as I am no longer a tenant at Firelake Plaza. Pending your guidance.

I have attached documents for your review. I can send any email correspondences you require.
