On 1/27/18 at approximately 0105 hours, Bartender Erin Lee sold a glass of red wine to a underage buyer during a Compliance Check conducted by AMCO Enforcement. The underage buyer was 20 years old at the time of purchase. The underage buyer's ID was not checked by any employee. In regards to whom was the responsible Licensee during the time of the incident, it is noted Borealis Investments, Inc. was in the process of transferring the license to Midnight Mine, LLC as of 7/20/17. A management agreement between Borealis Investments, Inc & Midnight Mine, LLC was established, indicating the effective date as: "This agreement, entered into this 19th day of, (missing month), 2017". The management agreement backdated the date Midnight Mine, LLC would begin to manage the establishment commencing on 10/1/17 & continuing until the Beverage Dispensary License was transfered to Midnight Mine, LLC. The agreement indicates Borealis Investments, Inc. "shall have power and duty to oversee, supervise, and is solely responsible to ensure Midnight Mine, LLC perform all duties necessary in the normal course of operation of said business lawfully and in compliance by agents or employees." The transfer of the license was issued on April 9, 2018.
