Recommendation:

Background: On the renewal application for Noodle World Alaska, a restaurant or eating place license issued to Yuk's, LLC, the licensee indicated that in 2017, 8.32% of the gross receipts were from food sales, and in 2018, 16.2% of the gross receipts were from food sales.

AS 04.11.100(e) states, "A license may be renewed under this section only if the licensee provides evidence to the board's satisfaction that gross receipts from the sale of food upon the licensed premises constitute no less than 50 percent of the gross receipts of the licensed premises for each of the two preceding calendar years."

At the February 2019 meeting, the board tabled the renewal of this license and requested the applicant to submit a revised statement regarding gross receipts along with supporting documentation. The licensee submitted a revised receipts affidavit indicating that sale of food was 98.8% of gross receipts in 2017 and 99% of gross receipts in 2018, along with some supporting documentation. The additional documentation is in the board's confidential folder on the laptop.

There was a fire at Noodle World Alaska on February 7, 2019, which caused an estimated \$10,000 in damage. The cause of the fire was under investigation by the Anchorage Fire Department and the Anchorage Police Department; I have no update on the status of the investigation.
