Background: The Totem Square Inn is a beverage dispensary—tourism license located in Sitka. Their renewal application was approved with delegation by the board at the February meeting. Subsequent to that meeting, the City and Borough of Sitka did not protest the renewal but requested the following condition be placed on the license: "The applicant must satisfy the note/payment plan entered into with the City and Borough of Sitka."

Note that AS 04.11.480(c) requires the local governing body to assuming responsibility for monitoring compliance with the condition, unless the board determines otherwise.
