Property Management Office –
Request to Sell Without a
License

Requested Action: Authorize the SOA Property Management Office to conduct a public auction to sell 1,068 bottles of spirits as listed for the board, without a license

Statutory Authority: AS 04.11.020(a) states, “license or permit is not required to authorize sales made by a person under a judgment and decree of foreclosure, under the bankruptcy law of the United States, or under order of the board or a court under AS 04.16.220.”
(emphasis added)

Staff Rec.: Approval

Update: The State of Alaska Property Management Office request to auction surplus alcohol from the Alaska Marine Highway System (AMHS) licenses was brought to the board in December of 2018. The board asked for more information about the operation of the current AMHS licenses and the off-site storage of alcohol.

AMHS holds the following current valid licenses:

- 30 issued to M/V Columbia
- 31 issued to M/V Kennicott
- 35 issued to M/V Tustumena
- 4392 issued to M/V Fairweather

In addition, a new application for 5782 for the M/V Tazlina is on this meeting’s agenda.

AMHS used to hold the following licenses which are no longer current and valid:

- 29 issued to M/V Bartlett (expired in 2005)
- 32 issued to M/V Malaspina (expired in 2015)
- 33 issued to M/V Matanuska (expired in 2015)
- 34 issued to M/V Taku (expired in 2015)
- 4397 issued to M/V Aurora (expired in 2015)

- 4524 issued to M/V Chenega (expired in 2016)

The Alaska Marine Highway System closed all bars on state ferries in 2015. While some ferries continue to serve alcohol out of their cafeteria, only beer and wine is currently served on vessels.

Further research shows that the Alaska Marine Highway System holds an off-site storage warehouse permit for a warehouse located at 6860 Glacier Highway, Juneau, which is where the alcohol in question is being stored.

Details of the proposed auction may be provided at the board meeting.

Background: As noted in the attached email, the State of Alaska Property Management Office is seeking to auction surplus liquor from the Alaska Marine Highway that is being stored in a Juneau warehouse.

Title 4 requires a license or permit to sell alcohol (AS 04.11.010(a)) but provides an exception in AS 04.11.020. This section of statute states that a license or permit is not required to authorize sales under order of the board.
