Requested Action: License renewal

Statutory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.470: "A person may object to an application for issuance, renewal, transfer of location, or transfer to another person of a license, or for issuance of a permit, by serving upon the applicant and the board the reasons for the objection. The board shall consider the objections and testimony received at a hearing conducted under AS 04.11.510(b)(2) when it considers the application..."

AS 04.11.510(b)(2): "The board may review an application for the issuance, renewal, transfer of location, or transfer to another person of a license without affording the applicant notice or hearing, except... (2) the board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local governing body to an application if a hearing is not required under this subsection;"

Staff Rec.: Hold a public hearing; approve the renewal with a condition

Update: The board tabled this matter at the February meeting to provide the licensee an opportunity to respond to the objections. The licensee has provided a written response to the objections that have been received.

Background: Multiple individuals who live near this beverage dispensary licensee in Sterling have objected to the license renewal on the grounds that there is excessive noise and disturbance coming from the bar. Three objection letters are attached along with a petition and the 2018 reports of the Alaska State Troopers. The Kenai Peninsula Borough does not protest the renewal. The borough has no applicable noise ordinances.

AS 04.11.395 states, "The board may, in the best interests of the public, impose conditions or restrictions on a license or permit issued under this chapter."

I recommend that the board renew this license with the following condition: "Outdoor speakers or speakers intended to broadcast music outside of the building at Mile 82, Sterling Highway, shall not be used between 10:00 pm and the following 10:00 am, Sundays through Thursdays, and between midnight and the following 10:00 am, Fridays and Saturdays."

A temporary license was issued on January 10, 2019.

As the sole member of Moosequito Ventures, LLC, I hereby submit Moosequitos' response to the Protest filed by Mr. Stan Welles on November 12, 2018. The subject Protest was apparently initiated on August 10, 2018, when Mr. Welles began circulating a petition, protesting the continued operation of Moosequitos Bar in Sterling, Alaska. Moosequitos, however, was not informed of the Protest or the circulating petition until a week before the Board's February 2019 meeting. Since that time, we have identified only one noise complaint recorded during the entirety of calendar year 2018. Unfortunately, we were unable to resolve that complaint when the complainant declined (or ignored) my personal invitation to meet and address the problem he raised. To fully understand the background of the Protest, I believe that the Board must look separately at the motives of the two apparent initiators of the Protest – Stan Welles and Jerry Cornell on the one hand – and, on the other hand, the other neighbors who agreed to sign the Petition that is included in the Protest.

On or about August 1, 2017, Moosequitos consented to the placement of a large pro-marijuana sign on its property in connection with a Kenai Peninsula Borough marijuana referendum that was voted upon in late 2017. At the time the sign was placed on our property, the pro-marijuana advocates warned me that the sign would likely anger a particularly vindictive anti-marijuana politician who lived in Sterling. While that politician was specifically identified to me as Mr. Stan Welles – I did not recognize the name since Moosequito's had not previously been involved in the pro-marijuana movement. While Moosequitos does not have a formal involvement in the marijuana industry and did not know anything about the referenced politician at the time, our support of the marijuana industry was based upon my general belief that the growth potential of this new industry offered potential long-term benefits for the Kenai Peninsula Borough and its economy.

On August 5, 2018, our records show that an individual identified only as “Jerry” called Moosequitos Bar at 4 pm in the afternoon and instructed our bartender to turn off our music. My bartender politely declined to turn off the music at that moment, but assured the caller that our practice was to turn the music volume down later in the evening. Upon hearing this, “Jerry” abruptly ended the call, closing with a vague threat against Moosequitos' continued operations. The bartender then immediately called me and described her conversation with “Jerry”. My instructions to her were to call the number that appeared on our caller ID and tell “Jerry” that I would welcome the opportunity to meet with him at any time to address his concerns and I proposed that he schedule a meeting with me at his convenience. My bartender called me back a few minutes later to report that “Jerry” had not answered her return call so she left a detailed voice mail message for the caller. “Jerry” never returned our

call nor took me up on my offer to meet. We had no further contact with “Jerry” until I read the Protest. Upon reviewing the petition, I noted that the first signor of the petition was identified as “Jerry Cornell” and lists the same telephone number that we had called using our caller ID information. Jerry signed the Petition five days after my request to meet with him.

Mr. Welles' Protest tellingly opens with the statement that “As a great grandparent; I am disgusted that we ever voted to legalize marijuana.” He ends by threatening that he has a “neighbor [who] says he has two rifles that will shoot a 3” group at 300 yards, [and who] says he knows how to take out [our] speakers!” Upon seeing Mr. Welles' name, I immediately recalled his name as being the “vindictive anti-marijuana neighbor” who I had been warned about. Mr. Welles' threats are appalling to me, as I am responsible for the safety and well-being of my entire staff and all customers who visit my business. It is my belief that Mr. Welles' written threats are unlawful – and certainly inappropriate to be made in submittals before this Board. They should not be condoned in any respect by this Board.

Since reviewing the Protest, my staff has had the opportunity to review our records for 2018 and we have found that “Jerry's” call was the only recorded noise complaint we received during 2018. Based upon our established protocol, our bartenders relay all telephone calls or messages to my attention in either of three ways. Depending upon the bartender's assessment of the importance of the matter, they will either (1) call me immediately and request guidance, (2) fill out a telephone message note and pin it to my bulletin board (for review when I return to Moosequitos), and/or (3) write an entry in our bar log book for review by my manager (on a daily basis), for review by my staff (the next time each member starts a shift) and by me (upon my return to the office).

While I may question the ulterior motives of Mr. Welles and Mr. Cornell, I do not similarly question the motives of the other neighbors who elected to sign the petition. I view the petition as evidence of a breakdown in communication between me and Moosequitos' neighbors. Clearly our neighbors have not been provided with a clear enough means of reaching me to discuss their issues. While I believe in the effectiveness of the telephone protocol we have in place, I recognize that our system may not be foolproof and relies on the judgment of each bartender. Notwithstanding my confidence in this system, it can be improved. In this spirit, I propose to provide every signer of the petition with a personal email address – the one that I personally use and monitor several times each day and which relates exclusively to the ongoing operations of Moosequitos. This is the email address that our vendors, all regulatory agencies and our bankers use to communicate with me regularly regarding Moosequitos' matters. I can guarantee the Board that every neighbor complaint arriving at this email address will be personally reviewed and addressed by me on a priority basis.

The communication problem that exists between Moosequitos and its local neighbors appears real and may be aggravating our relationship with the community. While our neighbors' perceptions may be that they are “constantly” contacting Moosequitos regarding noise issues, our perception is that we have not been receiving the number of complaints that they suggest. For our purposes, however, I believe that our best response is to allow me to work with our neighbors, rather than dealing with vague and unverified allegations of unruly behavior taking place on our business premises. For example, the Protest suggests that Moosequitos is unruly because the State Troopers disclosed a dozen “Incident Reports” from 2018 which allegedly were associated with Moosequitos. That is a misleading argument that

can be seen by simply reading the reports. Over one-half of the reports document calls that we initiated to the Troopers to address a transient parking problem that was caused by the State of Alaska park rangers across the street during 2018. In that case, the park rangers readily admitted that they were telling transient parkers that they could simply go across the street and park for free at Moosequitos because “we would not care”. At times last summer, we had as many as 20 transient parkers on our property – including massive side-dumps and large 18-wheelers that were apparently avoiding a stop at the weigh station located just up the road. Because of this problem, we were forced to initiate a signage and towing program during 2018 to regain control of our property. Other reports documented routine visits (walk throughs) by law enforcement personnel which found nothing out of the ordinary. Only one incident report from 2018 involved the inappropriate conduct of a customer of Moosequitos (called in by our personnel) and two disturbances caused by former customers who later became the subjects of temporary restraining orders. Contrary to the inferences drawn by Mr. Welles, the Incident Reports reflect a responsible business being conducted in accordance with applicable law. It is unfortunate that Mr. Welles did not read the reports before attempting to use them for ulterior purposes. Indeed, one report appears to document a visit that was initiated by an anonymous noise complaint (without prior knowledge to us) that the Trooper to be without merit.

The vague and unspecific charge contained in the Protest that “someone” once witnessed a drug deal taking place in our parking lot” is particularly disturbing and illustrative of how inflammatory and counterproductive such arguments can be. Moosequitos has 16 security cameras in operation at Moosequitos that effectively represent a security resource for the local community. We are often contacted by the State Troopers to see if our cameras may have recorded certain nearby activities – unassociated with Moosequitos operation - that are being investigated by the Troopers for purposes. It would be far more productive for our neighbors to report suspicious parking lot behavior to us with a detailed report (i.e. date, time, location on lot and a description of activity) and provide us the opportunity to fully investigate their report using our camera data and take appropriate remedial action, if warranted.

It seems as though, in this day of internet brevity, I am constantly asking my staff to improve their communication skills with our customers and amongst themselves. This need to improve our communication skills clearly goes beyond my isolated staff, however. It is time for us to renew our focus on communications with our local community. I intend to take full responsibility for the implementation of that task going forward.

Greetings to the AMCO Enforcement Staff;

Reading of some of your current workload, I apologize for adding to it. As a great grandparent; I am disgusted that we ever voted to legalize marijuana.

We, here in Sterling are very, very, very upset with the noise and disturbances coming from Moosequito's Bar at mile 82 of the Sterling Highway.

Prior to last year's open-heart surgery, I was on the Kenai Borough Assembly. With that in mind, a neighbor called to ask what we might do about the noise, etc. coming from Moosequito's Bar. I said I would call the Alcohol & Marijuana Control Office and ask. I did and the idea of putting a petition together and sending it to you folks at the Enforcement Branch developed.

Accordingly, I have attached the petition. Petitioners range from families with children to retired individuals to a popular lodge at the junction of the Moose and Kenai Rivers. Petitioners are located from across the Moose River to a half mile up-river. We have a lot of swans on the river, but they all stay ½ to ¾ mile up river.

The Lorentzens have young children. My wife and I live a quarter mile up-river from Moosequitos. The Lorentzens live a little north of us. The Lorentzen's have tried in vain for years to get Moosequitos to quiet down. Moosequitos response to them has been typical for all of us. Their letter is attached.

One neighbor called Moosequitos in the middle of this past July, politely asking them to turn off the outside speakers. They did for about 15 minutes. About a half hour later, with the noise back on, our neighbor called again. Moosequitos turned off the outside speaker for another 15 minutes and them back on. This sequence of call-speakers-off-for-15-minutes-and-back-on for-a-half-hour continued until our neighbors went to bed late that evening. It was 5:00AM the next morning before the speakers went off!

Some of the neighbors have to wear ear plugs to sleep. May I say it kindly but sincerely; the neighborhood is getting very pissed off at Moosequitos.

In my wife's (Nikki) attached letter, she speaks to our buying our current location here on the Moose River because the facilities would work for a B&B such as she ran in Homer before our coming to Sterling in 2012.

The importance of being able to do a B&B took on a new significance in the last three years. I've had major surgeries over the past three years including cancer, radiation, emergency colon surgery, open heart surgery and Colorectal Surgery. During these three years of major medical issues, I've had to put up with the crap from Moosequitos all during recovery. It doesn't matter to Moosequitos whether the temperature is 70°F or -20°F, rain, sunshine or

snow, the noise continues. Calls were always meant with sarcasm or rudeness or both.

I've also attached Alaska State Patrol's reports for 2018. Through October 2018, the police have been called in 12 times in 10 months. We know of a grill theft, a big brawl and two occasions of fireworks at about 2:00AM in the morning that apparently weren't reported. One neighbor while visiting Moosequitos to complain, watched a drug deal go down in the parking lot.

Please, shut them down. They are and insist on being a big pain in the butt in the neighborhood. A friend of one neighbor said "buy me a beer and I'll go pull the speaker wires." A retired school principle, knowing all the kid's tricks, has proposed super-gluing the locks. Another neighbor says he has two rifles that will shoot a 3" group at 300 yards, says he knows how to take out the speakers!

To Whom It May Concern,

Our family has lived in the Moose River area for just shy of 13 years. During that time, we have made numerous calls to Moosequito's Bar requesting the volume of the music broadcast over their outdoor loudspeakers be turned down. These requests have always been made very late at night – well after midnight – but we have never gotten any acceptable results from our requests. We have been met with indifference at best and sarcasm at worst. There have been warm summer nights when we had to keep our windows shut despite the discomfort in our house in an (unsuccessful) attempt to keep out the noise so our children could sleep. We have endured loud, early morning barfights outside the bar that echoed through the neighborhood. We can often hear every single word of every song until the bar closes down sometime in the morning.

We are very supportive in general of locally owned businesses, but when a business that affects an entire neighborhood refuses to be a good neighbor, we are no longer supportive of that business. We are sorry to protest a local business, but after 13 years of requests, we've realized that this business owner is probably not going to make any changes. We are therefore objecting to the renewal of the liquor license for Moosequito's Bar in Sterling.

They continue to ignore the request of turning down the outdoor speakers; starting early in the morning and run it late into the night. At times the music has been left on after the management has left for the night.

It seems the only thing we as neighbors can now do is request that the licenses for Moosequitos Bar not be renewed.

Petition to Object to the Renewal of a Liquor License for Moosequito's Bar



Dear Mr. Welles,

This letter is in response to your request seeking copies of materials/reports regarding the above premise.

Under the authority delegated to me by the Department of Public Safety Commissioner, I am denying portions of your request in order to comply with the *Alaska Victim and Witness Rights Act* (AS 12.61.100 – 12.61.150 and AS 11.41.470(7)) and *Alaska Personal Information Protection Act* (AS 45.48.010 – 45.48.900) which prevents disclosure of personally identifying information.

Considering the time the administrative staff spent to research, retrieve, compile, and submit these records was less than five hours, your cost for the records – in accordance with Alaska Statutes 40.25.110 and Alaska Administrative Code 96.350 – does not include a charge for personnel time but is limited to material and delivery costs. Because the total amount is less than \$5.00 this fee is currently being waived.

You may appeal this denial by following the procedures in 2 AAC 96.340. There is no bond requirement for an administrative appeal.

You may also obtain immediate judicial review of this denial by seeking an injunction from the superior court under AS 40.25.125. Choosing not to pursue injunctive relief in superior court will have no adverse effect on your rights before the department.

A copy of 2 AAC 96.335 – 2 AAC 96.350 is enclosed for your reference.

Alaska Administrative Code

CHAPTER 96 PUBLIC INFORMATION

Article 3 Requests for Public Records

2 AAC 96.335. Denial of request

- (a) A request for a public record that complies with this chapter may be denied only if
- (1) the record is not known to exist after the public agency makes a diligent search for it;
 - (2) the record is not in the public agency's possession, and after a diligent search the public agency does not know where the record is to be found;
 - (3) the record has been destroyed in accordance with an applicable record-retention schedule;
 - (4) nondisclosure of the record is authorized by a federal law or regulation, or by state law; or
 - (5) the record is believed to be in the agency's possession but has not yet been located, in which case the public agency shall proceed under (f) of this section.
- (b) A request may be denied by the public agency head or by an agency employee to whom denial authority has been delegated by the public agency head.
- (c) An initial denial of a written request must be in writing; must state the reasons for the denial, including any specific legal grounds for the denial; and must be dated and signed by the person issuing the denial. If a request is denied by a public agency employee to whom denial authority has been delegated, the notice of denial must reflect this delegation. A copy of 2 AAC 96.335 - 2 AAC 96.350 must be enclosed with the denial.
- (d) A denial of a written request, in whole or in part, must state that
- (1) the requestor may administratively appeal the denial by complying with the procedures in 2 AAC 96.340;
 - (2) the requestor may obtain immediate judicial review of the denial by seeking an injunction from the superior court under AS 40.25.125 ;
 - (3) an election not to pursue injunctive remedies in superior court shall have no adverse effects on the rights of the requestor before the public agency; and
 - (4) an administrative appeal from a denial of a request for public records requires no appeal bond.

(e) A denial of a written request is considered to be issued at the time the denial is either delivered to the United States Postal Service for mailing, or hand-delivered to the requestor by an employee or agent of the public agency.

(f) If a written request is denied because a record has not yet been located and the record is believed to exist in the agency's possession, the office in the public agency responsible for maintaining the record is believed to exist in the agency's possession, the office in the public agency responsible for maintaining the record shall continue to search until the record is located or until it appears that the record does not exist or is not in the public agency's possession. The public agency shall periodically inform the requestor of its progress in searching for the requested record.

(g) A record that is the subject of a public records request that has been denied shall not be destroyed or transferred from the public agency's custody, except that records may be transferred to state archives and records management services as provided by AS 40.21 and regulations adopted under AS 40.21. A public agency may not destroy or transfer custody of a record to which access has been denied or restricted until at least 60 working days after the requestor is notified in writing that the request has been denied, or if there is an administrative or judicial appeal or other legal action pending at the end of the 60-working-day period, until the requestor has exhausted those actions.

2 AAC 96.340. Appeal from denial; manner of making

(a) A requestor whose written request for a public record has been denied, in whole or in part, may ask for reconsideration of the denial by submitting a written appeal to the agency head.

(b) An appeal under (a) of this section must be mailed or hand-delivered to the agency head within 60 working days after the denial is issued and must include the date of the denial and the name and address of the person issuing the denial. The appeal must also identify the records to which access was denied and which are the subject of the appeal. If an appeal is from the failure of the agency to respond to the records request within the appropriate time limit under 2 AAC 96.325, the appeal must so state, must identify the records sought, and must identify the public agency to which the request was directed and the date of the request.

(c) The 60 working days within which an appeal must be filed begins to run upon the issuance of the denial or, if no denial is issued, upon the expiration of the time period within which the public agency should have responded.

2 AAC 96.345. Appeal determinations; time allowed; by whom made

(a) As soon as practicable, but not later than the 10th working day after the close of the record on appeal, the agency head shall issue a written determination stating which of the records that are the subject of the appeal will be disclosed and which records will not be disclosed. The written determination must comply with 2 AAC 96.350.

(b) The agency head may extend the 10-working-day period for a period not to exceed 30 working days upon written request from the requestor, or by sending a written notice to the requestor within the basic 10-working-day period.

(c) The agency head may delegate authority and duties under (a) and (b) of this section to a full-time employee of the public agency not involved in the denial and not subordinate to the employee responsible for the denial. The employee delegated this authority may not subdelegate to another employee.

2 AAC 96.350. Contents of determination denying appeal

A determination under 2 AAC 96.345 responding to an appeal must be in writing, must specify the specific statute, regulation, or court decision that is the basis for the denial, and must state briefly the reason for the denial. A denial under this section is the final agency decision. A denial must further state that, as provided by AS 40.25.124 , the requestor may obtain judicial review of the denial by appealing the denial to the superior court.

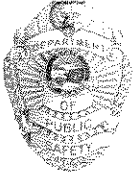

On 6/13/2018 at approximately 1920 hours, I responded to Moosquito's bar in Sterling, where **Shaleenah Marion**, reported she had been threatened by **Jared Leggett**, who subsequently broke her windshield with his fist.

Upon my arrival, I contacted Shaleenah, and she said, in essence, Jared was upset about a dispute from the previous summer regarding employment and money owed. Shaleenah said Jared's wife, **Shae Leggett**, works at Moosquitos and had left approximately 10 minutes prior to Jared's arrival. Shaleenah said Jared arrived and approached her vehicle, at which time she closed her window and locked her door because he is a large man and she was afraid he was going to hurt her. She indicated when Jared reached her vehicle, he swung his left hand at her windshield, striking it once, and causing it to break. Shaleenah said when Jared struck her windshield he said "I'm gonna fucking kill you!" Shaleenah she called 911, and Jared walked back to his pickup truck and left. I saw there was a large broken area on the driver's side of the windshield of Shaleenah's minivan. Her minivan was a gray Chrysler Pacifica bearing Alaska License number Shaleenah indicated, multiple times, that she was afraid because Leggett is very large, she is small, and she had her son, **B F**, in the vehicle with her. Additionally, she indicated that she knows Leggett is "very violent" based on her past experience with him.

Shaleenah told me after Jared struck her windshield he walked back to his truck and began to drive away, at which point she got out of her vehicle to take a picture of his license plate.

Shaleenah explained that the dispute was all due to Jared believing he was owed money from the prior summer when she and her husband, **Dennis Fields**, fired him. She said "Why attack me on it when all I do is the damn books for the frickin' job. Like, that's it. You got a problem with my husband, go deal with him".

Sgt Hershberger arrived on scene while I was speaking with Shaleenah.

I took photographs of Shaleenah's vehicle. I estimated the cost to replace her windshield as between \$300 and \$400.

Sgt Hershberger and I responded to Jared's residence

Upon our arrival, Jared was outside, sitting near a shed, drinking a beer. I spoke with him and asked him to tell me his side of what happened. Jared said "Well, starts, he owes me money, that's why I went over to talk to him". I asked him to clarify who he was talking about, and he gave the name "JJ", then said it was Dennis, Shaleenah's husband, and he was there during the incident, but would not talk to him. Jared

indicated when Denis would not talk with him, he "backhanded" their vehicle, and did not mean to hit it that hard. I saw Jared did not have any marks or cuts on his hands. Jared said "I shouldn't a done that, but I been tryin' to talk to this guy for a year and he refuses to talk to me."

I called Shaleenah and asked where Dennis was when the incident occurred. She indicated he was present in the vehicle with her. I asked why he left prior to my arrival and she indicated it was because he was afraid to be contacted by AST and he believed he has an arrest warrant.

I placed Jared under arrest for Assault in the 4th Degree (fear assault) and Criminal Mischief in the 4th Degree, and transported him to Wildwood Pretrial for remand.

On 6/18/2018, I received a voicemail from Shaleenah saying she received a quote from Nick's autoglass for \$300 to install the windshield, and \$100 extra to clean any broken glass out of the vehicle.

During followup with Moosquitos bar, I learned there was no video surveillance of this incident available.

My notes have been scanned and uploaded into ARMS.

My photos have been uploaded into the AST Soldotna Photo Server.

My audio has been burned to CD and submitted into evidence.

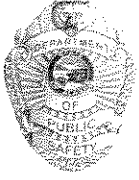

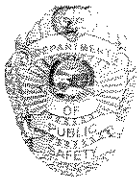

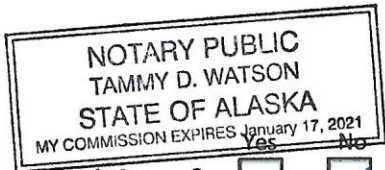
