**Staff Rec.:** Approve the renewal with a condition

**Background:** The holder of this recreational site license made a concerning statement in their renewal application. Ms. Christensen, half owner of the AK Entertainment, LLC, the license holder, wrote "We are available year round to serve for any events that are held at the establishment and may not have a particular schedule."

At the last renewal of this license, in 2017, the board discussed how the Menard Sports Center, where this license is located, holds all sorts of events, not just Tuesday Night Fights. The board renewed the license with the stated assumption that the license was being used for competitive events. A letter conveying this information was sent to the licensee on May 1, 2017.

AS 04.11.210 authorizes the sale of beer and wine during and one hour before and after a recreational event and defines recreational site as a location where a variety of sporting-type events are held during a season. Thus, the use of this license "for any events that are held at the establishment" is a violation of the statutory limitations on this license.

I recommend that the board warn the licensee that the license may only be used for events that qualify under AS 04.11.210, and condition this license to require a complete list of events at which alcohol was served by this license in 2019 and 2020 with their next renewal application.
