Statutory AS 04.06.090(b): "The board shall review all applications for licenses made under **Authority:** 

this title and may order the director to issue, renew, revoke, transfer, or suspend

licenses and permits authorized under this title."

**Update:** At the last meeting, the board tabled action on this renewal. A memo discussing this issue was provided in Tab 3.

**Background:** On the renewal application for the Residence Inn by Marriott, a restaurant or eating place license issued to JL 35th Avenue Hotel Company, the licensee indicated that they have no food receipts or gross receipts. When an inquiry was sent to the licensee, the licensee informed AMCO that this was "due to the fact that we do not (1) have a restaurant at this location, so no retail sales and (2) beer and wine which is dispensed is only provided on a complimentary basis in a controlled environment for hotel guests as part of a required Residence Inn/Marriott brand standard known as the RI Mix. We serve during limited evening hours three days per week complimentary food appetizers and complimentary beer, wine and soft drinks."

AS 04.11.100(b) states, "A license may be issued under this section only if the board determines that the premises to be licensed are a bona fide restaurant or eating place."

AS 04.11.330(a)(6) states that renewal of a license shall be denied if "renewal of the license would violate the restrictions pertaining to the particular license under this title or the license has been operated in violation of a condition or restriction imposed by the board."
