Hello,

My name is Riley Prestegard and I am one of the owners of "Two Seasons Meadery". My partners and I have been going over the regulations and noticed in line 3 of 304.380 an exemption exclusively for cider pour amounts under 8.5 percent. This exemption allows cider to be served to up to 36 ounces but other wine classified beverages such as mead does not.

We were curious if this was a typo because a majority of our meads are under 8.5 percent, and we plan on in the future having 6 percent mead. We would like this regulation to be clarified and do support including all wine classified beverages under 8.5 percent to be added to line 3 of section 304.380.

Re: Brewery and Distillery Restrictions

To Whom it May Concern:

I am writing in opposition to the proposed draft changes 3 AAC 304.390 dealing with the definitions of recreational or gaming opportunities. While I understand and appreciate the state's interest in regulating tasting rooms, I believe these proposed changes stifle new businesses and create unnecessary acrimony amongst purveyors of alcohol. I cannot support these proposed changes.

Resolution Brewery in Mountain View hosts many community events, including fundraisers, first Friday events showcasing local talent, cultural events, and organizational meetings for environmental and beautification groups. I am particularly concerned about my constituents in Mountain View losing that ability to organize in a fun and social way that benefits our community.

State alcohol regulations for breweries, distilleries, and wineries are already quite restrictive. Further restrictions on allowable activities would impinge on businesses' ability to participate in community events, contribute to the social fabric, and generate revenue in communities across Alaska. Local brewery taprooms are a safe gathering space for community events for individuals who may not patronize a bar, all while sampling local products and supporting local businesses.

I cannot support these regulatory changes as I believe these new restrictions further hinder the growth of this industry, negatively impact Alaskan small businesses, and lack community support. I would encourage the Board to reconsider these regulations.
