Reference: Creeekbend Company (#1381) Hope, Alaska license premises expansion

Creekbend Company (license# 1381) is a Restaurant Eating Place licensee with a Restaurant Designation Permit (RDP) located in Hope, Alaska who has made application for an extended expansion to their license premises.

The attached AB-14 was considered by the ABC board at its last meeting of March 31, 2020. The board elected to have the AMCO office continue its review to determine if the AB-14 requests are in support of the primary designation of their RDP, which is defined in 3AAC 304.305(a)(1) and (b): Restaurant eating place license where the principal activity is consumption of food and that the board can determine the portion of the premises (or proposed premises) that constitutes that portion of the sale and consumption of alcoholic beverages.

As requested by the ABC board, on June 1, 2020 I met with Creekbend's legal representative, Ms. Weltzin, who proposed a much smaller outdoor plan than was originally proposed. Creekbend indicated they wished to have 13-15 ticketed events, meaning musical concerts in the outdoor area outside of the restaurant. Additionally, Creekband wishes to work to allow some additional tables outside of the current designated restaurant area to accommodate social distancing.

After a review of the current and prior applications, permits, statements made by the licensee, as well as other supporting documentation, it appears that the primary business model for the requested expansion of the restaurant eating establishment is not for the principal activity of the consumption of food. Rather, it is primarily designed to support a pay-to-attend concert venue along with the consumption of alcoholic beverages.

The licensee was requested to submit the attached AB-14 by the Alcohol Marijuana Control Office (AMCO) for review and consideration by the board. It is the recommendation of the AMCO that the board not approve the current AB-14 application from Creekbend (license #1381) without specific size allocation designed specifically and solely for the consideration of social distancing for those patrons who would normally eat in the café or on the small attached deck (normally a total of 1260 square feet in size). Additionally, is it requested the board

recommend the licensee consider a more appropriate alcohol license type in the form of a Beverage Dispensary License (BDL) to support their concert driven endeavors.

RequestedAdditional consideration of the Licensed Premises Diagram Change andAction:Restaurant Designation Permit applications.

Statutory And Regulatory Authority:

3 AAC 304.185(d): "A licensee may not alter the functional floor plan, reduce or expand the area, or change the business name of the licensed premises without the prior written approval of the director. The licensee must provide a new line drawing showing the proposed changes in the premises. A licensee must pay a fee of \$250 for changing the business name or line drawing of the licensee's licensed premises when the name or line drawing change is not part of a transfer of ownership or location. A request for a business name or line drawing change for licensed premises not part of a transfer must be made on a form prescribed by the board."

3 AAC 304.305: "In AS 04.11.100 and this section, a "bona fide restaurant or eating place" is an establishment, or portion of an establishment, where, during all times that beer or wine is served or consumed, the patron's principal activity is consumption of food; and a variety of types of food items appropriate for meals is available for sale as shown on a menu provided to patrons and filed with the board. In considering an application for issuance, transfer, or relocation of a restaurant or eating place license, the board will determine the portion of the premises or proposed premises that constitutes a restaurant or eating place, and will license only that portion for the sale and consumption of alcoholic beverages."

Staff Rec.: Consider if the extended outdoor premises falls under the definition of a "bona fide restaurant or eating place".

Background:

This restaurant or eating place license in Hope, an unincorporated community in the Kenai Peninsula Borough, is held by Creekbend Company LLC. They wish to include approximately 71,725 square feet in the back of restaurant where there is a stage, outdoor grill/bar with a few picnic tables.

If approved, this form will <u>replace</u> the existing licensed premises diagram on file. Blueprints, CAD drawings, or other clearly drawn and marked diagrams may be submitted in lieu of the second page of this form, as long as it meets the requirements listed on this form. The first and third pages must still be completed, attached to, and submitted with any supplemental diagrams. An AMCO employee may require you to complete the second page of this form if additional documentation for your premises diagram is needed.

This form must be completed and submitted to AMCO's main office <u>prior to altering the existing floor plan</u>. The licensed premises may not be altered unless and until the AMCO director has given written approval on this form. Please note that licensees seeking to change licensed premises diagrams for multiple licenses must submit a separate completed copy of this form and pay a separate fee for <u>each license</u>.

Our customers' principal activity when they come to Creekbend is to consume food. A variety of types of food appropriate for means is available for sale and shown on the Creekbend menu. Creekbend always offers full-service menu of food items when it is open for business and will extend that full-service menu of food to the back area. The areas outside of the building simply serve as an extension of the restaurant area. Similar to 49th State Brewing Company in Anchorage, The Pump House in Fairbanks, Pikes Landing in Fairbanks, and other well-known establishment, including the outdoor area as dinning/serving areas simply allows for customers to enjoy the beautiful outdoor Alaskan scenery during their meal. Upon approval, we will begin to expand/improve our outdoor patio area, significantly expand outdoor seating and set up proper monitoring systems. When the back area is open to customers, meal service is always provided. Customers will enter the restaurant in the same manner as they do now. They will have the choice to sit inside or outside, as weather and business capacity allows. The lack of outdoor seating demand in the winter and shoulder season could result in the back area not being open for customers to utilize, as staffing the back area would not be an efficient use of staff time when no customers desire to sit outside. When the weather allows, Creekbend may choose to close the indoor seating, only offering outdoor dining, similar to how restaurants utilize certain areas of their space at certain times (i.e. only seat you in a certain section at lunch time or closing off a private room for a private group meal).

Our American-style menus including Burgers, Wraps, Salads, Pastas etc., will be available to every customer regardless if they choose to sit inside or outside. On special occasions, such as holidays, events and cook outs, Creekbend may offer a special themed menu, again available to all customers dining inside or outside. Customers will have the option to be served in the same manner as before the premise change, with servers and table service available in the building and at a minimum in the deck/patio areas. As this change to our layout occurs, Creekbend may consider other styles of service such as counter service. Customers will be seated as they arrive via a hostess or server. Just like the Cafe is currently, the area outside of the building will also be available to reserve/rent for a private party (i.e. wedding, family reunion, corporate picnic).

The area outside the building will have security cameras to assist in patrolling and securing the premise.

Staff and management will frequently check the dining area, inside and outside, for persons under the age of 21 that are not escorted by an adult and keep a close eye on patrons actions, quickly clean up beverages left on the tables and frequently check the dining areas for unacceptable behavior such as; an adult allowing a minor to consume alcohol. If an employee witnesses a patron handing a minor alcohol, he/she will immediately contact Management, Management will contact local law enforcement and the patron will be dealt with accordingly.

Is an owner, manager, or assistant manager who is 21 years of age or older always present on the premises during business hours?

Creekbend Company, LLC DBA Creekbend Company will be expanding their licensed premises from the inside of the facility to also include the exterior of the outdoor space. The increase will be approximately 71,725 sf. The expanded premises will allow for outdoor seating so patrons can eat outside by the grill, and still enjoy a glass of wine or beer. Upon approval of the licensed premises addition, Creekbend Company will be installing a 4.5[°] - 5[°] ft tall fence surrounding the entire perimeter. The fence will be made with thick wooden posts every 8-12feet, with wire fencing between the posts.

In addition, Creekbend Company will ensure that no alcohol is consumed or accessed by a minor in the establishment. Servers will check the identification of all patrons ordering an alcoholic beverage. A valid identification must be must be an unexpired, unaltered passport or an unexpired, unaltered driver's license or identification card issue d by a federal or state agency authorized to issue driver's licenses or identification cards Minors will be allowed throughout the entire establishment where patrons are permitted for dining. All minors under the age of 21 must be accompanied by an adult over the age of 21. All servers will be trained in verifying valid government issued photo identification. Minors who are employed will be allowed access to the entire facility. Employed minors will not serve alcohol under any circumstance and will be trained on procedures prior to employment. Staff and management will frequently check the dining area, inside and outside, for persons under the age of 21 that are not escorted by an adult and keep a close eye on patrons actions, quickly clean up beverages left on the tables and frequently check the dining areas for unacceptable behavior such as an adult allowing a minor to consume alcohol. If an employee witnesses a patron handing a minor alcohol, he/she will immediately contact Management. Management will contact local law enforcement and the patron will be dealt with accordingly. Lastly, security staff will frequently check the outer perimeter of the outdoor area for persons loitering outside the licensed premises. Employees and management will also keep a keen eye on the exits/entrances of the establishment to ensure that no alcohol is removed from the premises. When needed, a employee can be assigned to stay at exits/entrances, if management deems necessary, although we do not anticipate needing to have one employee designated to an entrance or exits at all times. If an employee witnesses a patron handing a minor alcohol or a patron attempting to vacate the establishment with alcohol, he/she will immediately contact Management, Management will contact local law enforcement and the patron will be dealt with accordingly. The facility will have signage posted that all minors must be accompanied by and adult over the age of 21.
