My name is Liz DeMoss. My husband Solomon DeMoss and I own The Seward Alehouse in Seward. Our license is up for renewal today at your board meeting.

As you can see we have a Notice of Violation attached to our renewal application this year.

My husband Solomon DeMoss and I have been working in the bar industry in Alaska for over 20 years each. We both have managed high volume bars and restaurants with a history of ZERO violations. We have owned and operated The Seward Alehouse for 13 years now. We bought it as DJ's Wheelhouse 13 years ago, remodeled and opened it up as a new bar in town with a new way of serving. We were empty for the first year of being open because we refused to serve the way that people in Seward were used to getting served. We were the first bar in town to go non-smoking before it was regulated. We set standards for our bar and our employees that people weren't used to. We are now known for being the bar that is the tightest run and we wouldn't have it any other way. We care deeply about serving responsibly and protecting our customers and our industry.

In the last year we have taken additional steps to improve responsible serving. We have our entire staff trained in the SAFE BARS program. We have added additional signage in the bar stating that you will be asked to leave if you appear to be intoxicated. We have had countless meetings with our staff and they are as disheartened by this as well. They are all on board for even stricter serving procedures from this point forward.

AMCO Staff and Board Members,

I listened to your meeting today because of interest in the Creekbend permit(s). First, thank you for all the work (paid employment and volunteer services) that you do for Alaska.

Listening to the call made me realize the dedication you all have to the process.

Second, I was personally offended by the comments made by the legal representative of the Creekbend. She implied that the only reason Board members received lots of emails is because there was push for community members to send them. The reason there was a push, is because there are so many people upset by the way the business is being run and its impact on the community. Comments made were based on observations and experiences, not talking points from an email. Residents have observed drunk driving, underage drinking, people defecating, excessively loud concerts late into the night, and other problems. Residents have also tried to negotiate with the owner and found him to be dishonest and deceitful. This is not just concerns of a handful of families as implied by the attorney.

There are probably some residents and guests that support Creekbend. The business has potential to be an asset to the community, but not the way it is currently being operated.

I appreciate the Board tabling Creekbend's application to gather more information and investigate the situation. Continue to listen to the concerns voiced, please!

I am asking that this item be considered for the agenda for the upcoming April 22, 2020 meeting.

In the midst of COVID-19, many emergency regulations are being considered and implemented for the health and safety of patrons and employees, I would like to ask that either:


AMCO Form AB-14: Licensed Premises Diagram Change to be suspended for Restaurant or Bars who can safely expand to outdoor seating **or an Addendum be added** (if possible) to the suspended statutes in Title 4 to include:

- Allow establishments to expand seating area to the outdoors (where space is adequate) for the health and safety of patrons and employees.
- Allow establishments to apply for an emergency application (in alignment with current email emergency application for curbside/home delivery) to expand seating and forgo completing Form AB-14 for board review for summer 2020.
- Example - My bar is located on an 11 acre lodge property outside city limits in the Matanuska-Susitna borough. I have grassy areas all around the property that provide social distancing where I keep picnic tables/umbrellas for patrons to eat. I would like to serve drinks outdoors to protect the health and safety of those patrons and employees serving them. Behind the bar location is a campground where people can park RV or tent camp, again - another option for people to have food/drinks outside the designated bar area.

If the recent suspension of statutes in Title 4 (AS 04.11.090, AS 04.11.100, AS 04.11.130(b)(1), AS 04.11.135(a)(3), AS 04.11.135(d)(3)(C)&(e), AS 04.11.140(b)(1)(A), AS 04.11.150, 04.11.170) Curbside/Home Delivery options encompasses this idea, please confirm it would be okay for me to expand delivery to outdoor seating under the above mentioned statutes in Title 4 vs. delivering to a car and the people in the car getting out and eating under picnic table.

Your consideration or clarification is appreciated.

I hope this finds you and your family healthy & doing well in the midst of this COVID-19 disaster. It was a pleasure to meet you at Tom Anderson's home a few years back. Thank you for taking care of us during this crisis and reporting daily via FB.

As an owner (and nurse) of an off-grid lodge/bar/gas station, I have many concerns. I will keep this email down to one concern. I have a suggestion, but would need to have support of AMCO with less red tape involved with the current process to change square footage of serving areas.

I am hopeful as the travel ban is lifted within the State and into the State, our guests will return. Right now, I only have cancellations and refunds going out the door.

With the concern of personal space at bars (or lack of). Could you ask/intervene with AMCO officials to create an easy way for those of us who are surrounded by acres of land at our lodges/bar to be allowed to serve alcohol at tables outdoors during the summer season, thus increasing our serving area?

My lodge is on the Denali Highway. Nearest town is Cantwell 52 miles to the west and Paxson 82 miles to the east. There is nothing between but a few other lodges. I'd feel safer for myself and my staff (and I'd think guests/tourists would too) to have customers/guests sitting at tables with their food and drinks in the vicinity of the bar/lodge area vs. elbow to elbow at the bar. I have nice picnic tables with umbrellas that each family could sit at or small groups of friends.

This would help many bars appear safer in keeping social distancing as we move forward with COVID-19 after-effects.

Dear Governor Dunleavy,

My name is Carey Fristoe. I am an owner of Black Spruce Brewing Company, a brewery in Fairbanks, Alaska. As you know, Fairbanks is a hot spot of covid-19 activity. I have two goals during this pandemic: to minimize the amount of exposure the community has to help flatten the curve and to ensure that my business, and the businesses of my peers, are in stable positions once we, as a community, are through this crisis. From my perspective, the fewer people out and about the lower the chances of spreading the virus further. It is with these two goals in mind, minimizing the spread of the virus, and preserving my small, family run business and the businesses of my peers, I suggest that the Governor temporarily allow for the home delivery of alcoholic beverages. This is not a new or novel idea. Title 4 Statutes already include provisions for delivery of alcoholic beverages by package stores (sec. 04.11.150). Numerous States have enacted emergency orders to help support the service industry during these difficult times and encourage people to stay home. A draft regulation has been written up to make the change to temporarily allow home delivery of alcoholic beverages to occur during the Covid-19 pandemic and save small businesses.

I implore the Governor to help small businesses succeed during these trying times. Allow the home delivery of alcoholic beverages. Allow people to shelter-in-place and minimize the spread of Covid-19. Allow my small business, and everyone's small business, to have a fighting chance of making it through this crisis. The safety of our community and the financial well-being of our industry relies on the quick adaptation of the Government to make a sensible change such as this.

I greatly appreciate your urgency in making this temporary change to help flatten the curve and help small businesses remain in business during these times.

Alaska's manufacturers, restaurants and retailers are in desperate need of cash-flow, and we are all doing our best to create and maintain safe and sanitary stores for customers to visit when they purchase to-go items from our businesses. By offering curbside pick-up, customers would be relieved from having to enter an establishment and risk inadvertent exposure to the Coronavirus. First let me say thank you for all you are doing for our state and especially at this time of COVID-19 which is devastating many different industries. I wish you the best of luck and hope for our state you are successful.

Second item is an urgent request:

I built the original Snow Goose Restaurant and Brewpub in Anchorage over twenty years ago and about 3 years ago I sold it to two young guys that have continued it as the 49th State Restaurant and Pub in downtown Anchorage along with their other operations up in Denali National Park and in Healy. Last year they employed over 700 people. We just built a brand new production brewery on railroad land on 1st Avenue in Anchorage and started spin up operations in December (not the best timing due to COVID-19). The 49th restaurant had to lay off 146 people two weeks ago due to closing sit down restaurants. They were however able to quickly switch to take out and delivery (although this is 1/6 the business) and keep some of their staff. As a brewpub, they were able to sell meals and their packaged beer for delivery with the contingent "curbside" approval of the ABC BOD. This was working well with all the added precautions of checking ID's both on the order and also on the delivery (it had to be the same person). Now, however, we just received this letter from the ABC that states No More Delivery. This will cut their business by over half and will lead to more people being laid off. I do not see the rational behind this. Can you please explain where the major problem is? The mayor and I assume you would like to see people staying home to restrict this spread and yet you are saying if you want to have a pizza and a craft beer you must get in your car and go get it yourself instead of our delivery people making 10-15 stops with one car. Most states that have wine making like California and others allow home delivery to encourage their industries. I can get beer and wine delivered through the internet using UPS or FedEx. Why can't breweries in this state be able to do the same thing?

As one of the earliest developers of the craft industry in our state, I can honestly say, our industry has done more than any other industry except oil to develop new or revamp old structures and hire more people (by now in the thousands) and paid more taxes than any other industry in the last 24 years. If you do nothing to help keep these breweries and brewpubs stay open during this crisis most of them will not make it through and once again we will fall behind in diversification of our economy and will continue be more dependent on oil. I am able and willing to discuss this situation at any time.

Mr. Ross,

I understand your request and there are two options that I am currently aware of. The ABC Board and the AMCO office do not have the power to change any of the current Governor's Mandates, which currently are very specific when it comes to bar (BDLs) not being open. That being said, the Governor may do a couple of things. He may choose to suspend the Alaska Law (statutes) using a DHSS Health Mandate as he did for other establishments and THEN the ABC board can modify regulations to fit the mandate (The board or my office do NOT have the power to change Alaska statutes, only regulations). Or, and there are rumors, the Governor may be considering lifting the current moratorium on bars in the very near future.

Either option will likely allow you to move forward with being open and serving your clientele. The Alcohol Beverage Control Board simply does not have the ability to grant your request.
