I am one of the owners of Goldie's AK in Fairbanks, Alaska. Our business has been closed since June 26, 2020. We were able to shift gears under the order by the Governor for emergency curbside delivery approved and managed by the ABC board. In the February ABC meeting, the board mentioned looking for feedback from license holders on this topic. I am writing to support any effort to extend the emergency orders, or make a permanent change to statutes to allow curbside pick-up from our establishment.

We have had significant support from our customer base to close on site consumption and pivot towards to-go sales only. They saw our dedication to the safety of our community and began purchasing from us in new ways. Curbside pick-up has given us flexibility to sustain our operations through the pandemic.

With the order revoked, we are forced to open our doors to generate income. Human behavior has changed. People are not comfortable going indoors in the Fairbanks winter. Gatherings are taboo. Tourism is minimal. Our space is small and with 'distancing' occupancy is limited. Curbside is the only outlet to give customers the choice about their financial contribution to the business. They can safely purchase alcohol curbside with minimal interaction.

ABC should extend the emergency order, or consider supporting a permanent change to the statutes. Bars, restaurants, manufacturers and distributors need assistance from this governing body. This small change could make a big impact on struggling businesses.
