Requested Action:

Refund request and renewal for the 2021-2022 renewal period.

Statutory and Regulatory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.570: "(a) If an application for a license is denied, the board shall refund the license fee less the application fee. (b) A license fee may not be refunded after the license has been issued unless the board determines it has erred in the issuance through no fault of the applicant. (c) If a license is revoked on grounds that statements made in the application are untrue, the license fee paid by the applicant is forfeited to the state."

3 AAC 304.105(d) "A non-refundable application fee of \$300 must accompany an application for license renewal."

**Staff Rec.:** 

Evaluate refund request in accordance with above statutes and regulation and approve the renewal applications for licenses #975 and #976.

Background:

The licensee is requesting a refund of some or all of the fees associated with the two renewal applications due to the Swan Lake Fire and the Covid-19 pandemic. The licensee paid the following:

#975 Beverage Dispensary: \$2,500.00 license fee (refundable) and \$300.00 application fee (non-refundable).

#976 Package Store: \$1,500.00 license fee (refundable) and \$300.00 application fee (non-refundable).

#### **ADDENDUM**

## **Section 4 – License Operation**

Moosequito Ventures, LLC, is an Alaska limited liability company which owns and operates two Alaska liquor licenses – a beverage dispensary license (License No. 975) and a package store liquor license (License No. 976). Both licenses have been owned and operated by Moosequitos from the same location along the Sterling Highway in Sterling, Alaska for the last 20 years or so.

Moosequitos operated its two liquor licenses for less than 15 days each during 2020 due to circumstances beyond our control. These circumstances were as follows:

The Swan Lake Fire began on June 5, 2019 on the Kenai River Moose Range at a specific location about 5 miles from our licensed premises. Ultimately, that fire destroyed over 160,000 acres of wilderness land on the Kenai Peninsula – most of which was within the Kenai National Moose Range. The fire closed the Isaak Walton campground in Sterling (which is located directly across the Sterling Highway from Moosequitos) along with just about every other public campground on the Kenai Peninsula during the summer of 2019, thereby eliminating most of the summer recreational traffic to and from the Kenai Peninsula for 2019. The fire also randomly closed the Sterling Highway between Cooper Landing and Sterling to automobile and truck traffic, thereby periodically cutting off all automobile traffic between Anchorage and Sterling and all points south along the Sterling Highway. When the Sterling Highway was open, the smoke which spread throughout southcentral Alaska reminded tourists in Anchorage that the Kenai Peninsula was experiencing a massive fire and should be avoided. Smoke from the fire also effectively prevented our local customers from using our popular outdoor deck, which overlooks the picturesque Moose River, during the 2019 summer season. One prominent Anchorage band refused to take our stage when they arrived in Sterling because they believed that our ambient - inside - air quality would be dangerous to their expensive electrical equipment. So much for our "smoke free" bar environment.

In total, the Swan Lake Fire resulted in a reduction of about 40% in our expected 2019 summer revenues in both the bar and liquor store for the 3-4 months that the fire raged locally. Thereafter, the effects of the fire continued for the remainder of 2019 – first because of loss of our local summer tourist season, followed later by the damage dealt to our local economy. Ultimately, our local year-round customers disappeared for the remainder of 2019 because they too had lost much of their expected summertime revenue due to the fire. The Federal government quickly designated the Swan Lake Fire as a "National Disaster Area" and offered loans to adversely impacted residents and businesses. While we immediately applied for such disaster relief from the SBA in October of 2019, we continued to operate our licenses – at 40-50% below our expected revenue for the remainder of 2019. Finally, in December of 2019, we reluctantly decided to temporarily suspend our operations "for a few months" until the local economy improved and until the 2020 tourism season began again. Our initial

estimate was that the local economy would recover from the Swan Lake Fire by the second quarter of 2020, so we announced a temporary closure from mid-January through about March of 2020 in hopes of reopening in April or May in time for the 2020 summer season. Unfortunately, the national COVID-19 pandemic began in early February of 2020, thereby delaying and disrupting our immediate plans to reopen. By late February, it became obvious that we could no longer reasonably expect our local economy to rebound as quickly as we had initially projected.

Since our shut down in January of 2020, we have nonetheless continued to pursue our Swan Lake Fire disaster loan application with the SBA but administrative delays caused by the pandemic have resulted in unexpected delays. At one point we were told that the SBA email box that we were told to use for our loan application had a backlog of over 20,000 unread and unprocessed emails and that many of our loan application exhibits could not be found. Finally, after over one year of administrative delays caused by the pandemic) the SBA told us that our Swan Lake disaster loan application was denied, but that we could seek reconsideration of this decision by "supplementing" our application by March of 2021. We plan to update and supplement our application before that deadline, however, we are dealing with ever-changing circumstances which have only begun to apparently stabilize. Throughout this process, we were found ineligible for COVID-19 relief because we were not formally operating in February of 2020 when the pandemic hit.

During this process, our landlord lost ownership of our former business premises and, as a result, we lost our lease. While our former premises is still vacant and in its former condition, we have been unable to discuss the reopening of that premises with the new owner until our industry and local economy stabilize. In the meantime, we have been approached by a potential new landlord who wants to build us a new premises just outside Soldotna to house our reopened businesses.

As you can see, the Swan Lake Fire and the intervening COVID-19 pandemic caused us to operate Moosequitos' two liquor licenses for less than 15 days each during 2020 before "temporarily" suspending our operations in January of 2020 and we have not operated since that time due to subsequent events. Despite our frustration, we continue to believe that we can still be up and running before the 2021 summer season is upon us even if a license transfer proceeding is required.

Enclosed, based upon the recommendation of one member of the ABC Board staff, we have filed our license renewal applications for both License Nos. 975 and 976. We have also tendered our regular license renewal fees of \$2,800 and \$1,800, respectively. The payment of these fees at this time did indeed present a financial hardship to us given the overall circumstances we find ourself in, but we wanted to demonstrate our continued commitment to and belief in our local economy. If, on the other hand, there are grounds to reasonably request and receive an abatement or deferral of all or some portion of these renewal fees (or any other fees we may have overlooked) we would request that this be considered as our

#### Good afternoon,

Thank you for your response and allow me to answer your questions.

I have added your email clarification of the premises address to your renewal packet and deemed your renewals complete. I will issue your temporary licenses shortly and email you the licenses and information on the upcoming board meeting. The addendums you added asking for an abatement or deferral of all or some renewal fees and any other overlooked fees for both license #975 and #976 will be on the upcoming board meeting agenda for board consideration.

Your Beverage Dispensary license #975 and your Package Store license #976 are shown with the premises address of "33590 Sterling Hwy (same as Mile 82 Sterling Hwy)". You are only approved to operate from that address. Should you want to move your beverage dispensary license to a new location the location MUST be within the same local governing body as your initially approved license AND you will need to submit a transfer application to have the new premises approved by the board. Your local government is Kenai Peninsula Borough. You will not be able to operate the license at the new premises until the board has approved the transfer. The transfer application as well as instructions are located on our website at <a href="https://www.commerce.alaska.gov/web/amco/">https://www.commerce.alaska.gov/web/amco/</a>

As you are planning to transfer your package license to new buyer you will have to submit a transfer application for that as well. The change in premises address that the new buyer intends to make can be added and be a part of that transfer application.

#### Dear Ms. Serezhenkov

Thank you for your reply to our two pending license renewal applications. After discussing our renewal applications during a telephone conversation with an ABC Board representative in December of 2020, I thought that I had submitted our applications properly. The physical location which I provided on each application (Mile 82 Sterling Highway) was properly reflective of the physical location from which we conducted public operations until early 2020, when we suspended operations due to the effects of the Swan Lake Fire of 2019 and, later, the COVID-19 pandemic. At the time of that conversation, I was unaware that the street address of 33590 Sterling Highway was used by the ABC Board in connection as our physical address rather than our milepost location. Since the USPS does not offer mail delivery in Sterling, Alaska, we typically used our milepost location as a means of identifying how to physically find our bar and package store. Either location, Mile 82 or 33590, correctly identifies the one and only business location we have ever used.

As reflected in the exhibits to our two renewal applications, we suspended our business operations under both of our liquor licenses in January of 2020 and have not operated either, from any location, since that time. Accordingly, at present we technically do not have a business location from which we are operating. Furthermore, we have recently agreed to transfer our package license to a new buyer who is in the process of identifying the new location to which we

will use for an anticipated transfer. We are also in discussions with a new prospective landlord to relocate and reopen our beverage dispensary license at another location within the Kenai Peninsula Borough. Therefore, at this time, we do not have a location from which we are currently conducting retail operations.

While I am certainly willing to modify our pending renewal applications consistent with the facts of this case, I could use some preliminary guidance from you. Would you prefer to have me list our former physical address (i.e. 33590 Sterling Highway) on each renewal application, or simply say "none" on the renewal applications, which would more accurately describe current operating status but would leave that line without a listed location? If I could receive your advice on that issue, I will promptly revise and resubmit our pending renewal applications.

Finally, with respect to the renewal of our current business licenses, I understand from your email that that is not any issue that must be addressed at this time. For your information, I have tried to address that issue at various times during the pandemic, but to no avail.
