MEMORANDUM

Requested Action:

Rescind previous new license approval with delegation at the April 28th, 2021 meeting and instruct staff to keep the application in place and allow the applicant to to change the license type to a Restaurant/Eating Place - Public Convenience by redoing the publishing requirement and completing Form AB-12: Petition. Once completed, the application would need to be brought before the board for consideration.

Statutory Authority:

AS Sec. 04.11.400. "Population limitations: (2) inside an established village, incorporated city, or unified municipality if, after the issuance or relocation, there would be inside the established village, incorporated city, or unified municipality (A) more than one restaurant or eating place license for each 1,500 population or fraction of that population;"

AS 04.11.400(g): "The board may approve the issuance or transfer of ownership of a restaurant or eating place license in a municipality without regard to (a) [population limits] of this section if the board finds that issuance or transfer of the license is necessary for the public convenience."

- 3 AAC 304.335: "(a) The board may issue a restaurant or eating place license under AS 04.11.400(g) upon a showing that
- (1) repealed 8/24/2001;
- (2) there is community support, which must be shown by a petition signed by a majority of the residents 21 years of age or over who reside within one mile of the proposed premises; and the governing body of the municipality in which the licensed premises are to be located approves the application."
- 3 AAC 304.115(a): "...Petition signatures must be obtained within the 90-day period immediately preceding the submission of the application. After an application has been filed, no additional signatures may be added to the petition, and no signatures may be withdrawn."

Background: The City of Fairbanks is only allowed to have 21 Restaurant/Eating Place licenses (REPL) based on population. After AMCO received an application for FatBurger #5926 on 7/13/2020 (license issued 9/1/2020) there were no new licenses of this type available in the City of Fairbanks.

On January 21, 2021 AMCO received an application for a new REPL in the City of Fairbanks, House of Fire Pizza. AMCO staff should have verified the current and correct license count when the application was submitted and again when it was reviewed for completion. There is also an internal checklist that the examiner completes which includes the question, "Are there available licenses of this type in this LGB?"

When the application was submitted, the Population Figures spreadsheet on the website said that there were 19 current Restaurant/Eating Place licenses, but as of 7/13/20 there were really 21 current/pending REPLs in the City of Fairbanks per the Currently Active Licenses report in our database. Therefore, staff should have immediately notified the applicant that there were no new REPLs available and offer the option of applying for a REPL – Public Convenience.

In this case, I believe staff checked the Population Figures spreadsheet on our website but they did not pull a Currently Active Licenses report out of our database, which has accurate license counts because it includes pending applications that have been to submitted to the office for processing. The Population Figures spreadsheet, which is available to the public, does not contain that information. This was a training error and Licensing is in the process of putting their policies and procedures down on paper.

Dear Mr. Bartels:

At the April 28, 2021, meeting of the Alcoholic Beverage Control Board in Anchorage, Alaska, the board voted to approve your application with delegation. However, after reviewing the population figures and license counts for the City of Fairbanks, we have discovered that when the application was submitted to our offices on January 21, 2021 there were no Restaurant/Eating Place licenses available for application. A more recent search as of today again shows no available Restaurant/Eating Place licenses.

We regret to inform you that your application will need to appear before the ABC Board once again at the June 22, 2021 board meeting where AMCO will present the situation and request the Board to rescind their previous approval, instruct the staff to keep your application in place and allow you to change the license type to a Restaurant/Eating Place — Public Convenience AS 04.11.400(g) by re-doing the publishing requirement and completing and submitting Form AB-12: Petition.

The other option the board would have is to rescind the approval and deny the application. A refund form for the full amount of \$1,150.00 will be provided to you after the meeting.


