- 5. Does your establishment include a dining facility?
- 6. Are additional amenities available to your guests through your establishment (eg: guided tours or trips, rental equipment for guests, other activities that attract tourists)?



#### Tourism Statement - Denali Bluffs Hotel

- 1. Explain how issuance of a liquor license at your establishment has/will encourage tourism.

  The Denali Bluffs Hotel is a 176 Room, Seasonally Operated, Full-Service Hotel property located within a mile of the entry to Denali National Park, Alaska's premier Tourist Destination. Many Visitors to Alaska, and certainly to Denali, require both appropriate and desired Hotel accommodations and amenities as part of their itineraries, to include Food & Beverage services. The Denali Bluffs Hotel provides, in a normal operating summer such services to approximately 35,000 guests each Season.
- 2. Explain how the facility was/will be constructed or improved in accordance with this application.

  The Mountaineer Grill & Bar, at the Denali Bluffs Hotel, is a 75 seat restaurant dining facility to include a 20 seat full service Bar. As a very large percentage of our patrons at the Mountaineer are adults, on vacation, their ability to order adult style beverages to accompany their dining choices ensures a high level of service and satisfaction for their stay at the Hotel, while contributing positively to the financial performance of the overall Hotel operation.
- 3. Who operates the facility for which a liquor license is being applied?

  Grande Denali, LLC, a subsidiary owned by Old Harbor Native Corporation, operates the Denali Bluffs Hotel and the Mountaineer Grill & Bar.
- 4. Do you offer room rentals to the traveling public?
  - A. The Denali Bluffs Hotel includes 176 overnight guest accommodations, none with kitchen facilities as defined within the Tourism Statement Guidelines, with the exclusion of a mini-fridge. The Hotel does not stock alcoholic beverages in the guest rooms.
  - B. The Denall Bluffs Hotel is not located within an airport terminal.
- 5. Does your establishment include a dining facility?
  - Yes -- The Mountaineer Grill & Bar.
- 6. The Denali Bluffs Hotel does offer assistance to guests who are interested in participating in local tours, trips and activities that attract tourists. Such help extends to providing information, collateral materials, booking options and assistance, through our agreements with a large number of attraction/activity vendors located in the Denali area.
