RE: Package Store license #680 and Beverage Dispensary license #679 for McGuire's Tavern & Liquor Inc.

Requested<br/>Action:Request for time extension and request to allow continued operations by the<br/>personal representative.

Statutory Authority: AS 04.11.030(a): "The executor or administrator of the estate of a person who was operating a business as a sole licensee under a licensed authorized by this title may continue to operate the licensed business until an application for transfer of a license to another person is approved or until the licensed is forfeited under (b) of this section."

AS 04.11.030(b): "If an application for the transfer of ownership of a license from a deceased licensee is not made within 90 days of the death of the licensee or within an additional 90 days if an application for transfer of ownership made by the executor is denied, or no petition is made to the board for an extension of time under (c) of this section within the time, the license is forfeited."

AS 04.11.030(c): "The board may extend the time limits in (b) of this section on petition of the executor or administrator."

**Background:** On August 14, 2021 AMCO received written notice from Josie Magnuson, daughter of Allan Anderson II, that Allan Anderson II, 100% shareholder of McGuire's Tavern & Liquor Store Inc. had passed away on July 1, 2021. Josie Magnuson is requesting a time extension up to August 1, 2022 to file transfer applications and to continue operating the two licenses owned by McGurie's Tavern & Liquor Store Inc. during the transfer process.

To whom it may concern,

My name is Josie Magnuson, I am the daughter of Allan Anderson II. One month ago, 7-1-2021, my father passed away after a three month long fight in the hospital. I am writing to the ABC board in regards to the licenses #679 and #680. I am requesting an extension for the transfer application process. I foresee the probate process itself to take up to a year to complete, therefore am requesting a period up to August 1,2022 to fulfill his wishes based on his Will and file for the license transfer.

Unfortunately I am only able to provide a 'release of remains' from the crematorium at this point in time. As you may know, the vital statistics hack has caused a major delay in many ways including Death Certificates in which I am still waiting on. Therefore I have been unable to begin the probate process in itself. I am named as the executor of the estate in his Will and am currently doing what I can while I wait for the Death certificate. Once I receive the DC I will begin the probate process immediately. I have held off submitting this request in the hopes that I would have the proper paperwork and a better timeline in place by now. With that not being an option just yet I would really appreciate the extension from the ABC board. I am more than willing to update the board as soon as possible when I have the proper paperwork from the court.

In order for the business to support itself, water, heat, electricity. The most ideal situation would to keep operations going. With the oncoming winter months It is very important to keep the building properly heated and such. I am unable to do that out of my own pocket if I am not granted the ability to keep the business running.

These times have been difficult to navigate. As the would be third generation to uphold these licenses I am very concerned for the future of my family's business and humbly ask for the extension and ability to remain open for business in the meantime.
