Background: This is an application to issue a Beverage Dispensary – Tourism Duplicate license to JPS Enterprises, Inc. in the City of Nome.

AS 04.11.400(d)(2)(A)(ii) requires that the facility must maintain at least the minimum number of rental rooms required at original licensure. Staff has determined that the license is compliant with the room number requirements.

The hotel shares the same building with Bering Sea Bar and Grill which is connected by a hallway to the dining room and restaurant operated by the same owners. The dining room is available to patrons of the hotel. In addition, the hotel bar has food service from the restaurant available to order in the bar.
