Tourism Statement

- 2.1 My establishment encourages tourism by having a place for travelers to relax while they are waiting for their flights going to lodges in our community, other Southeast Cities, and other Alaska Airlines destinations. A bar has been a part of the Ketchikan Airport Terminal since 1973. I have leased the space from the Ketchikan Gateway Borough since I acquired my liquor license. Along with the bar, I also lease space for a snack bar which sells food. I do not offer any room rentals or additional amenities.
- 2.2 Airport Lounge & Snack Bar is located inside a secure area at the Ketchikan International Airport. The liquor license I have held since 1998 and is the only license on the airport premises. W continue to promote local breweries throughout the years which are in high demand by the traveling tourists. There have been a few different scenarios for expanding our airport by the Ketchikan Gateway Borough who operates our terminal. This includes a drastic expansion of the bar location with food concession. Therefor increasing my financial interest into location to provide a better experience for our tourists that are traveling. We will have a much larger seating area which will need to have a new area built with new refrigeration and all bar accessories. Once we are notified by the Ketchikan Gateway Borough of a definite date of remodel, I will notify the AMCO Board.


