Requested Action:

New Outdoor Recreation Lodge-Seasonal license

Statutory and Regulatory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.460. Prior public approval.

- (a) A new license or the transfer of location of an existing license may not be approved by the board in an area outside but within 50 miles of the boundaries of a municipality unless a petition asking that the license be issued or transferred within the area containing signatures of a majority of the permanent residents residing within one mile of the proposed premises is filed with the board.
- (b) A license may not be issued in an area that is 50 miles or more from the boundaries of a municipality unless a petition asking that the license be issued within the area containing the signatures of two-thirds of the permanent residents residing within a radius of five miles of the United States post office station nearest to the proposed licensed premises, is filed with the board. If there are two or more United States post office stations in the vicinity of the proposed licensed premises, the nearest to the premises constitutes the point of beginning under this subsection. If there is no United States post office station within a radius of five miles of the proposed licensed premises, the applicant must obtain the signatures of two-thirds of the permanent residents residing within a five mile radius of the proposed licensed premises. A petition is not required for the renewal of a license issued in accordance with this subsection unless specifically required by the board.
- (c) In this section, "permanent resident" means a person 21 years of age or older who has established a permanent place of abode.

3 AAC 304.115. Petitions

- (a) If required by statute or regulation, a petition is a necessary part of an application for a new license, and for renewal, transfer, or relocation of an existing license. An application submitted without the required petition is incomplete. All petitions must be on forms prescribed by the board. Petition signatures must be obtained within the 90-day period immediately preceding the submission of the application. After an application has been filed, no additional signatures may be added to the petition, and no signatures may be withdrawn.
- (b) A person signing a petition relating to a license must be 21 years of age or older and must be a permanent resident of the geographical area relevant to the petition. A person may have only one permanent residence.
- (c) Municipal boundaries shall be disregarded when gathering petition signatures.
- (d) When submitting a petition under AS 04.11.460, an applicant shall assist in the determination of population by submitting the following information with the application:
- (1) a graphic designation on a United States Geodetic Survey map with a scale of at least one inch to the mile showing the population within a circle of the applicable radius, and showing where petition signatures were obtained; and
- (2) the population within the applicable area and narrative of how the population was determined.

Staff Rec.: Approve with delegation

Background: This application is for a new Outdoor Recreation Lodge-Seasonal license with no local governing body located in Southeast Alaska. Though this is a new application, it also represents a replacement of existing Outdoor Recreation Lodge-Seasonal license #5309 due to a change in controlling interest of Alaska Sea Otter Sound Lodge LLC.

The applicant determined the number of signatures required by providing a signed affidavit that there are zero permanent residents in a one mile radius of the proposed premises and provided an aerial map also showing no structures in that radius.





Outdoor Recreations Site Statement

Sea Otter Sound Lodge is a floating fishing lodge with leased fixed moorage through DNR. The lodge has been actively in business for 23 years. It is located approximately 15 water miles from the nearest village, Naukati and 40 water miles north of Craig, Alaska. There are less than 100 year-round residents of Naukati.

Sea Otter Sound Lodge is a full-service lodge that accommodates up to 20 guests every 5 days. The lodge provides all meals, rooms with room service and full fish processing with fish packaging and freezing for the guests. The lodge does not have a bar. It only sells bottled beer and wine. No hard liquor is sold.

90 percent of the lodge guests are return guests with the lodge staying booked 2 years in advance. Currently the lodge is booked through 2024. Most guests are small business people or retirees.





Bird's eye view of lodge off of Hecate Island



One staff member, Joshua Davies, d.o.b. 07/10/1994, is allocated to go to where it is stored and hand the bottle of wine or the beer to the guest. No minor, whether guest or employee, is allowed to handle alcohol. An ABC under 21 notice is displayed in the area where alcohol is kept. Sea Otter Sound Lodge has a 2 year waitlist for guests. A guest that consumes too much alcohol or violates our policies is not invited back. All employees are required to sign our Rules and Regulations (attached) during the hiring process. On page 2, underage consumption results in immediate dismissal and we enforce that.
