### MEMORANDUM

Statutory AS 04.06.090(b): "(b) Only the board may issue, renew, transfer, Authority: relocate, suspend, or revoke a license or endorsement under this title. The board shall review all applications for licenses and endorsements made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses, endorsements, and permits authorized under this title."

> 3AAC 305.615c "(c) An application for transfer of a license from a deceased licensee must comply with the time limitations set out in AS 04.11.030(b). An applicant who fails to comply with the provisions of AS 04.11.030(b) forfeits the license unless the board approves a written request to extend the applicable deadline from the personal representative of the licensee's estate. If the board grants a deadline extension, the extension may not exceed the time reasonably necessary to close the affairs of the deceased individual, as determined by the board. A written request to extend the applicable deadline must (1) be submitted to the board before the applicable deadline expires; however, the board may approve a request that is submitted after the deadline if (A) there is good cause to approve the deadline extension; and (B) the license is still available for transfer; and (2) include an estimated length of time required for the extension from the personal representative and a description of the factors that support the requested timeline. (d) In this section, " personal representative " includes an agent within the meaning given in AS 13.06.050. (Eff. 1/1/2024, Register 248)

**Background:** At the November 13-14, 2023 ABC board meeting, the board granted a six-month time extension for filing a transfer. (Expires May 13-14, 2024)

**Current Request**: Executors for the estate are requesting an additional six-month extension to complete a sale of the license.

Staff Recommendation: Staff recommends an additional six-month time extension.

Dear Chair Walukiewicz and Members of the Alcoholic Beverage Control Board:

Our firm represents MTM, Inc., d/b/a the Mug-Shot Saloon, Beverage Dispensary License No. 2924. Pursuant to 3 AAC 304.216 (b), Mug-Shot Saloon respectfully requests that the Board grant a second extension of six (6) months for the filing of a transfer application following the death of an individual who owns a controlling interest in the corporation. The basis for the second extension is MTM, Inc, has identified a potential buyer; and therefore, will require additional time to finalize the terms of the transfer, and complete the necessary documents to perfect the transaction of buying an existing business.

MTM, Inc. is the owner of Beverage Dispensary License No. 2924, and is a business corporation in good standing with two shareholders: Ms. Megan Soczka, who owns 10% of the corporation's shares; and Mr. Theodore W. Anderson, Jr., who owns 90%. Mr. Anderson passed away on July 27, 2023. Prior to his passing, Mr. Anderson executed a *Last Will and Testament* and *Revocable Trust Agreement for the Theodore W. Anderson, Jr. Revocable Trust.* Through these documents, Mr. Anderson appointed MTM, Inc.'s Business Manager, Ms. Nicole M. Lee, and Mr. John Ashe as the co-personal representatives of his estate and Co-Trustees of the Trust.

On August 17, 2023, an informal probate action was initiated in the matter of Mr. Anderson's estate, bearing the case number 3PA-23-00683 PR. On September 26, 2023, the Court entered *Letters Testamentary* and a *Statement of Informal Probate of Will and Appointment of Co-Personal Representatives* in that matter, appointing Ms. Lee and Mr. Ashe as the personal representatives of the estate. Since her appointment, Ms. Lee has worked with a professional realtor with experience in transactions involving alcohol licenses. They have together identified four interested parties who appeared to be viable candidates for transfer, and have ultimately been

Beyond preliminary negotiations, Ms. Lee and the potential buyer are finalizing mutually acceptable terms for the purchase and intend to execute a Letter of Intent within the next 21 days.

Given the progress in its efforts to find a suitable transferee and the anticipated time required to effectuate such a transfer, MTM, Inc., respectfully requests a six-month extension of time to reach agreed terms for the transfer of Beverage Dispensary License No. 2924 and submit an application for such a transfer.

AS 04.11.030(b): "If an application for the transfer of ownership of a license from a deceased licensee is not made within 90 days of the death of the licensee or within an additional 90 days if an application for transfer of ownership made by the executor is denied, or no petition is made to the board for an extension of time under (c) of this section within the time, the license is forfeited." AS 04.11.030(c): "The board may extend the time limits in (b) of this section on petition of the executor or administrator." 3 AAC 304.216 "(a) Upon the death of an individual who owns a controlling interest in a partnership, including a limited partnership, a limited liability company, or a corporation that holds a license under AS 04 and this chapter, the business entity may continue to operate the licensed business but shall file, not later than 90 days after the individual's death, a transfer application as required under AS 04.11.040 and 3 AAC 304.175 or a time extension request under (b) of this section. If a transfer application or time extension request is not filed by the 90-day deadline, the business shall cease operation until a transfer application is filed. (b) Upon receipt of a time extension request, the board may grant an extension not to exceed one year. A written request to extend the applicable deadline must be submitted before the expiration of the applicable deadline, unless the board approves a request submitted after the deadline for good case. Additional extensions may be granted by the board only for good cause."

**Background:** On October 20,2023 AMCO received the attached request from Carlson Law Group, counsel for the personal representatives, for a extension to complete a transfer application. The death of the licensee with controlling interest occurred on 7/27/2023. On 08/17/2023 an informal probate action was initiated personal representatives were recently appointed. They are requesting a six month extension to complete a transfer.


