Specialist Paper Application

This project was initiated at the January 2024 board meeting to charge a fee for those applicants choosing to submit paper applications when an online application process is available to them. The attached regulations draft is for board discussion.

3 AAC 306.165. Miscellaneous fees.

This section is amended by adding a new paragraph (10) to outline a \$150 fee for submission of an application on a paper form with the exception of permit applications. New paragraph (11) is added to create a \$50 fee beginning January 1, 2025 for the submission of a paper permit application.

Options for the board:

- Move to approve and send to Law for initial review and (with Law's approval) subsequent public comment
- Move to amend and then send to Law for initial review and (with Law's approval) subsequent public comment
- Move to send back to staff for more work
- Close the regulations project
